- 3 Be it enacted by the people of the State of Nebraska,

LB923 2016

- 1 Section 1. The Legislature finds and declares that:
- 2 (1) Nebraska's seven federally qualified health centers are
- 3 nonprofit, community-based organizations that provide comprehensive,
- 4 high-quality primary care and preventive care, including medical, dental,
- 5 <u>behavioral</u> health, and pharmacy services and support services to
- 6 Nebraskans;
- 7 (2) Federally qualified health centers are safety-net health care
- 8 providers that serve low-income families, members of racial and ethnic
- 9 minority groups, the uninsured, and rural residents. In 2014, federally
- 10 <u>qualified health centers served over sixty-nine thousand patients in</u>
- 11 <u>Nebraska, of which sixty-eight percent were of a racial or ethnic</u>
- 12 <u>minority</u>, <u>ninety-one percent had family incomes at or below two hundred</u>
- 13 percent of the federal poverty level, fifty percent were uninsured and
- 14 <u>twenty-nine percent were covered by the medical assistance program;</u>
- 15 (3) Federally qualified health centers allow low-income medically
- 16 <u>underserved Nebraskans access to health care and to establish a medical</u>
- 17 <u>home and currently do not have the capacity to meet the demand of this</u>
- 18 population; and
- 19 (4) Investing in health services for low-income medically
- 20 <u>underserved Nebraskans saves health care dollars in the long term and</u>
- 21 ensures that low-income workers can continue to support their families
- 22 and contribute to society.
- 23 Sec. 2. <u>It is the intent of the Legislature to appropriate for</u>
- 24 FY2016-17 an additional \$1,400,000 General Funds, for state aid for the
- 25 seven community health centers funded through Federal Program 330, the
- 26 Federal Health Centers Consolidation Act of 1996, Public Law 104-299, as
- 27 <u>such act and law existed on January 1, 2016. Each of the following</u>
- 28 <u>centers is to receive \$200,000 to expand capacity: Charles Drew Health</u>
- 29 <u>Center, One World Community Health Center, Good Neighbor Community Health</u>
- 30 Center, Community Partnership of Western Nebraska, Midtown Community
- 31 Health Center, People's Health Center, and Heartland Health Center.

1 It is the intent of the Legislature to appropriate for 2 FY2016-17 an additional \$1,200,000 General Funds for distribution to 3 federally qualified health centers in Nebraska to serve Nebraskans on 4 waiting lists or subject to delays in receiving services at health 5 centers. Such funds shall be distributed proportionately based on the 6 total number of patients served in the previous year by such federally 7 qualified health centers as reported through the uniform data system of 8 the Health Resources and Services Administration of the United States 9 Department of Health and Human Services. 10 Sec. 4. It is the intent of the Legislature to appropriate for FY2016-17 an additional \$2,400,000 General Funds for state aid to the 11 seven community health centers funded through Federal Program 330, the 12 13 Federal Health Centers Consolidation Act of 1996, Public Law 104-299, as such act and law existed on January 1, 2016. Each center is to receive an 14 amount to be distributed proportionally based on the previous year's 15 16 number of uninsured as reported through the uniform data system of the

Health Resources and Services Administration of the United State

Department of Health and Human Services.
