# A BILL

- 1 FOR AN ACT relating to personal property; to regulate dealers in the
- 2 business of purchasing and reselling precious items; to
- 3 provide a penalty; and to harmonize provisions.
- 4 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. For purposes of sections 1 to 9 of this act:
- 2 (1) Dealer means any person that engages in the business
- 3 of purchasing precious items for the purpose of reselling such items
- 4 in any form. Dealer does not include a manufacturer, retailer, or
- 5 pawnbroker as defined in section 69-201;
- 6 (2) Local law enforcement agency means the police
- 7 department of the municipality where the dealer is permitted to do
- 8 business or, if the municipality does not have a police department or
- 9 if the dealer's permanent place of business is outside a
- 10 municipality, the sheriff of the county where the dealer is permitted
- 11 to do business;
- 12 <u>(3) Permanent place of business means a fixed premises</u>
- 13 <u>either owned by the dealer or leased by the dealer for at least one</u>
- 14 year; and
- (4) Precious item means (a) an article made in whole or
- 16 in part of gold, silver, or platinum or (b) precious or semiprecious
- 17 stones or pearls whether mounted or unmounted.
- 18 Sec. 2. (1) Each dealer shall apply to the city, village,
- 19 or county treasurer for a permit to carry on business and shall pay
- 20 the sum of one hundred dollars per year or fifty dollars for every
- 21 six months. The application shall be made to the county treasurer if
- 22 the applicant's permanent place of business is outside a
- 23 <u>municipality</u>.
- 24 (2) The application shall contain the following
- 25 <u>information:</u>

1 (a) The name and address of the owner and the manager of

- 2 the business and, if the applicant is an individual, the applicant's
- 3 <u>social security number;</u>
- 4 (b) If the applicant is a business entity, a copy of the
- 5 articles of organization and the names of its officers and its
- 6 owners; and
- 7 (c) The location of the permanent place of business.
- 8 (3) Upon receipt of a complete application and the fee,
- 9 the city, village, or county treasurer shall forward the application
- 10 to the city or village clerk or county clerk, as appropriate. The
- 11 governing body of the city, village, or county shall review the
- 12 application and, if it complies with the provisions of sections 1 to
- 13 9 of this act, approve the application and direct the clerk to issue
- 14 a permit. The governing body may delegate its duties under this
- 15 section.
- 16 Sec. 3. A dealer may only operate from the permanent
- 17 place of business listed on the permit issued under section 2 of this
- 18 act. The dealer shall provide a copy of the permit to the local law
- 19 <u>enforcement agency within five days after receipt. It shall be</u>
- 20 unlawful for any person to act as a dealer without a permit.
- 21 Sec. 4. A dealer shall keep a ledger containing the
- 22 following information for six months after the date of purchase of a
- 23 precious item:
- 24 (1) The name of the person from whom the precious item is
- 25 purchased or received, his or her signature and date of birth, and a

1 record of his or her valid photo identification which contains a

- 2 <u>traceable number to be recorded by the dealer;</u>
- 3 (2) A full and accurate description of the precious item
- 4 purchased, including any manufacturer's identifying insignia or
- 5 serial number;
- 6 (3) The date and time the precious item was purchased;
- 7 (4) The amount paid for the precious item; and
- 8 (5) The identification and signature of the clerk or
- 9 agent for the dealer who handled the transaction.
- 10 Ledger entries shall not in any manner be erased,
- 11 obliterated, or defaced. The person selling a precious item to a
- 12 <u>dealer shall receive a receipt for the precious item sold which</u>
- 13 contains a copy of the entries required by this section.
- Sec. 5. Every dealer shall admit to the dealer's
- 15 permanent place of business at any reasonable time during normal
- 16 <u>business</u> hours any law enforcement officer for the purpose of
- 17 examining any precious item and records on the premises and shall
- 18 allow any law enforcement officer to place restrictions on the
- 19 <u>disposition of any precious item for which a reasonable belief exists</u>
- 20 that it has been stolen. Any person claiming ownership interest in a
- 21 precious item received by a dealer for which reasonable belief exists
- 22 that such precious item has been stolen may recover such precious
- 23 <u>item as provided by sections 25-1093 to 25-10,110.</u>
- Sec. 6. <u>It shall be the duty of every dealer every day</u>,
- 25 except Sunday, before the hour of 12 noon to deliver to the local law

1 enforcement agency a report containing a complete and legible copy of 2 each ledger entry as required by section 4 of this act of precious 3 items purchased during the period since the last report. It is 4 presumptive evidence of intent to violate sections 1 to 9 of this act 5 if the precious items purchased are not listed or fail to agree with the description contained in the report. No report shall be required 6 7 for precious items purchased from manufacturers or wholesalers having 8 an established place of business, precious items purchased at open 9 sale from a bankrupt stock, or precious items purchased from any 10 other person doing business and having an established place of business in the city, village, or county, but such precious items 11 12 must be accompanied by a bill of sale or other evidence of open and 13 legitimate purchase and must be shown to any law enforcement officer 14 when demanded. 15 Sec. 7. (1) Any precious item purchased by a dealer shall 16 be held in the same shape and form as receipted for in the dealer's custody for fourteen business days after delivering the report to the 17 18 local law enforcement agency as required in section 6 of this act. 19 (2) A dealer shall make payment to the seller by check, 20 made payable to the seller. (3) On notification by a law enforcement officer or 21 22 county attorney that reasonable belief exists that a precious item purchased has been stolen, the dealer may not dispose of the precious 23 24 item.

(4) Each dealer shall, in addition to the requirements of

1 sections 1 to 9 of this act, obtain and keep a single legible

- 2 fingerprint of each person selling any precious item. The fingerprint
- 3 shall be taken from the right index finger or, if the right index
- 4 finger is missing, from the left index finger. Each dealer shall
- 5 display a notice to customers, in a prominent location, stating that
- 6 such dealer is required by state law to fingerprint every person
- 7 <u>selling an item.</u>
- 8 (5) A dealer may not purchase a precious item (a) from
- 9 any person under eighteen years of age unless the person is
- 10 accompanied by a parent or quardian who shall submit identification
- 11 as required by section 4 of this act, (b) from any person who appears
- 12 to be under the influence of alcohol, narcotic drug, stimulant, or
- 13 depressant or who appears to be mentally incompetent, or (c) on which
- 14 any serial numbers or other identifying insignia has been destroyed,
- 15 removed, altered, covered, or defaced.
- 16 Sec. 8. <u>Each dealer shall prominently display a copy of</u>
- 17 the permit issued pursuant to sections 1 to 9 of this act in a
- 18 conspicuous place at the permanent place of business.
- 19 Sec. 9. Any person who violates sections 1 to 8 of this
- 20 act is guilty of a Class III misdemeanor.
- 21 Sec. 10. <u>Sections 69-201 to 69-210 do not apply to a</u>
- 22 dealer as defined in section 1 of this act who has been issued a
- 23 permit as provided in sections 1 to 9 of this act.
- 24 Sec. 11. Sections 1 to 9 of this act do not apply to a
- 25 person who has been issued a permit as provided in sections 69-201 to

1 69-210.
