## 1 A MEMORIAL 2 COMMEMORATING FEBRUARY 15, 2019 AS "VALENCIA COUNTY DAY" IN 3 THE HOUSE OF REPRESENTATIVES. 4 5 WHEREAS, Valencia county is part of the Rio Abajo; and 6 WHEREAS, Valencia county is the home of the largest 7 matanza in the United States, and the matanza is a symbol of 8 the rich Spanish heritage of the Rio Grande valley; and 9 WHEREAS, Valencia county is the home of the famous Tome 10 land grant, which the king of Spain granted to thirty families in 1739; and 11 12 WHEREAS, the village of Los Lunas was founded by 13 Spaniards in the seventeenth century; and 14 WHEREAS, Belen is officially known as "Nuestra Señora de 15 Belen", or "Our Lady of Belen"; and 16 WHEREAS, Belen means "Bethlehem" in Spanish; and 17 WHEREAS, Belen was a strategic point along the Camino 18 Real, also known as the "Royal Road", which carved a trade 19 route south into Mexico; and 20 WHEREAS, Belen has gained the nickname "hub city" 21 because of the Belen cutoff of the Atchison, Topeka and Santa 22 Fe railway, now known as the BNSF railway company; and 23 WHEREAS, Bosque Farms was a destination for relocated 24 dust bowl refugees; and

WHEREAS, Bosque Farms strives to be a sparsely

populated, agricultural community; and

WHEREAS, Peralta was the site of a minor engagement during the American civil war; and

WHEREAS, Rio Communities is home to Valencia county's only golf course, Tierra del Sol; and

WHEREAS, Valencia county is home to the decalogue stone, which contains an inscription that is interpreted to be an abridged version of the ten commandments in a form of the Paleo-Hebrew alphabet; and

WHEREAS, Valencia county houses two museums, the Belen Harvey house museum and the Los Lunas museum of heritage and arts; and

WHEREAS, Valencia county is home to parts of the Cibola national forest and the Manzano wilderness; and

WHEREAS, Valencia county is renowned for its agriculture; and

WHEREAS, Valencia county hosts the United States' largest matanza, a family fun event that raises funds to provide scholarships to students while preserving Valencia county traditions by promoting and enhancing local business development through civic, social, cultural and employment training programs;

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE OF NEW MEXICO that February 15, 2019 be commemorated as "Valencia County Day" in the house of
