The articles of organization may be amended in 6 Β. 7 any respect desired, so long as the articles of organization, as amended, contain only provisions that may be lawfully 8 9 contained in articles of organization at the time of making the amendment. 10 C. The articles of organization shall be amended to 11 12 reflect any change in the name of the limited liability company, any change in the membership of the limited liability 13 company and shall include the name and address of each member 14 not already provided to the secretary of state, the latest date 15 on which the limited liability company is to dissolve or 16 whether the limited liability company is to be managed by 17 18 members or managers. 19 D. Articles of organization may be restated at any 20 time.
