SUMMARY—Revises provisions governing commercial motor vehicles. (BDR 43-255)

AN ACT relating to commercial motor vehicles; revising provisions relating to additional fees for the registration of certain commercial motor vehicles based on the weight of the vehicle; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law requires, for every motortruck, truck-tractor or bus, the payment
2 of an additional fee for registration that is based on the weight of the vehicle. At the
3 top of the fee schedule, such a vehicle which weighs not less than 26,001 pounds
4 and not more than 80,000 pounds must pay a fee of \$17 for each 1,000 pounds,
5 with a maximum fee of \$1,360. (NRS 482.482) This bill adds an additional tier of
6 vehicle weights, to the extent authorized by federal law, from 80,001 pounds to
7 131,550 pounds. Such a vehicle must pay a fee of \$1,360, plus \$20 for each 1,000
8 pounds over 80,000 pounds, with a maximum fee of \$2,391.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 482.482 is hereby amended to read as follows:
2 482.482 1. In addition to any other applicable fee listed in
3 NRS 482.480, there must be paid to the Department for the
4 registration of every motortruck, truck-tractor or bus which has a
5 declared gross weight of:
6 (a) Less than 6,000 pounds, a fee of \$33.
7 (b) Not less than 6,000 pounds and not more than 8,499 pounds,
8 a fee of \$38.



1 (c) Not less than 8,500 pounds and not more than 10,000
2 pounds, a fee of \$48.

3 (d) Not less than 10,001 pounds and not more than 26,000
4 pounds, a fee of \$12 for each 1,000 pounds or fraction thereof.

5 (e) Not less than 26,001 pounds and not more than 80,000
6 pounds, a fee of \$17 for each 1,000 pounds or fraction thereof. ~~The
7 maximum fee is \$1,360.~~

8 *(f) To the extent authorized by federal law, not less than
9 80,001 and not more than 131,550 pounds, a fee of \$1,360, plus
10 \$20 for each 1,000 pounds or fraction thereof over 80,000 pounds.
11 The maximum fee is \$2,391.*

12 2. Except as otherwise provided in subsection 6, the original or
13 renewal registration fees for fleets of vehicles with a declared gross
14 weight in excess of 26,000 pounds and the governmental services
15 tax imposed by the provisions of chapter 371 of NRS for the
16 privilege of operating those vehicles may be paid in installments, the
17 amount of which must be determined by regulation. The Department
18 shall not allow installment payments for a vehicle added to a fleet
19 after the original or renewal registration is issued.

20 3. If the due date of any installment falls on a Saturday, Sunday
21 or legal holiday, that installment is not due until the next following
22 business day.

23 4. Any payment required by subsection 2 shall be deemed
24 received by the Department on the date shown by the post office
25 cancellation mark stamped on an envelope containing payment
26 properly addressed to the Department, if that date is earlier than the
27 actual receipt of that payment.

28 5. A person who fails to pay any fee pursuant to subsection 2
29 or governmental services tax when due shall pay to the Department
30 a penalty of 10 percent of the amount of the unpaid fee, plus interest
31 on the unpaid fee at the rate of 1 percent per month or fraction of a
32 month from the date the fee and tax were due until the date of
33 payment.

34 6. If a person fails to pay any fee pursuant to subsection 2 or
35 governmental services tax when due, the Department may, in
36 addition to the penalty provided for in subsection 5, require that
37 person to pay:

38 (a) The entire amount of the unpaid registration fee and
39 governmental services tax owed by that person for the remainder of
40 the period of registration; and

41 (b) On an annual basis, any registration fee and governmental
42 services tax set forth in subsection 2 which may be incurred by that
43 person in any subsequent period of registration.



1 7. A person who is convicted of, or who pleads guilty, guilty
2 but mentally ill or nolo contendere to, a violation of NRS 484D.630
3 must reregister the vehicle with a declared gross weight equal to:
4 (a) The gross vehicle weight rating; or
5 (b) The combined gross vehicle weight rating, if the vehicle was
6 operated in combination at the time of the violation.
7 ↳ The registration fee owed pursuant to this subsection is incurred
8 from the date the person was convicted of, or pled guilty, guilty but
9 mentally ill or nolo contendere to, a violation of NRS 484D.630.
10 **Sec. 2.** This act becomes effective upon passage and approval.
