SUMMARY—Revises provisions governing the Public Employees’ Deferred Compensation Program. (BDR 18-233)

AN ACT relating to public employees; revising provisions governing the Executive Officer of the Public Employees’ Deferred Compensation Program; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 Under existing law, the Director of the Department of Administration, with the
2 concurrence of the Governor and the Committee to Administer the Public
3 Employees’ Deferred Compensation Program, appoints the Executive Officer of the
4 Public Employees’ Deferred Compensation Program. (NRS 232.215) The
5 Executive Officer serves at the pleasure of the Director and may be removed by a
6 majority vote of the Committee. (NRS 232.2165) **Section 1** of this bill removes the
7 requirement that the Executive Officer of the Program must be appointed with
8 the concurrence of the Committee. **Section 2** of this bill eliminates the authority of
9 the Committee to remove the Executive Officer.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 232.215 is hereby amended to read as follows:
2 232.215 The Director:
3 1. Shall appoint an Administrator of the:
4 (a) Risk Management Division;
5 (b) State Public Works Division;
6 (c) Purchasing Division;
7 (d) Administrative Services Division;



- 1 (e) Division of Human Resource Management;
- 2 (f) Division of Enterprise Information Technology Services;
- 3 (g) Division of State Library, Archives and Public Records;
- 4 (h) Office of Grant Procurement, Coordination and
- 5 Management; and
- 6 (i) Fleet Services Division.

7 2. Shall, with the concurrence of the Governor, ~~and the~~
8 ~~Committee to Administer the Public Employees' Deferred~~
9 ~~Compensation Program,]~~ appoint the Executive Officer of the Public
10 Employees' Deferred Compensation Program.

11 3. Shall serve as Chief of the Hearings Division and shall
12 appoint the hearing officers and compensation officers. The Director
13 may designate one of the appeals officers in the Division to
14 supervise the administrative, technical and procedural activities of
15 the Division.

16 4. Is responsible for the administration, through the divisions
17 of the Department, of the provisions of chapters 233F, 242 and 284
18 of NRS, NRS 287.250 to 287.370, inclusive, and chapters 331, 333,
19 336, 338, 341 and 378 of NRS and all other provisions of law
20 relating to the functions of the divisions of the Department.

21 5. Is responsible for the administration of the laws of this State
22 relating to the negotiation and procurement of medical services and
23 other benefits for state agencies.

24 6. Has such other powers and duties as are provided by law.

25 **Sec. 2.** NRS 232.2165 is hereby amended to read as follows:

26 232.2165 1. The Administrator of:

- 27 (a) The State Public Works Division;
- 28 (b) The Purchasing Division;
- 29 (c) The Administrative Services Division;
- 30 (d) The Division of Human Resource Management;
- 31 (e) The Division of Enterprise Information Technology
- 32 Services;
- 33 (f) The Division of State Library, Archives and Public Records;
- 34 (g) The Office of Grant Procurement, Coordination and
- 35 Management; and
- 36 (h) The Fleet Services Division,

37 ↪ of the Department serves at the pleasure of the Director and is in
38 the unclassified service of the State.

39 2. The Executive Officer of the Public Employees' Deferred
40 Compensation Program appointed pursuant to NRS 232.215 is in the
41 unclassified service of the State and serves at the pleasure of the
42 Director. ~~[except that he or she may be removed by a majority~~
43 ~~vote of the Committee to Administer the Public Employees'~~
44 ~~Deferred Compensation Program.]~~
