SENATE BILL NO. 319–SENATORS DONDERO LOOP, WOODHOUSE, DENIS, PARKS; BROOKS, CANCELA, CANNIZZARO, D. HARRIS, OHRENSCHALL, RATTI AND SCHEIBLE

SUMMARY—Revises provisions relating to education. (BDR 34-1063)

FISCAL NOTE: Effect on Local Government: May have Fiscal Impact. Effect on the State: Yes.

EXPLANATION - Matter in *bolded italics* is new; matter between brackets [omitted material] is material to be omitted.

AN ACT relating to education; defining "school counselor," "school psychologist" and "school social worker" for certain purposes; establishing the duties of a school counselor, psychologist and social worker; requiring certain school counselors, psychologists and social workers to receive an additional 5 percent of the base salary each year; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

Existing law provides for the licensing of psychologists and social workers. (Chapters 641 and 641B of NRS) Existing law authorizes a person who is certified as a school psychologist by the State Board of Education to use the title "school psychologist" or "certified school psychologist." (NRS 641.390) Section 1 of this bill defines school counselor, school psychologist and school social worker, respectively, for the school environment. Sections 3-5 of this bill establish the duties of a school counselor, psychologist and social worker, respectively, employed by a school district.

9 Existing law requires an annual 5 percent salary increase for teachers, speech-10 language pathologists and school library media specialists who hold certain 11 national certifications. (NRS 391.161-391.163) **Section 6** of this bill requires an 12 additional 5 percent to be added to the base salary of a counselor, psychologist or 13 social worker who holds a national certification.

14 **Section 7** of this bill makes a conforming change.





THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. NRS 385.007 is hereby amended to read as follows:
 385.007 As used in this title, unless the context otherwise
 requires:
 "Achievement charter school" means a public school

"School psychologist" or "psychologist" means a39psychologist licensed pursuant to chapter 641 of NRS who holds a40license issued pursuant to chapter 391 of NRS and an41endorsement to serve as a school psychologist issued pursuant to42regulations adopted by the Commission on Professional Standards

15 Sec. 2. Chapter 391 of NRS is hereby amended by adding 16 thereto the provisions set forth as sections 3 to 6, inclusive, of this 17 act.

18 Sec. 3. 1. A school counselor shall, through consultation or 19 collaboration with other educational personnel or by providing 20 direct services:

(a) Design and deliver comprehensive programs for school
 counseling that promote achievement of pupils;

(b) Analyze data concerning the academic, career, social and
 emotional development of pupils to identify issues, needs and
 challenges of pupils;

(c) Address needs relating to the academic, career, social and
 emotional development of all pupils;

(d) Advocate for equitable access to a rigorous education for
 all pupils and work to remove systemic barriers to such access;

(e) Deliver school counseling lessons through large-group,
 classroom, small-group and individual settings to promote pupil
 success;

(f) Provide to individual pupils services relating to academic
 planning and goal setting;

(g) Provide peer facilitation, crisis counseling and short-term
 counseling to pupils in individual and small-group settings;

(h) Provide referrals to a pupil and the parent or legal
guardian of a pupil, as needed, for additional support services
provided by the school or within the community;

On or before September 15 of the school year, the person has submitted evidence satisfactory to the school district of the 31 32 current certification of the person: 33 (a) As a school counselor by the National Board for **Professional Teaching Standards or its successor organization:** 34 (b) As a national certified school counselor by the National 35 36 **Board for Certified Counselors or its successor organization:** (c) As a nationally certified school psychologist by the 37 National Association of School Psychologists or its successor 38 39 organization; 40 (d) As a school psychologist by the American Board of School 41 *Psychology or its successor organization; or* 42 (e) As a certified school social work specialist by the National 43 Association of Social Workers or its successor organization; and





1 2. The person is assigned by the school district to serve as a 2 school counselor, psychologist or social worker, as applicable, 3 during that school year.

→ No increase in salary may be given pursuant to this section 4 during a particular school year to a person who submits evidence 5 of certification after September 15 of that school year. Once a 6 7 person has submitted evidence of such certification to the school district, the school district shall retain the evidence in its records, 8 as applicable, for future school years. An increase in salary given 9 10 in accordance with this section is in addition to any other increase 11 to which the person may otherwise be entitled. NRS 391.160 is hereby amended to read as follows: 12 Sec. 7.

391.160 The salaries of teachers and other employees must be
determined by the character of the service required as described in
NRS 391.161 to 391.169, inclusive [..], and section 6 of this act. A
school district shall not discriminate between male and female
