SENATE RESOLUTION—Adopting the Rules of the Senate for the 27th Special Session of the Legislature.

1       RESOLVED BY THE SENATE OF THE STATE OF NEVADA, That the  
2 following Rules of the Senate for the 27th Special Session of the  
3 Legislature are hereby adopted:

5                                   ***I. APPLICABILITY***

6  
7       ***Rule No. 1. Generally.***

8       ***The Rules of the Senate for the 27th Special Session of the***  
9 ***Legislature are applicable only during the 27th Special Session of***  
10 ***the Legislature.***

11  
12                                   ***II. OFFICERS AND EMPLOYEES***

13  
14                                   ***DUTIES OF OFFICERS***

15  
16       ***Rule No. 2. President.***

17       ***The President shall take the chair and call the Senate to order***  
18 ***precisely at the hour appointed for meeting. The President shall***  
19 ***preserve order and decorum, and in case of any disturbance or***  
20 ***disorderly conduct within the Senate Chamber, shall order the***  
21 ***Sergeant at Arms to suppress it, and may order the arrest of any***  
22 ***person creating any disturbance within the Senate Chamber. The***  
23 ***President may speak to points of order in preference to members,***  
24 ***rising from his or her seat for that purpose, and shall decide***  
25 ***questions of order without debate, subject to an appeal to the***  
26 ***Senate by two members, on which appeal no member may speak***



1 *more than once without leave of the Senate. The President shall*  
2 *sign all acts, addresses and joint resolutions, and all writs,*  
3 *warrants and subpoenas issued by order of the Senate; all of*  
4 *which must be attested by the Secretary. The President has general*  
5 *direction of the Senate Chamber.*

6  
7 **Rule No. 3. President Pro Tempore.**

8 *The President Pro Tempore has all the power and shall*  
9 *discharge all the duties of the President during his or her absence*  
10 *or inability to discharge the duties of his or her office. In the*  
11 *absence or inability of the President Pro Tempore to discharge the*  
12 *duties of the President's office, the Senate shall elect one of its*  
13 *members as the presiding officer for that occasion. A member who*  
14 *is serving as the presiding officer has all the power and shall*  
15 *discharge all the duties of the President until the absence or*  
16 *inability which resulted in the member serving as the presiding*  
17 *officer has ended.*

18  
19 **Rule No. 4. Secretary.**

20 **1. The Secretary of the Senate is elected by the Senate, and**  
21 **shall:**

22 **(a) Interview and recommend persons to be considered for**  
23 **employment to assist the Secretary.**

24 **(b) See that these employees perform their respective duties.**

25 **(c) Administer the daily business of the Senate, including the**  
26 **provision of secretaries as needed.**

27 **(d) Unless otherwise ordered by the Senate, transmit as soon**  
28 **as practicable those bills and resolutions upon which the next**  
29 **action is to be taken by the Assembly.**

30 **2. The Secretary is responsible to the Majority Leader.**

31  
32 **Rule No. 5. Sergeant at Arms.**

33 **1. The Sergeant at Arms shall attend the Senate during its**  
34 **sittings, and execute its commands and all process issued by its**  
35 **authority. He or she must be sworn to keep the secrets of the**  
36 **Senate.**

37 **2. The Sergeant at Arms shall:**

38 **(a) Superintend the upkeep of the Senate's Chamber, private**  
39 **lounge, and meeting rooms.**

40 **(b) Interview and recommend persons to be considered for**  
41 **employment to assist the Sergeant at Arms.**

42 **3. The Sergeant at Arms is responsible to the Majority**  
43 **Leader.**



1 **Rule No. 6. Assistant Sergeant at Arms.**

2 *The Assistant Sergeant at Arms shall be doorkeeper and shall*  
3 *preserve order in the Senate Chamber and shall assist the*  
4 *Sergeant at Arms. He or she shall be sworn to keep the secrets of*  
5 *the Senate.*

6  
7 **III. SESSIONS AND MEETINGS**

8  
9 **Rule No. 7. Call of Senate—Moved by Three Members.**

10 *A Call of the Senate may be moved by three Senators, and if*  
11 *carried by a majority of all present, the Secretary shall call the roll*  
12 *and note the absentees, after which the names of the absentees*  
13 *shall again be called over. The doors shall then be closed and the*  
14 *Sergeant at Arms directed to take into custody all who may be*  
15 *absent without leave, and all Senators so taken into custody shall*  
16 *be presented at the bar of the Senate for such action as to the*  
17 *Senate may seem proper.*

18  
19 **Rule No. 8. Absence—Leave Required.**

20 *No Senator shall absent himself or herself from the service of*  
21 *the Senate without leave, except in case of accident or sickness,*  
22 *and if any Senator or officer shall so absent himself or herself, his*  
23 *or her pro diem shall not be allowed.*

24  
25 **Rule No. 9. Open Meetings.**

26 *1. Except as otherwise provided in the Constitution of the*  
27 *State of Nevada and in subsection 2 of this rule, all meetings of*  
28 *the Senate and the Committee of the Whole or a standing*  
29 *committee must be open to the public.*

30 *2. A meeting may be closed to consider the character, alleged*  
31 *misconduct, professional competence, or physical or mental health*  
32 *of a person.*

33  
34 **IV. DECORUM AND DEBATE**

35  
36 **Rule No. 10. Points of Order.**

37 *1. If any Senator, in speaking or otherwise, transgresses the*  
38 *rules of the Senate, the President shall, or any Senator may, call*  
39 *the member to order. If a Senator is so called to order, he or she*  
40 *shall not proceed without leave of the Senate. If such leave is*  
41 *granted, it must be upon the motion, "That the Senator be allowed*  
42 *to proceed in order," and the Senator shall confine himself or*  
43 *herself to the question under consideration and avoid personality.*

44 *2. Every decision of points of order made by the President is*  
45 *subject to appeal, and a discussion of a question of order may be*



1 *allowed only upon the appeal of two Senators. In all cases of*  
2 *appeal, the question must be, "Shall the decision of the Chair*  
3 *stand as the judgment of the Senate?"*  
4

5 ***Rule No. 11. Breaches of Decorum.***

6 *1. In cases of breaches of decorum or propriety, any Senator,*  
7 *officer or other person is liable to such censure or punishment as*  
8 *the Senate may deem proper.*

9 *2. If any Senator is called to order for offensive or indecorous*  
10 *language or conduct, the person calling the member to order shall*  
11 *report the offensive or indecorous language or conduct to the*  
12 *presiding officer. No member may be held to answer for any*  
13 *language used on the floor of the Senate if business has*  
14 *intervened before exception to the language was taken.*

15 *3. Indecorous conduct or boisterous or unbecoming language*  
16 *is not permitted in the Senate Chamber.*  
17

18 ***Rule No. 11.5. Legislative Ethics.***

19 *1. In determining whether a Legislator has a conflict of*  
20 *interest, the Legislator should consider whether the independence*  
21 *of judgment of a reasonable person in his or her position upon the*  
22 *matter in question would be materially affected by:*

23 *(a) His or her acceptance of a gift or loan;*

24 *(b) His or her private economic interest; or*

25 *(c) His or her commitment to a member of his or her*  
26 *household or his or her immediate family.*

27 *2. Except as otherwise provided in subsection 3, if a*  
28 *Legislator knows he or she has a conflict of interest pursuant to*  
29 *subsection 1, the Legislator shall make a general disclosure of the*  
30 *conflict of interest on the record in a meeting of a committee or on*  
31 *the floor of the Senate, as applicable. Such a disclosure must be*  
32 *entered:*

33 *(a) If the Legislator makes the disclosure in a meeting of a*  
34 *committee, in the minutes for that meeting.*

35 *(b) If the Legislator makes the disclosure on the floor of the*  
36 *Senate, in the Journal.*

37 *3. If, on one or more prior occasions during the current*  
38 *session of the Legislature, a Legislator has made a general*  
39 *disclosure of a conflict of interest on the record in a meeting of a*  
40 *committee or on the floor of the Senate, the Legislator is not*  
41 *required to make that general disclosure at length again regarding*  
42 *the same conflict of interest if, when the matter in question arises*  
43 *on subsequent occasions, the Legislator makes a reference on the*  
44 *record to the previous disclosure.*



1     ***4. In determining whether to abstain from voting upon,***  
2 ***advocating or opposing a matter concerning which a Legislator***  
3 ***has a conflict of interest pursuant to subsection 1, the Legislator***  
4 ***should consider whether:***

5       ***(a) The conflict impedes his or her independence of judgment;***  
6 ***and***

7       ***(b) His or her interest is greater than the interests of an entire***  
8 ***class of persons similarly situated.***

9     ***5. The provisions of this rule do not under any circumstances***  
10 ***and regardless of any conflict of interest:***

11       ***(a) Prohibit a Legislator from requesting or introducing a***  
12 ***legislative measure; or***

13       ***(b) Require a Legislator to take any particular action before or***  
14 ***while requesting or introducing a legislative measure.***

15     ***6. If a Legislator who is a member of a committee declares on***  
16 ***the record when a vote is to be taken by the committee that he or***  
17 ***she will abstain from voting because of the requirements of this***  
18 ***rule, the necessary quorum to act upon and the number of votes***  
19 ***necessary to act upon the matter is reduced as though the***  
20 ***Legislator abstaining were not a member of the committee.***

21     ***7. Except as otherwise provided in the Joint Rules of the 27th***  
22 ***Special Session, the standards and procedures set forth in this rule***  
23 ***which govern whether and to what extent a Senator has a conflict***  
24 ***of interest, should disclose a conflict of interest or should abstain***  
25 ***from voting upon, advocating or opposing a matter concerning***  
26 ***which the Senator has a conflict of interest pursuant to***  
27 ***subsection 1:***

28       ***(a) Are exclusive and are the only standards and procedures***  
29 ***that apply to Senators with regard to such matters; and***

30       ***(b) Supersede and preempt all other standards and procedures***  
31 ***with regard to such matters.***

32  
33                           ***V. QUORUM, VOTING, ELECTIONS***

34  
35 ***Rule No. 12. Action Required to Be Taken in Senate Chamber.***

36     ***Any action taken by the Senate must be taken in the Senate***  
37 ***Chamber.***

38  
39 ***Rule No. 13. Recorded Vote—Three Required to Call For.***

40     ***1. A recorded vote must be taken upon final passage of a bill***  
41 ***or joint resolution, and in any other case when called for by three***  
42 ***members. Every Senator within the bar of the Senate shall vote***  
43 ***“yea” or “nay” or record himself or herself as “not voting,” unless***  
44 ***excused by unanimous vote of the Senate.***



1       2. *The votes and names of those absent or recorded as “not*  
2 *voting” and the names of Senators demanding the recorded vote*  
3 *must be entered in the Journal.*

4  
5 *Rule No. 14. President to Decide—Tie Vote.*

6       *A question is lost by a tie vote, but when the Senate is equally*  
7 *divided on any question except the passage of a bill or joint*  
8 *resolution, the President may give the deciding vote.*

9  
10 *Rule No. 15. Manner of Election—Voting.*

11       1. *In all cases of election by the Senate, the vote must be*  
12 *taken viva voce. In other cases, if a vote is to be recorded, it may*  
13 *be taken by oral roll-call or by electronic recording.*

14       2. *When a recorded vote is taken, no Senator may:*

15       (a) *Vote except when at his or her seat;*

16       (b) *Explain his or her vote or discuss the question while the*  
17 *voting is in progress; or*

18       (c) *Change his or her vote after the result is announced.*

19       3. *The announcement of the result of any vote must not be*  
20 *postponed.*

21  
22                                   **VI. LEGISLATIVE BODIES**

23  
24 *Rule No. 16. Committee of the Whole.*

25       1. *All bills and resolutions may be referred only to the*  
26 *Committee of the Whole or to such standing committee as may be*  
27 *appointed pursuant to Rule No. 16.5.*

28       2. *The Majority Leader shall preside as Chair of the*  
29 *Committee of the Whole or name a Chair to preside.*

30       3. *Any meeting of the Committee of the Whole may be*  
31 *conducted outside the Senate Chamber, as designated by the Chair*  
32 *of the Committee.*

33       4. *A member of the Committee of the Whole may speak only*  
34 *once on an item listed on the Committee’s agenda, for a period of*  
35 *not more than 10 minutes, unless he or she is granted leave of the*  
36 *Chair to speak for a longer period or more than once. If a member*  
37 *is granted leave to speak for a longer period or more than once,*  
38 *the Chair may limit the length of additional time that the member*  
39 *may speak.*

40       5. *The Chair may require any vote of the Committee of the*  
41 *Whole to be recorded in the manner designated by the Chair.*

42       6. *All amendments proposed by the Committee of the Whole:*

43       (a) *Must first be approved by the Committee.*

44       (b) *Must be reported by the Chair to the Senate.*



1       7. *The minutes of the Committee's meetings must be entered*  
2 *in the final Journal.*

3  
4 ***Rule No. 16.5. Standing Committees.***

5       *In addition to the Committee of the Whole, such standing*  
6 *committees may be appointed as may be deemed necessary.*

7  
8 ***Rule No. 17. Rules Applicable to Standing Committees and***  
9 ***Committee of the Whole.***

10       *The Rules of the Senate shall apply to proceedings in*  
11 *Committee of the Whole and such standing committees as may be*  
12 *appointed, except that the previous question shall not be ordered.*  
13 *Messages may be received by the President while the Committee is*  
14 *sitting; in which case the President shall resume the chair and*  
15 *receive the message. After receiving the message, the President*  
16 *shall vacate the chair in favor of the Chair of the Committee. The*  
17 *rules of parliamentary practice contained in Mason's Manual of*  
18 *Legislative Procedure shall govern such committees in all cases in*  
19 *which they are applicable and in which they are not inconsistent*  
20 *with the rules and orders of the Senate.*

21  
22 ***Rule No. 18. Motion to Rise Committee of the Whole.***

23       *A motion that the Committee of the Whole rise shall always be*  
24 *in order, and shall be decided without debate.*

25  
26                                   **VII. RULES GOVERNING MOTIONS**

27  
28                                   **A. MOTIONS GENERALLY**

29  
30 ***Rule No. 19. Entertaining.***

31       1. *No motion may be debated until it is announced by the*  
32 *President.*

33       2. *By consent of the Senate, a motion may be withdrawn*  
34 *before amendment or decision.*

35  
36 ***Rule No. 20. Precedence of Motions.***

37       *When a question is under debate, no motion shall be received*  
38 *but the following, which shall have precedence in the order*  
39 *named:*

- 40       1. *To adjourn.*  
41       2. *For a call of the Senate.*  
42       3. *To recess.*  
43       4. *To lay on the table.*  
44       5. *For the previous question.*  
45       6. *To postpone to a day certain.*



1 7. *To commit.*

2 8. *To amend.*

3 9. *To postpone indefinitely.*

4 ↪ *The first four shall be decided without debate.*

5  
6 **Rule No. 21. *When Not Entertained.***

7 1. *When a motion to commit, to postpone to a day certain, or*  
8 *to postpone indefinitely has been decided, it must not be again*  
9 *entertained on the same day.*

10 2. *When a question has been postponed indefinitely, it must*  
11 *not again be introduced during the Special Session.*

12 3. *There must be no reconsideration of a vote on a motion to*  
13 *postpone indefinitely.*

14  
15 **B. PARTICULAR MOTIONS**

16  
17 **Rule No. 22. *To Adjourn.***

18 *A motion to adjourn shall always be in order. The name of the*  
19 *Senator moving to adjourn, and the time when the motion was*  
20 *made, shall be entered in the Journal.*

21  
22 **Rule No. 23. *Lay on the Table.***

23 *A motion to lay on or take from the table shall be carried by a*  
24 *majority vote.*

25  
26 **Rule No. 24. *To Strike Enacting Clause.***

27 *A motion to strike out the enacting clause of a bill or resolution*  
28 *has precedence over a motion to commit or amend. If a motion to*  
29 *strike out the enacting clause of a bill or resolution is carried, the*  
30 *bill or resolution is rejected.*

31  
32 **Rule No. 25. *Division of Question.***

33 1. *Any Senator may call for a division of a question.*

34 2. *A question must be divided if it embraces subjects so*  
35 *distinct that if one subject is taken away, a substantive proposition*  
36 *remains for the decision of the Senate.*

37 3. *A motion to strike out and insert must not be divided.*

38  
39 **Rule No. 26. *Explanation of Motion.***

40 *Whenever a Senator moves to change the usual disposition of a*  
41 *bill or resolution, he or she shall describe the subject of the bill or*  
42 *resolution and state the reasons for requesting the change in the*  
43 *processing of the bill or resolution.*





VIII. DEBATE

1  
2  
3 **Rule No. 27. Speaking on Question.**

4 1. Every Senator who speaks shall, standing in his or her  
5 place, address "Mr. or Madam President," in a courteous manner,  
6 and shall confine himself or herself to the question before the  
7 Senate. When the member has finished, he or she shall sit down.

8 2. Except as otherwise provided in Senate Rules Nos. 10 and  
9 45 of the 27th Special Session, a Senator may speak only once on  
10 a question before the Senate, for a period of not more than 10  
11 minutes, unless he or she is granted leave of the President to speak  
12 for a longer period or more than once. If a Senator is granted  
13 leave to speak for a longer period or more than once, the President  
14 may limit the length of additional time that the member may  
15 speak.

16 3. Incidental and subsidiary questions arising during debate  
17 shall not be considered the same question.

18  
19 **Rule No. 28. Previous Question.**

20 The previous question shall not be put unless demanded by  
21 three Senators, and it shall be in this form: "Shall the main  
22 question be now put?" When sustained by a majority of Senators  
23 present, it shall put an end to all debate and bring the Senate to a  
24 vote on the question or questions before it, and all incidental  
25 questions arising after the motion was made shall be decided  
26 without debate. A person who is speaking on a question shall not  
27 while he or she has the floor move to put that question.

28  
29 IX. CONDUCT OF BUSINESS

30  
31 A. GENERALLY

32  
33 **Rule No. 29. Mason's Manual.**

34 The rules of parliamentary practice contained in Mason's  
35 Manual of Legislative Procedure shall govern the Senate in all  
36 cases in which they are applicable and in which they are not  
37 inconsistent with the rules and orders of the Senate for the 27th  
38 Special Session of the Legislature, and the Joint Rules of the  
39 Senate and Assembly for the 27th Special Session of the  
40 Legislature.

41  
42 **Rule No. 30. Suspension of Rule.**

43 No rule or order of the Senate for the 27th Special Session of  
44 the Legislature shall be rescinded or changed without a majority  
45 vote of the Senate; but, except as otherwise provided in Senate



1 *Rule No. 39 of the 27th Special Session of the Legislature, a rule*  
2 *or order may be temporarily suspended for a special purpose by a*  
3 *majority vote of the members present. When the suspension of a*  
4 *rule is called for, and after due notice from the President no*  
5 *objection is offered, the President can announce the rule*  
6 *suspended and the Senate may proceed accordingly; but this shall*  
7 *not apply to that portion of Senate Rule No. 39 of the 27th Special*  
8 *Session of the Legislature relating to the third reading of bills,*  
9 *which cannot be suspended.*

10  
11 *Rule No. 31. Protest.*

12 *Any Senator, or Senators, may protest against the action of the*  
13 *Senate upon any question, and have such protest entered in the*  
14 *Journal.*

15  
16 *Rule No. 32. Privilege of the Floor.*

17 *1. To preserve decorum and facilitate the business of the*  
18 *Senate, only the following persons may be present on the floor of*  
19 *the Senate during formal sessions:*

- 20 *(a) State officers;*  
21 *(b) Officers and members of the Senate;*  
22 *(c) Employees of the Legislative Counsel Bureau;*  
23 *(d) Attaches and employees of the Senate; and*  
24 *(e) Members of the Assembly whose presence is required for*  
25 *the transaction of business.*

26 *2. Guests of Senators must be seated in a section of the upper*  
27 *or lower gallery of the Senate Chamber to be specially designated*  
28 *by the Sergeant at Arms. The Majority Leader may specify special*  
29 *occasions when guests may be seated on the floor of the Senate*  
30 *with a Senator.*

31 *3. A majority of Senators may authorize the President to have*  
32 *the Senate Chamber cleared of all persons except Senators and*  
33 *officers of the Senate.*

34 *4. The Senate Chamber may not be used for any business*  
35 *other than legislative business during a legislative session.*

36  
37 *Rule No. 33. Material Placed on Legislators' Desks.*

38 *1. Only the Sergeant at Arms and officers and employees of*  
39 *the Senate may place papers, letters, notes, pamphlets and other*  
40 *written material upon a Senator's desk. Such material must*  
41 *contain the name of the Legislator requesting the placement of the*  
42 *material on the desk or a designation of the origin of the material.*

43 *2. This rule does not apply to books containing the legislative*  
44 *bills and resolutions, the daily histories and daily journals of the*  
45 *Senate or Assembly, or Legislative Counsel Bureau material.*



1 **Rule No. 34. Petitions and Memorials.**

2 *The contents of any petition or memorial shall be briefly stated*  
3 *by the President or any Senator presenting it. It shall then lie on*  
4 *the table or be referred, as the President or Senate may direct.*

5 **Rule No. 35. Objection to Reading of Paper.**

6 *Where the reading of any paper is called for, and is objected to*  
7 *by any Senator, it shall be determined by a vote of the Senate, and*  
8 *without debate.*

9  
10 **Rule No. 36. Questions Relating to Priority of Business.**

11 *All questions relating to the priority of business shall be*  
12 *decided without debate.*

13  
14 **B. BILLS**

15  
16 **Rule No. 37. Requests for the Drafting of Bills, Resolutions and**  
17 **Amendments.**

18 *The Legislative Counsel shall not honor a request for the*  
19 *drafting of a bill, resolution or amendment to be introduced in the*  
20 *Senate unless it is submitted by the Committee of the Whole, a*  
21 *standing committee, a Conference Committee or the Governor.*

22  
23 **Rule No. 38. Introduction of Bills.**

24 *1. Except as otherwise provided in this rule, no bill or*  
25 *resolution may be introduced in the Senate unless it is first*  
26 *approved by the Committee of the Whole or a standing committee.*

27 *2. The provisions of subsection 1 do not apply to a bill or*  
28 *resolution that is:*

29 *(a) Required to carry out the business of the Senate or the*  
30 *Legislature; or*

31 *(b) Requested by the Governor.*

32 *3. Skeleton bills may not be introduced.*

33  
34 **Rule No. 39. Reading of Bills.**

35 *1. Every bill must receive three readings before its passage,*  
36 *unless, in case of emergency, this rule is suspended by a two-thirds*  
37 *vote of the members elected to the Senate.*

38 *2. The first reading of a bill is for information, and if there is*  
39 *opposition to the bill, the question must be, "Shall this bill receive*  
40 *no further consideration?" If there is no opposition to the bill, or*  
41 *if the question to reject is defeated, the bill must then take the*  
42 *usual course.*

43 *3. No bill may be committed until once read, nor amended*  
44 *until twice read.*

45 *4. The third reading of every bill must be by sections.*



1 **Rule No. 40. Second Reading File—Consent Calendar.**

2 1. All bills or joint resolutions reported by the Committee of  
3 the Whole or a standing committee must be placed on a Second  
4 Reading File unless recommended for placement on the Consent  
5 Calendar.

6 2. The Committee of the Whole or a standing committee shall  
7 not recommend a bill or joint resolution for placement on the  
8 Consent Calendar if:

9 (a) An amendment of the bill or joint resolution is  
10 recommended;

11 (b) It contains an appropriation;

12 (c) It requires a two-thirds vote of the Senate; or

13 (d) It is controversial in nature.

14 3. A bill or joint resolution must be removed from the  
15 Consent Calendar at the request of any Senator. A bill or joint  
16 resolution so removed must be immediately placed on the Second  
17 Reading File for consideration in the usual order of business.

18 4. When the Consent Calendar is called, the bills remaining  
19 on the Consent Calendar must be read by number and summary,  
20 and the vote must be taken on their final passage as a group.

21  
22 **Rule No. 41. Reading of Bills—General File.**

23 1. Upon reading of bills on the Second Reading File, Senate  
24 and Assembly bills reported without amendments must be placed  
25 on the General File.

26 2. Only amendments proposed by the Committee of the Whole  
27 may be considered.

28 3. Amendments proposed by the Committee of the Whole and  
29 reported with bills may be adopted by a majority vote of the  
30 members present. Bills so amended must be reprinted, engrossed  
31 or reengrossed, and placed on the General File. The File must be  
32 made available to members of the public each day by the
