A BILL

To amend sections 3335.02, 3335.09, 3337.01, 1
3339.01, 3341.02, 3343.02, 3343.06, 3344.01, 2
3350.10, 3352.01, 3356.01, 3359.01, 3361.01, 3
3362.01, and 3364.01 of the Revised Code to 4
grant student members of the boards of trustees 5
of state universities and the Northeast Ohio 6
Medical University voting power and the 7
authority to attend executive sessions. 8

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That sections 3335.02, 3335.09, 3337.01, 9
3339.01, 3341.02, 3343.02, 3343.06, 3344.01, 3350.10, 3352.01, 10
3356.01, 3359.01, 3361.01, 3362.01, and 3364.01 of the Revised 11
Code be amended to read as follows: 12

Sec. 3335.02. (A) The government of the Ohio state 13
university shall be vested in a board of fourteen trustees in 14
2005, and seventeen trustees beginning in 2006, who shall be 15
appointed by the governor, with the advice and consent of the 16
senate. Two of the seventeen trustees shall be students at the 17
Ohio state university, and their selection and terms shall be in 18
accordance with division (B) of this section. Except as provided 19

in division (C) of this section and except for the terms of 20
student members, terms of office shall be for nine years, 21
commencing on the fourteenth day of May and ending on the 22
thirteenth day of May. Each trustee shall hold office from the 23
date of appointment until the end of the term for which the 24
trustee was appointed. Any trustee appointed to fill a vacancy 25
occurring prior to the expiration of the term for which the 26
trustee's predecessor was appointed shall hold office for the 27
remainder of such term. Any trustee shall continue in office 28
subsequent to the expiration date of the trustee's term until 29
the trustee's successor takes office, or until a period of sixty 30
days has elapsed, whichever occurs first. No person who has 31
served a full nine-year term or more than six years of such a 32
term shall be eligible for reappointment until a period of four 33
years has elapsed since the last day of the term for which the 34
person previously served. The trustees shall not receive 35
compensation for their services, but shall be paid their 36
reasonable necessary expenses while engaged in the discharge of 37
their official duties. 38

(B) The student members of the board of trustees of the 39
Ohio state university shall be students at the Ohio state 40
university, shall have no voting power on the board. ~~Student~~ 41
~~members, and shall not~~ be considered as members of the board in 42
determining whether a quorum is present. Student members shall 43
~~not~~ be entitled to attend executive sessions of the board. The 44
student members of the board shall be appointed by the governor, 45
with the advice and consent of the senate, from a group of five 46
candidates selected pursuant to a procedure adopted by the 47
university's student governments and approved by the 48
university's board of trustees. The initial term of office of 49
one of the student members shall commence on May 14, 1988, and 50

shall expire on May 13, 1989, and the initial term of office of 51
the other student member shall commence on May 14, 1988, and 52
expire on May 13, 1990. Thereafter, terms of office of student 53
members shall be for two years, each term ending on the same day 54
of the same month of the year as the term it succeeds. In the 55
event a student member cannot fulfill a two-year term, a 56
replacement shall be selected to fill the unexpired term in the 57
same manner used to make the original selection. 58

No student shall be disqualified from membership on the 59
board of trustees because the student receives a scholarship, 60
grant, loan, or any other financial assistance payable out of 61
the state treasury or a university fund, or because the student 62
is employed by the university in a position pursuant to a work- 63
study program or other student employment, including as a 64
graduate teaching assistant, graduate administrative assistant, 65
or graduate research assistant, the compensation for which is 66
payable out of the state treasury or a university fund. 67

Acceptance of such financial assistance or employment by a 68
student trustee shall not be considered a violation of Chapter 69
102. or section 2921.42 or 2921.43 of the Revised Code. 70

(C) (1) The initial terms of office for the three 71
additional trustees appointed in 2005 shall commence on a date 72
in 2005 that is selected by the governor with one term of office 73
expiring on May 13, 2009, one term of office expiring on May 13, 74
2010, and one term of office expiring on May 13, 2011, as 75
designated by the governor upon appointment. Thereafter terms of 76
office shall be for nine years, as provided in division (A) of 77
this section. 78

(2) The initial terms of office for the three additional 79
trustees appointed in 2006 shall commence on May 14, 2006, with 80

one term of office expiring on May 13, 2012, one term of office 81
expiring on May 13, 2013, and one term of office expiring on May 82
13, 2014, as designated by the governor upon appointment. 83
Thereafter terms of office shall be for nine years, as provided 84
in division (A) of this section. 85

Sec. 3335.09. The board of trustees of the Ohio state 86
university shall elect, fix the compensation of, and remove, the 87
president and such number of professors, teachers, and other 88
employees as are necessary; ~~but~~. Except as provided under 89
division (B) of section 3335.02 of the Revised Code, no trustee, 90
~~or his relation~~ relative of a trustee by blood or marriage, 91
shall be eligible to a professorship or position in the 92
university, the compensation for which is payable out of the 93
state treasury or a university fund. The board shall fix and 94
regulate the course of instruction and prescribe the extent and 95
character of experiments to be made at the university. 96

Sec. 3337.01. (A) The body politic and corporate by the 97
name and style of "The President and Trustees of the Ohio 98
University" now in the university instituted and established in 99
Athens by the name and style of "The Ohio University" shall 100
consist of a board of trustees composed of eleven members, who 101
shall be appointed by the governor, with the advice and consent 102
of the senate. At least five of the trustees who are not 103
students shall be graduates of Ohio university. Two of the 104
trustees shall be students at Ohio university, and their 105
selection and terms shall be in accordance with division (B) of 106
this section. A majority of the board constitutes a quorum. 107
Except for the terms of student members, terms of office shall 108
be for nine years, commencing on the fourteenth day of May and 109
ending on the thirteenth day of May, except that upon expiration 110
of the term ending on May 14, 1978, the new term which succeeds 111

it shall commence on May 15, 1978, and end on May 13, 1987. Each member shall hold office from the date of appointment until the end of the term for which the member was appointed. Any member appointed to fill a vacancy occurring prior to the expiration of the term for which the member's predecessor was appointed shall hold office for the remainder of such term. Any member shall continue in office subsequent to the expiration date of the member's term until the member's successor takes office, or until a period of sixty days has elapsed, whichever occurs first. No person who has served a full nine-year term or more than six years of such a term shall be eligible for reappointment until a period of four years has elapsed since the last day of the term for which the person previously served. Such trustees shall receive no compensation for their services, but shall be paid their actual and necessary expenses while engaged in the discharge of their official duties.

(B) The student members of the board of trustees of the Ohio university shall be students at the Ohio university, shall have ~~no~~ voting power on the board. ~~Student members, and shall~~ ~~not~~ be considered as members of the board in determining whether a quorum is present. Student members shall ~~not~~ be entitled to attend executive sessions of the board. The student members of the board shall be appointed by the governor, with the advice and consent of the senate, from a group of five candidates selected pursuant to a procedure adopted by the university's student governments and approved by the university's board of trustees. The initial term of office of one of the student members shall commence on May 14, 1988, and shall expire on May 13, 1989, and the initial term of office of the other student member shall commence on May 14, 1988, and expire on May 13, 1990. Thereafter, terms of office of student members shall be

for two years, each term ending on the same day of the same 143

Sec. 3339.01. (A) The government of Miami university shall 160
be vested in eleven trustees, who shall be appointed by the 161
governor, with the advice and consent of the senate. Two of the 162
trustees shall be students at Miami university, and their 163
selection and terms shall be in accordance with division (B) of 164
this section. A majority of the board constitutes a quorum. 165
Except for the terms of student members, terms of office shall 166
be for nine years, commencing on the first day of March and 167
ending on the last day of February, except that upon expiration 168
of the trustee term ending on March 1, 1974, the trustee term 169
which succeeds it shall commence on March 2, 1974, and end on 170
February 28, 1983; upon expiration of the trustee term ending on 171
March 1, 1977, the trustee term which succeeds it shall commence 172

on March 2, 1977, and end on February 28, 1986; upon expiration 173
of the trustee term ending on March 1, 1978, the trustee term 174
which succeeds it shall commence on March 2, 1978, and end on 175
February 28, 1987; and upon expiration of the trustee term 176
ending on March 1, 1979, the trustee term which succeeds it 177
shall commence on March 2, 1979, and end on February 29, 1988. 178
Each trustee shall hold office from the date of appointment 179
until the end of the term for which the trustee was appointed. 180
Any trustee appointed to fill a vacancy occurring prior to the 181
end of the term for which the trustee's predecessor was 182
appointed shall hold office for the remainder of such term. Any 183
trustee shall continue in office subsequent to the expiration 184
date of the trustee's term until a successor takes office, or 185
until a period of sixty days has elapsed, whichever occurs 186
first. No person who has served a full nine-year term or more 187
than six years of such a term shall be eligible for 188
reappointment until a period of four years has elapsed since the 189

and consent of the senate, from a group of five candidates 201

student governments and approved by the university's board of 203

trustees. The initial term of office of one of the student 204
members shall commence on March 1, 1988, and shall expire on 205
February 28, 1989, and the initial term of office of the other 206
student member shall commence on March 1, 1988, and expire on 207
February 28, 1990. Thereafter, terms of office of student 208
members shall be for two years, each term ending on the last day 209
of February. In the event that a student member cannot fulfill 210
the student member's two-year term, a replacement shall be 211
selected to fill the unexpired term in the same manner used to 212

Sec. 3341.02. (A) The government of Bowling Green state 226
university is vested in a board of eleven trustees, who shall be 227
appointed by the governor, with the advice and consent of the 228
senate. Two of the trustees shall be students at Bowling Green 229
state university, and their selection and terms shall be in 230
accordance with division (B) of this section. A majority of the 231
board constitutes a quorum. Except for the terms of student 232
members, terms of office shall be for nine years, commencing on 233

the seventeenth day of May and ending on the sixteenth day of 234
May. No person who has served a full nine-year term or more than 235
six years of such a term shall be eligible for reappointment 236
until a period of four years has elapsed since the last day of 237
the term for which the person previously served. 238

(B) The student members of the board of trustees of 239
Bowling Green state university shall be students at Bowling 240
Green state university, shall have no-voting power on the board.— 241
Student members, and shall not be considered as members of the 242
board in determining whether a quorum is present. Student 243
members shall not be entitled to attend executive sessions of 244
the board. The student members of the board shall be appointed 245
by the governor, with the advice and consent of the senate, from 246
a group of five candidates selected pursuant to a procedure 247
adopted by the university's student governments and approved by 248
the university's board of trustees. The initial term of office 249
of one of the student members shall commence on March 17, 1988, 250
and shall expire on March 16, 1989, and the initial term of 251
office of the other student member shall commence on March 17, 252
1988, and expire on March 16, 1990. After September 22, 2000, 253
terms of office shall commence on the seventeenth day of May and 254
shall end on the sixteenth day of May. Terms of office of 255
student members shall be for two years, each term ending on the 256
same day of the same month of the year as the term it succeeds. 257
In the event that a student member cannot fulfill the student 258
member's two-year term, a replacement shall be selected in the 259
manner used for the original selection to fill the unexpired 260
term. 261

No student shall be disqualified from membership on the 262
board of trustees because the student receives a scholarship, 263
grant, loan, or any other financial assistance payable out of 264

the state treasury or a university fund, or because the student 265
is employed by the university in a position pursuant to a work- 266
study program or other student employment, including as a 267
graduate teaching assistant, graduate administrative assistant, 268

state university shall be students at Kent state university, 288

entitled to attend executive sessions of the board. The student 292
members of the board shall be appointed by the governor, with 293
the advice and consent of the senate, from a group of five 294

the trustees shall be students at Central state university, and 337
their selection and terms shall be in accordance with division 338
(B) of this section. A majority of the board constitutes a 339
quorum. Except for the student members, terms of office shall be 340
for nine years, commencing on the first day of July and ending 341
on the thirtieth day of June. Each member shall hold office from 342
the date of appointment until the end of the term for which the 343
member was appointed. Any member appointed to fill a vacancy 344
occurring prior to the expiration of the term for which the 345
member's predecessor was appointed shall hold office for the 346
remainder of such term. Any member shall continue in office 347
subsequent to the expiration date of the member's term until the 348
member's successor takes office, or until a period of sixty days 349

and remove such number of professors, teachers, and other 391
employees as is necessary. ~~No~~ Except as provided under division 392
(B) of section 3343.02 of the Revised Code, no trustee, or his- 393
relative of a trustee by blood or marriage, is eligible to a 394
professorship or position in the university, the compensation 395
for which is payable out of the state treasury or a university 396
fund. ~~No~~, and no officer, teacher, or other employee of the 397
university is eligible to membership on the board of trustees of 398
such university while occupying any of said positions. 399

Sec. 3344.01. (A) There is hereby created the Cleveland 400
state university. The government of the Cleveland state 401
university is vested in a board of eleven trustees, who shall be 402
appointed by the governor, with the advice and consent of the 403
senate. Two of the trustees shall be students at the Cleveland 404
state university, and their selection and terms shall be in 405
accordance with division (B) of this section. Except for the 406
student members, terms of office shall be for nine years, 407
commencing on the second day of May and ending on the first day 408
of May. Each trustee shall hold office from the date of 409
appointment until the end of the term for which the trustee was 410
appointed. Any trustee appointed to fill a vacancy occurring 411
prior to the expiration of the term for which the trustee's 412
predecessor was appointed shall hold office for the remainder of 413
such term. Any trustee shall continue in office subsequent to 414
the expiration date of the trustee's term until the trustee's 415
successor takes office, or until a period of sixty days has 416
elapsed, whichever occurs first. No person who has served a full 417

nine-year term or more than six years of such a term shall be 418
eligible for reappointment until a period of four years has 419
elapsed since the last day of the term for which the person 420

Sec. 3350.10. (A) There is hereby created the northeast 457
Ohio medical university. The principal goal of the medical 458
university shall be to collaborate with the university of Akron, 459
Cleveland state university, Kent state university, and 460
Youngstown state university to graduate physicians oriented to 461
the practice of medicine at the community level, especially 462
family physicians. To accomplish this goal, the medical 463
university may incorporate in the clinical experience provided 464
its students the several community hospitals in the cities and 465
areas served by the medical university; utilize practicing 466
physicians as teachers; and to the fullest extent possible 467
utilize the basic science capabilities of the university of 468
Akron, Cleveland state university, Kent state university, and 469
Youngstown state university. 470

(1) Until December 22, 2008, the government of the 471
northeast Ohio medical university is vested in a nine-member 472
board of trustees consisting of the presidents of the university 473
of Akron, Kent state university, and Youngstown state 474
university; one member each of the boards of trustees of the 475
university of Akron, Kent state university, and Youngstown state 476
university, to be appointed by their respective boards of 477
trustees for a term of six years ending on the first day of May 478

or until the trustee's term on the respective university board 479
of trustees expires, whichever occurs first; and one person each 480
to be appointed by the boards of trustees of the university of 481
Akron, Kent state university, and Youngstown state university, 482
for a term of nine years ending on the first day of May; except 483
that the term of those first appointed by the several boards of 484
trustees shall expire on the first day of May next following 485
their appointment. Vacancies shall be filled for the unexpired 486
term in the manner provided for original appointment. The 487
trustees shall receive no compensation for their services but 488
shall be paid their reasonable necessary expenses while engaged 489
in the discharge of their official duties. A majority of the 490
board constitutes a quorum. 491

(2) Beginning December 22, 2008, the government of the 492
northeast Ohio medical university is vested in a board of eleven 493
trustees, who shall be appointed by the governor, with the 494
advice and consent of the senate. Two of the trustees shall be 495
current students of the medical university, and their selection 496
and terms shall be in accordance with division (B) of this 497
section. Except as provided in division (A)(3) of this section 498
and except for the student members, terms of office shall be for 499
nine years. Each trustee shall hold office from the date of 500
appointment until the end of the term for which the trustee was 501
