BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 3313.814 of the Revised Code be	6
amended to read as follows:	7
Sec. 3313.814. (A) As used in this section and sections	8
3313.816 and 3313.817 of the Revised Code:	9
(1) "A la carte item" means an individually priced food or	10
beverage item that is available for sale to students through any	11
of the following:	12
(a) A school food service program;	13
(b) A vending machine located on school property;	14
(c) A store operated by the school, a student association,	15
or other school-sponsored organization.	16
"A la carte item" does not include any food or beverage	17

item available for sale in connection with a school-sponsored			
fundraiser held outside of the regular school day, any other			
school-sponsored event held outside of the regular school day,			
or an interscholastic athletic event. "A la carte item" also			
does not include any food or beverage item that is part of a			
reimbursable meal and that is available for sale as an			
individually priced item in a serving portion of the same size			
as in the reimbursable meal, regardless of whether the food or			
beverage item is included in the reimbursable meal served on a			
particular school day.			

- (2) "Added sweeteners" means any additives that enhance 28 the sweetness of a beverage, including processed sugar. "Added 29 sweeteners" do not include any natural sugars found in fruit 30 juices that are a component of the beverage. 31
- (3) "Extended school day" means the period before and

 32 after the regular school day during which students participate

 33 in school-sponsored extracurricular activities, latchkey

 34 programs as defined in section 3313.207 of the Revised Code, or

 35 other academic or enrichment programs.

- (4) "Regular school day" means the period each school day37between the designated arrival time for students and the end ofthe final instructional period.39
- (5) "Reimbursable meal" means a meal that is provided to

 students through a school breakfast or lunch program established

 under the "National School Lunch Act," 60 Stat. 230 (1946), 42

 U.S.C. 1751, as amended, and the "Child Nutrition Act of 1966,"

 80 Stat. 885, 42 U.S.C. 1771, as amended, and that meets the

 criteria for reimbursement established by the United States

(6) "School food service program" means a school food	47
service program operated under section 3313.81 or 3313.813 of	48

(B) Each school district board of education and each	50
chartered nonpublic school governing authority shall adopt and	51
enforce nutrition standards governing the types of food and	52
beverages that may be sold on the premises of its schools, and	53
specifying the time and place each type of food or beverage may	54
be sold.	55
(1) In adopting the standards, the board or governing	56
authority shall do all of the following:	57
(a) Consider the nutritional value of each food or	58
beverage;	59
(b) Consult with a dietitian licensed under Chapter 4759.	60
of the Revised Code, a dietetic technician registered by the	61
commission on dietetic registration, or a school nutrition	62
specialist certified or credentialed by the school nutrition	63
association. The person with whom the board or governing	64

(c) Consult the dietary guidelines for Americans jointly	69
developed by the United States department of agriculture and the	70

(2) No food or beverage may be sold on any school premises	74
except in accordance with the standards adopted by the board or	75

(3) The standards shall comply with sections 3313.816 and	77	
3313.817 of the Revised Code, but nothing in this section shall	78 79	
prohibit the standards from being more restrictive than		
otherwise required by those sections.	80	
(C) The nutrition standards adopted under this section	81	
shall prohibit the placement of vending machines in any	82	
classroom where students are provided instruction, unless the	83	
classroom also is used to serve students meals. This division	84	
does not apply to vending machines that sell only milk,	85	
reimbursable meals, or food and beverage items that are part of	86	
a reimbursable meal and are available for sale as individually	87	
priced items in serving portions of the same size as in the	88	
reimbursable meal.	89	
(D) Each board or governing authority shall designate	90	
staff to be responsible for ensuring that the school district or	91	
school meets the nutrition standards adopted under this section.	92	
The staff shall prepare an annual report regarding the	93	
district's or school's compliance with the standards and submit	94	
it to the department of education. The board or governing	95	
authority annually shall schedule a presentation on the report	96	
at one of its regular meetings. Each district or school shall	97	
make copies of the report available to the public upon request.	98	
(E) The state board of education shall formulate do both	99	
of the following:	100	
(1) Formulate and adopt guidelines, which boards of	101	
education and chartered nonpublic schools may follow in	102	
enforcing and implementing this section.

this amendment, adopt rules pursuant to Chapter 119. of the	105
Revised Code regarding the sale of beverages and food during the	106
regular school day in connection with a school-sponsored	107
fundraiser. The rules shall specify that, if a fundraiser takes	108
place during the regular school day for not more than the	109
equivalent of thirty school days during a school year, the sale	110
of beverages and food in connection with that fundraiser, shall	111
be exempt from sections 3313.816 and 3313.817 of the Revised	112
Code, so long as no beverages or food are sold in connection	113
with the fundraiser during the time of a meal service in the	114
food service area. Each school district board of education or	115
chartered nonpublic school governing authority may incorporate	
the rules adopted by the state board pursuant to this division	117
into the guidelines adopted by the district board or school	118
governing authority under division (B) of this section.	119
