**A BILL**

To enact section 109.661 of the Revised Code to 1  
create the anti-prostitution grant program fund 2  
and to make an appropriation. 3

**BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:**

**Section 1.** That section 109.661 of the Revised Code be 4  
enacted to read as follows: 5

Sec. 109.661. (A) There is hereby created in the state 6  
treasury the anti-prostitution grant program fund consisting of 7  
money appropriated to the fund by the general assembly. The 8  
attorney general shall administer the anti-prostitution grant 9  
program fund. 10

(B) The attorney general shall adopt rules pursuant to 11  
Chapter 119. of the Revised Code that shall establish procedures 12  
for anti-prostitution programs, such as programs certified by 13  
the Ohio supreme court as specialized dockets aimed at helping 14  
victims of human trafficking and programs for educating persons 15  
alleged to have engaged in soliciting, to apply to the attorney 16  
general for funding from the anti-prostitution grant program 17  
fund and procedures for the attorney general to distribute money 18  
out of the fund to anti-prostitution programs. 19

(C) An anti-prostitution program that receives funds from 20  
the anti-prostitution grant program fund shall use the funds 21  
received for programming aimed at reducing supply or demand for 22  
prostitution, as determined by the attorney general. 23

**Section 2.** All items in this section are hereby 24  
appropriated as designated out of any moneys in the state 25  
treasury to the credit of the designated fund. For all 26  
appropriations made in this act, those in the first column are 27  
for fiscal year 2020 and those in the second column are for 28  
fiscal year 2021. The appropriations made in this act are in 29  
addition to any other appropriations made for the FY 2020-FY 30  
2021 biennium. 31

ANTI-PROSTITUTION GRANT PROGRAM 37

On July 1 of each fiscal year of the biennium ending June 38  
30, 2021, or as soon as possible thereafter, the Director of 39  
Budget and Management shall transfer \$1,000,000 cash from the 40  
General Revenue Fund to the Anti-Prostitution Grant Program Fund 41  
(5WG0) created in section 109.661 of the Revised Code. 42

The foregoing appropriation item 055508, Anti-Prostitution 43  
Grant Program, shall be used for the anti-prostitution grant 44  
program as described in section 109.661 of the Revised Code. 45

**Section 3.** Within the limits set forth in this act, the 46

Director of Budget and Management shall establish accounts 47  
indicating the source and amount of funds for each appropriation 48  
made in this act, and shall determine the form and manner in 49  
which appropriation accounts shall be maintained. Expenditures 50  
from appropriations contained in this act shall be accounted for 51  
as though made in the main operating appropriations act of the 52  
133rd General Assembly. 53

The appropriations made in this act are subject to all 54  
provisions of the main operating appropriations act of the 133rd 55  
General Assembly that are generally applicable to such 56  
appropriations. 57
