A JOINT RESOLUTION

Proposing to enact Section 22 of Article I of the 1
Constitution of the State of Ohio to protect 2
individuals from being compelled to wear a mask or 3
other facial covering. 4

Be it resolved by the General Assembly of the State of 5
Ohio, three-fifths of the members elected to each house 6
concurring herein, that there shall be submitted to the electors 7
of the state, in the manner prescribed by law at the general 8
election to be held on November 5, 2024, a proposal to enact 9
Section 22 of Article I of the Constitution of the State of Ohio 10
to read as follows: 11

ARTICLE I 12

Section 22. (A) (1) No individual shall be required to wear 13
a mask or other facial covering in any of the following 14
locations: 15

<u>(a) A place of public accommodation;</u>	16
<u>(b) A facility owned or operated by a political subdivision or state agency;</u>	17
<u>(c) A court.</u>	18
<u>(2) Nothing in this section shall be construed as applying to a private residence.</u>	19
<u>(B) As used in this section:</u>	20
<u>(1) "Place of public accommodation" means all of the following:</u>	21
<u>(a) An inn, hotel, motel, or other place of lodging;</u>	22
<u>(b) A restaurant, bar, or other establishment serving food or drink;</u>	23
<u>(c) A motion picture house, theater, concert hall, stadium, or other place of exhibition or entertainment;</u>	24
<u>(d) An auditorium, convention center, lecture hall, or other place of public gathering;</u>	25
<u>(e) A bakery, grocery store, clothing store, hardware store, shopping center, or other sales or rental establishment;</u>	26
<u>(f) A laundromat, dry-cleaner, bank, barber shop, beauty shop, travel service, shoe repair service, funeral parlor, gas station, office of an accountant or lawyer, pharmacy, insurance office, professional office of a health care provider, publicly accessible area of a hospital, or other service establishment;</u>	27
<u>(g) A terminal, depot, or other station used for public transportation;</u>	28
<u>(h) A museum, library, gallery, or other place of public</u>	29

<u>display or collection;</u>	42
<u>(i) A park, zoo, amusement park, or other place of recreation;</u>	43 44
<u>(j) A preschool, elementary, secondary, undergraduate, or postgraduate public or private school, or other place of education;</u>	45 46 47
<u>(k) A child care center, senior citizen center, homeless shelter, food bank, adoption agency, or other social service center establishment; and</u>	48 49 50
<u>(l) A gymnasium, health spa, bowling alley, golf course, or other place of exercise or recreation.</u>	51 52
<u>(2) "State agency" means any organized body, office, agency, commission, board, institution, or other entity established by the laws of the state for the exercise of any function of state government.</u>	53 54 55 56
