BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That sections 103.85, 103.86, 103.87, and	4
103.88 of the Revised Code be enacted to read as follows:	5
Sec. 103.85. (A) As used in this section and in sections	6
103.86 to 103.88 of the Revised Code, "long-term care facility"	7
means all of the following:	8
(1) A nursing home, as defined in section 3721.01 of the	9
Revised Code;	10
(2) A facility or part of a facility that is certified as	11
a skilled nursing facility or a nursing facility under Title	12
XVIII or XIX of the "Social Security Act," 42 U.S.C. 1395 et	13
<u>seq. or 42 U.S.C. 1396 et seq.;</u>	14
(3) A residential care facility, as defined in section	15
3721.01 of the Revised Code.	16
(B) There is hereby created a long-term care inspection	17
committee as a subcommittee of the legislative service	18

commission. The committee shall consist of eight persons, four	19
of whom shall be members of the senate appointed by the	20
president of the senate, not more than two of whom shall be	21
members of the same political party, and four of whom shall be	22
members of the house of representatives appointed by the speaker	23
of the house of representatives, not more than two of whom shall	24
be members of the same political party.	25
Initial appointments to the committee shall be made within	26
fifteen days after the effective date of this section and in the	27
manner prescribed in this section. Thereafter, appointments to	28
the committee shall be made within fifteen days after the	29
commencement of the first regular session of the general	30
assembly and in the manner prescribed in this section. A vacancy	31
on the committee shall be filled for the unexpired term in the	32
same manner as the original appointment. Members of the	33
committee shall serve on the committee until the appointments	34
are made in the first regular session of the following general	35
assembly, unless they cease to be members of the general	36
assembly.	37
The committee, subject to the oversight and direction of	38
the legislative service commission, shall direct the work of the	39
director and staff of the committee.	40
Sec. 103.86. The long-term care inspection committee, by a	41
vote of at least five members, shall select from its membership	42
a chairperson, vice-chairperson, and secretary. The members of	43
the committee shall serve without compensation but shall be	44
reimbursed for their actual and necessary expenses incurred in	45
the discharge of their official duties.	46
Sec. 103.87. (A)(1) Subject to division (A)(2) of this	47
section, the long-term care inspection committee shall establish	48

and maintain a continuing program of inspection of each long-	49
term care facility in this state. The committee shall conduct an	50
inspection of each long-term care facility each biennium. The	51
inspection shall include attendance at one general meal period	52
and one social activity program.	53
(2) All of the following apply with respect to an	54
<u>inspection of a long-term care facility under division (A)(1) of</u>	55
this section:	56
(a) The inspection shall not be conducted unless the	57
chairperson of the committee grants prior approval for the	58
inspection.	59
(b) The inspection shall be conducted by at least one	60
staff member of the committee and may include one or more of the	61
members appointed to the committee.	62

(c) The inspectors shall be given access to the facility	63
or any part of the facility. The inspectors are not required to	64
give advance notice of, or to make prior arrangements before	65
conducting, the inspection.	66
(d) Unless the chairperson of the committee determines_	67
that the inspection must be conducted outside of normal business	68
hours for any reason, including emergency circumstances or a	69
justifiable cause that perpetuates the mission of the committee,	70
and the chairperson specifies in the grant of prior approval for	71
the inspection that the chairperson has so determined, the	72
inspection shall be conducted only during normal business hours.	73
If the chairperson determines that the inspection must be	74
conducted outside of normal business hours and the chairperson_	75
specifies in the grant of prior approval for the inspection that	76
the chairperson has so determined, the inspection may be	77

conducted outside of normal business hours. 78 (B) The committee shall evaluate and assist in the 79 development of programs to improve the condition or operation of 80 long-term care facilities. 81 (C) The committee shall prepare a report for submission to 82 the succeeding general assembly of the findings the committee 83 makes in its inspections and of any programs that have been 84 proposed or developed to improve the condition or operation of 85 the long-term care facilities in the state. The report shall 86 contain a separate evaluation of the resident grievance 87 procedure at each long-term care facility. The committee shall 88 submit the report to the succeeding general assembly within 89 fifteen days after commencement of that general assembly's first 90 regular session. 91 Sec. 103.88. The long-term care inspection committee may 92 employ a director and any other nonlegal staff, who shall be in 93 the unclassified service of the state, that are necessary for 94 the committee to carry out its duties and may contract for the 95 services of whatever nonlegal technical advisors are necessary 96 for the committee to carry out its duties. The attorney general 97 shall act as legal counsel to the committee. 98 The chairperson and vice-chairperson of the legislative 99 service commission shall fix the compensation of the director. 100 The director, with the approval of the director of the 101 legislative service commission, shall fix the compensation of 102 other staff of the committee in accordance with a salary 103 schedule established by the director of the legislative service 104 commission. Contracts for the services of necessary technical 105 advisors shall be approved by the director of the legislative 106 service commission. 107

The general assembly shall biennially appropriate to the	108
long-term care inspection committee an amount sufficient to	109
enable the committee to perform its duties. Salaries and	110
expenses incurred by the committee shall be paid from that	111
appropriation upon vouchers approved by the chairperson of the	112
committee.	113
