10 An Act relating to general appropriations for the
11 expenses of various agencies of the executive,
12 legislative and judicial departments of the state;
13 repealing Sections 1 through 170, Chapter 371, O.S.L.
14 2017, which relate to appropriations; making
15 appropriations to the Oklahoma Education Lottery
16 Trust Fund, State Board of Education, the Oklahoma
17 Arts Council, the State Board of Career and
18 Technology Education, the Office of Educational
19 Quality and Accountability, the Oklahoma Educational
20 Television Authority, the Oklahoma State Regents for

stating purposes and restrictions; authorizing
certain expenditures; authorizing certain transfers;
and providing for effect of prior allocations and
expenditures.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. REPEALER Sections 1 through 170, Chapter 371,
O.S.L. 2017, are hereby repealed.

EDUCATION

1 SECTION 2. There is hereby appropriated to the Oklahoma
2 Education Lottery Trust Fund from any monies not otherwise
3 appropriated from the Special Cash Fund of the State Treasury, the
4 sum of _____ Dollars (\$0.00) or so much thereof as may be
5 necessary pursuant to the provisions of subsection E of Section 713
6 of Title 3A of the Oklahoma Statutes.

7 SECTION 3. There is hereby appropriated to the State Board of
8 Education from any monies not otherwise appropriated from the
9 General Revenue Fund of the State Treasury for the fiscal year
10 ending June 30, 2018, the sum of _____ Dollars (\$0.00) or so
11 much thereof as may be necessary for the financial support of public
12 schools.

13 SECTION 4. There is hereby appropriated to the State Board of
14 Education from any monies not otherwise appropriated from the
15 Education Reform Revolving Fund created in Section 34.89 of Title 62
16 of the Oklahoma Statutes, the sum of _____ Dollars (\$0.00) or so
17 much thereof as may be necessary for the financial support of public
18 schools.

19 SECTION 5. The State Board of Education is hereby authorized to
20 expend during the fiscal year ending June 30, 2018, from the Common
21 Education Technology Revolving Fund of the State Treasury, the sum
22 of _____ Dollars (\$0.00) or so much thereof as may be
23 necessary for the financial support of public schools.

1 SECTION 6. There is hereby appropriated to the State Board of
2 Education from any monies not otherwise appropriated from the
3 Mineral Leasing Fund of the State Treasury for the fiscal year
4 ending June 30, 2018, the sum of _____ Dollars (\$0.00) or so
5 much thereof as may be necessary for the financial support of public
6 schools.

7 SECTION 7. There is hereby appropriated to the State Board of
8 Education from any monies not otherwise appropriated from the
9 Mineral Leasing Fund of the State Treasury for the fiscal year
10 ending June 30, 2016, the sum of _____ Dollars (\$0.00) or so
11 much thereof as may be necessary for the financial support of public
12 schools.

13 SECTION 8. There is hereby appropriated to the State Board of
14 Education from any monies not otherwise appropriated from the
15 Oklahoma Education Lottery Trust Fund of the State Treasury for the
16 fiscal year ending June 30, 2018, the sum of _____ Dollars
17 (\$0.00) or so much thereof as may be necessary for the financial
18 support of public schools.

19 SECTION 9. There is hereby appropriated to the State Board of
20 Education from any monies not otherwise appropriated from the
21 Oklahoma Education Lottery Trust Fund of the State Treasury for the
22 fiscal year ending June 30, 2016, the sum of _____ Dollars
23 (\$0.00) or so much thereof as may be necessary for the financial
24 support of public schools.

1 SECTION 10. Notwithstanding any other provision of law, the
2 State Board of Education is hereby authorized to expend during the
3 fiscal year ending June 30, 2018, from the School Consolidation
4 Assistance Fund (260 Fund), the sum of _____ Dollars (\$0.00) or
5 so much thereof as may be necessary for the financial support of
6 public schools.

7 SECTION 11. There is hereby appropriated to the State Board of
8 Education from any monies not otherwise appropriated from the
9 General Revenue Fund of the State Treasury for the fiscal year
10 ending June 30, 2018, the sum of _____ Dollars (\$0.00) or so
11 much thereof as may be necessary for the support of public schools
12 activities.

13 SECTION 12. There is hereby appropriated to the State Board of
14 Education from any monies not otherwise appropriated from the
15 General Revenue Fund of the State Treasury for the fiscal year
16 ending June 30, 2018, the sum of _____ Dollars (\$0.00) or
17 so much thereof as may be necessary for the Certified Employee
18 Health Benefit Allowance.

19 SECTION 13. There is hereby appropriated to the State Board of
20 Education from any monies not otherwise appropriated from the
21 General Revenue Fund of the State Treasury for the fiscal year
22 ending June 30, 2018, the sum of _____ Dollars
23 (\$0.00) so much thereof as may be necessary for the Support
24 Personnel Health Benefit Allowance.

1 SECTION 14. There is hereby appropriated to the State Board of
2 Education from any monies not otherwise appropriated from the
3 General Revenue Fund of the State Treasury for the fiscal year
4 ending June 30, 2018, the sum of _____ Dollars (\$0.00) or
5 so much thereof as may be necessary for administrative and support
6 functions of the State Department of Education.

7 SECTION 15. There is hereby appropriated to the State Board of
8 Education from any monies not otherwise appropriated from the
9 Oklahoma Education Lottery Trust Fund of the State Treasury for the
10 fiscal year ending June 30, 2018, the sum of _____
11 Dollars (\$0.00) or so much thereof as may be necessary for transfer
12 to the School Consolidation Assistance Fund.

13 SECTION 16. There is hereby appropriated to the State Board of
14 Education from any monies not otherwise appropriated from the
15 Oklahoma Education Lottery Trust Fund of the State Treasury for the
16 fiscal year ending June 30, 2016, the sum of _____
17 Dollars (\$0.00) or so much thereof as may be necessary for transfer

19 SECTION 17. There is hereby appropriated to the State Board of

10 _____ Dollars (\$0.00) pursuant to paragraph 2 of subsection C
11 of Section 713 of Title 3A of the Oklahoma Statutes for allocation
12 by the State Board of Career and Technology Education for the
13 education and general operating budgets of the institutions and for
14 other programs, construction, renovations or repairs administered by
15 the State Board of Career and Technology Education.

16 SECTION 23. Notwithstanding any other provision of law, the
17 State Board of Career and Technology Education is hereby authorized
18 to expend during the fiscal year ending June 30, 2018, from the
19 State Board of Career and Technology Education Revolving Fund (200
20 Fund), the sum of _____ Dollars (\$0.00) or so much thereof
21 as may be necessary to perform the duties imposed upon the State
22 Board of Career and Technology Education by law.

23 SECTION 24. There is hereby appropriated to the Office of
24 Educational Quality and Accountability from any monies not otherwise

1 appropriated from the General Revenue Fund of the State Treasury for
2 the fiscal year ending June 30, 2018, the sum of _____
3 Dollars (\$0.00) or so much thereof as may be necessary to perform
4 the duties imposed upon the Office of Educational Quality and
5 Accountability by law.

6 SECTION 25. There is hereby appropriated to the Office of
7 Educational Quality and Accountability from any monies not otherwise
8 appropriated from the Special Cash Fund of the State Treasury the
9 sum of _____ Dollars (\$0.00) or so much thereof as may be
10 necessary to perform the duties imposed upon the Office of

1 pursuant to the provisions of Article XIII-A of the Oklahoma
2 Constitution for the education and general operating budgets of the

4 repairs administered by the Oklahoma State Regents for Higher
5 Education. Of those funds appropriated, the sum of _____
6 Dollars (\$0.00) shall be transferred to the Oklahoma Tuition
7 Equalization Grant Trust Fund to implement the provisions of the
8 Oklahoma Tuition Equalization Grant Act.

9 SECTION 28. The Oklahoma State Regents for Higher Education are
10 hereby authorized to expend during the fiscal year ending June 30,
11 2018, the sum of _____ Dollars (\$0.00) from the Higher
12 Education Capital Revolving Fund of the State Treasury for
13 allocation by the Oklahoma State Regents for Higher Education
14 pursuant to the provisions of Article XIII-A of the Oklahoma
15 Constitution for the education and general operating budgets of the
16 institutions and for other programs, construction, renovations or
17 repairs administered by the Oklahoma State Regents for Higher
18 Education.

19 SECTION 29. The Oklahoma State Regents for Higher Education are
20 hereby authorized to expend during the fiscal year ending June 30,
21 2018, the sum of _____ Dollars (\$0.00) from the Oklahoma
22 Student Aid Revolving Fund of the State Treasury for allocation by
23 the Oklahoma State Regents for Higher Education pursuant to the
24 provisions of Article XIII-A of the Oklahoma Constitution for the

1 education and general operating budgets of the institutions and for
2 other programs, construction, renovations or repairs administered by
3 the Oklahoma State Regents for Higher Education.

4 SECTION 30. There is hereby appropriated to the Oklahoma State
5 Regents for Higher Education from any monies not otherwise
6 appropriated from the General Revenue Fund of the State Treasury for
7 the fiscal year ending June 30, 2018, the sum of _____ Dollars
8 (\$0.00) or so much thereof as may be necessary for expenditures for
9 concurrent enrollment pursuant to Section 628.13 of Title 70 of the
10 Oklahoma Statutes.

11 SECTION 31. There is hereby appropriated to the Oklahoma State
12 Regents for Higher Education from any monies not otherwise
13 appropriated from the Oklahoma Education Lottery Trust Fund of the
14 State Treasury for the fiscal year ending June 30, 2018, the sum of
15 _____ Dollars (\$0.00) pursuant to paragraph 2 of subsection
16 C of Section 713 of Title 3A of the Oklahoma Statutes for allocation
17 by the Oklahoma State Regents for Higher Education pursuant to the

14 deposited in the Seed-Capital Revolving Fund, created pursuant to

23 SECTION 41. There is hereby appropriated to the Office of the
24 Attorney General from any monies not otherwise appropriated from the

1 General Revenue Fund of the State Treasury for the fiscal year
2 ending June 30, 2018, the sum of _____ Dollars (\$0.00) to
3 transfer to the Legal Services Revolving Fund, created pursuant to
4 subsection G of Section 921.1 of Title 12 of the Oklahoma Statutes.

5 SECTION 42. REAPPROPRIATION AND REDESIGNATION The amount
6 of _____ Dollars (\$0.00)) of the original appropriation of
7 _____ Dollars (\$0.00), appropriated to the Office of the
8 Attorney General by Section 154, Chapter 311, O.S.L. 2012, from any
9 monies not otherwise appropriated from the Special Cash Fund of the
10 State Treasury, for the prosecution and defense of claims related to
11 water and water rights in Oklahoma, is hereby reappropriated and
12 redesignated to perform the duties imposed upon the Office of the
13 Attorney General by law. If, on the date this act is approved, any
14 of the amount originally appropriated, as adjusted by expenditures,
15 encumbrances and transfers, results in an unencumbered balance less
16 than the reappropriated and redesignated amount, that reappropriated
17 and redesignated amount is reduced to the unencumbered amount.

18 SECTION 43. For the fiscal year ending June 30, 2018, the

1 SECTION 44. There is hereby appropriated to the Office of the
2 State Auditor and Inspector from any monies not otherwise
3 appropriated from the General Revenue Fund of the State Treasury for
4 the fiscal year ending June 30, 2018, the sum of _____ Dollars
5 (\$0.00) or so much thereof as may be necessary to perform the duties
6 imposed upon the Office of the State Auditor and Inspector by law.

7 SECTION 45. There is hereby appropriated to the Office of the
8 State Auditor and Inspector from any monies not otherwise
9 appropriated from the General Revenue Fund of the State Treasury for
10 the fiscal year ending June 30, 2018, the sum of _____ Dollars
11 (\$0.00) or so much thereof as may be necessary to perform the duties
12 imposed upon the Commission on County Government Personnel Education
13 and Training. The appropriation made in this section shall be
14 expended exclusively for the purpose so stated and shall not be
15 transferable.

22 Inspector by law.

23 SECTION 47. There is hereby appropriated to the State Election
24 Board from any monies not otherwise appropriated from the General

1 Revenue Fund of the State Treasury for the fiscal year ending June
2 30, 2018, the sum of _____ Dollars (\$0.00) or so much thereof
3 as may be necessary to perform the duties imposed upon the State
4 Election Board by law.

5 SECTION 48. There is hereby appropriated to the State Election
6 Board from any monies not otherwise appropriated from the Special
7 Cash Fund of the State Treasury, the sum of _____ Dollars
8 (\$0.00) or so much thereof as may be necessary to perform the duties
9 imposed upon the State Election Board by law.

10 SECTION 49. There is hereby appropriated to the Oklahoma
11 Department of Emergency Management from any monies not otherwise
12 appropriated from the General Revenue Fund of the State Treasury for

2 as may be necessary to perform the duties imposed upon the Office of
3 the Governor by law.
