10	An Act relating to state contracts; providing for certain fee; modifying certain program designation;
11	limiting amount of certain contracts; providing for
12	codification; and declaring an emergency.

14	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
15	SECTION 1. NEW LAW A new section of law to be codified
16	in the Oklahoma Statutes as Section 85.7j of Title 74, unless there
17	is created a duplication in numbering, reads as follows:
18	A. The Office of Management and Enterprise Services shall
19	collect a fee for services provided by the Office under the Roof
20	Asset Management Program, also known as the RAMP program, or a
21	successor program authorized by statute or agency rule, of no more
22	than one percent (1%) of the roofing contract price.
23	B. Beginning January 1, 2018, the Roof Asset Management
24	Program, also known as the RAMP program, or a successor program

authorized by statute or agency rule, shall be known as the Oklahoma
Optional Roofing Program. Whenever the terms "Roof Asset Management
Program" or "RAMP", when used to reference the "Oklahoma Optional
Roofing Program", appear in statute or rule, such terms shall mean
the Oklahoma Optional Roofing Program.

1. Upon the effective date of this act, except for those 6 С. contracts entered into before the effective date of this act, any 7 contract for roofing repairs or replacement entered into on behalf 8 9 of a state agency or political subdivision by the Office of 10 Management and Enterprise Services utilizing an ongoing contracting 11 program through the Oklahoma Optional Roofing Program, or a 12 successor program authorized by statute or agency rule, that does 13 not exceed a total of Fifty Thousand Dollars (\$50,000.00), shall be required to utilize the Oklahoma Optional Roofing Program. 14

2. Upon the effective date of this act, except for those 15 contracts entered into before the effective date of this act, any 16 17 contract for roofing repairs or replacement entered into on behalf of a state agency or political subdivision by the Office of 18 Management and Enterprise Services utilizing an ongoing contracting 19 program through the Oklahoma Optional Roofing Program, or a 20 successor program authorized by statute or agency rule, that exceeds 21 a total of Fifty Thousand Dollars (\$50,000.00), may utilize the 22 Oklahoma Optional Roofing Program, or may adhere to the requirements 23 of the Public Competitive Bidding Act of 1974. 24

1	3. Upon the effective date of this act, except for those
2	contracts entered into before the effective date of this act, the
3	Office of Management and Enterprise Services shall permit no more
4	than two state agency or political subdivisions in the same region
5	of the state to enter into contracts for roofing repairs or
6	replacement through the Oklahoma Optional Roofing Program
7	simultaneously.
8	SECTION 2. It being immediately necessary for the preservation
9	of the public peace, health or safety, an emergency is hereby
10	declared to exist, by reason whereof this act shall take effect and
11	be in full force from and after its passage and approval.
