13	SECTION 1. NEW LAW A new section of law to be codified
14	in the Oklahoma Statutes as Section 1-830.1 of Title 63, unless
15	there is created a duplication in numbering, reads as follows:
16	A. Any residential care home, as defined in paragraph 12 of
17	Section 1-820 of Title 63 of the Oklahoma Statutes, that wishes to
18	challenge a statement of deficiency through either an informal
19	dispute resolution process or an alternative informal dispute
20	resolution process may make a written request to the State
21	Department of Health within thirty (30) calendar days after the
22	receipt of a statement of deficiencies from the Department.
23	B. The informal dispute resolution process for violations of
24	the Residential Care Act or any rule promulgated pursuant thereto

shall follow the process contained in Sections 1-1914.3, 1-1914.4,
 subsections B and C of 1-1914.5 and 1-1914.6 through 1914.10 of
 Title 63 of the Oklahoma Statutes.

C. The alternative informal dispute resolution process for
violations of the Residential Care Act or any rule promulgated
pursuant thereto shall follow the process contained in Sections 11914.11 through 1-1914.16 of Title 63 of the Oklahoma Statutes.
D. An impartial decision-making panel for the alternative

9 informal dispute resolution set forth in subsection C of this 10 section shall be comprised of the following members:

Two members who are representative volunteers who have
 experience in the operation of a residential care home;

One member who is an employee of the Department and has
 experience in the survey process from residential care homes;

15 3. One member who is a representative from the aging and 16 disabled community and who does not represent a state agency; and 17 4. One member who is a lay member and who is not employed by 18 the Department.

SECTION 2. This act shall become effective November 1, 2016.
