7 An Act relating to medical marijuana; amending  
8 Section 2, Chapter 337, O.S.L. 2019 (63 O.S. Supp.  
9 2019, Section 428.1), which relates to the Oklahoma  
10 Medical Marijuana Waste Management Act; and modifying  
11 scope of certain definition.

12 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

13 SECTION 1. AMENDATORY Section 2, Chapter 337, O.S.L.  
14 2019 (63 O.S. Supp. 2019, Section 428.1), is amended to read as  
15 follows:

16 Section 428.1 As used in this act:

17 1. "Authority" shall mean the Oklahoma Medical Marijuana  
18 Authority, or successor agency;

19 2. "Commercial licensee" shall mean any person or entity issued  
20 a license by the Oklahoma Medical Marijuana Authority, or successor  
21 agency, to conduct commercial business in this state;

22 3. "Disposal" shall mean the final disposition of medical  
23 marijuana waste by either a process which renders the waste unusable  
24 through physical destruction or a recycling process;

1 4. "Facility" shall mean a location where the disposal of  
2 medical marijuana waste takes place by a licensee;

3 5. "License" shall mean a medical marijuana waste disposal  
4 license;

5 6. "Licensee" shall mean the holder of a medical marijuana  
6 waste disposal license;

7 7. "Medical marijuana waste" shall mean:

8 a. unused, surplus, returned or out-of-date marijuana and  
9 plant debris of the plant of the genus Cannabis,  
10 including dead plants and all unused plant parts,  
11 except the term shall not include roots, stems, stalks  
12 and fan leaves,

13 b. all product which is deemed to fail laboratory  
14 testing, and

15 c. all product and inventory from commercial licensees,  
16 medical marijuana research facilities and medical  
17 marijuana education facilities that have gone out of  
18 business and are not subject to the provisions of  
19 Section 1560 of Title 12 of the Oklahoma Statutes; and

20 8. "Medical marijuana waste disposal license" shall mean a  
21 license issued by the Oklahoma Medical Marijuana Authority, or  
22 successor agency.
