1 not less than forty (40) years nor more than fifty (50) years in the 2 State Penitentiary and assessed a fine of not less than Two Hundred 3 Fifty Thousand Dollars (\$250,000.00) nor more than Five Hundred 4 Thousand Dollars (\$500,000.00). Any term of imprisonment pursuant 5 to this section shall be served consecutively. No penalty may be 6 assessed against the female upon whom the abortion is performed or 7 induced or attempted to be performed or induced. 8 SECTION 2. AMENDATORY 63 O.S. 2011, Section 1-731, is 9 amended to read as follows: 10 Section 1-731. A. No person shall perform or induce an 11 abortion upon a pregnant woman unless that person is a physician 12 licensed to practice medicine in the State of Oklahoma. Any person 13 violating this section shall be guilty of a felony punishable by 14 imprisonment for not less than one (1) year forty (40) years nor 15 more than three (3) fifty (50) years in the State Penitentiary and 16 assessed a fine of not less than Two Hundred Fifty Thousand Dollars 17 (\$250,000.00) nor more than Five Hundred Thousand Dollars 18 (\$500,000.00). Any term of imprisonment pursuant to this section 19 shall be served consecutively. 20 B. No person shall perform or induce an abortion upon a 21 pregnant woman subsequent to the end of the first trimester of her 22
