6 AS INTRODUCED

7 A Joint Resolution directing the Secretary of State
8 to refer to the people for their approval or
9 rejection a proposed amendment to the Constitution of
10 the State of Oklahoma by adding a new Section 38 to
11 Article II; guaranteeing the right to engage in
12 certain farming and ranching practices; prohibiting
13 Legislature from passing certain laws; providing for
14 interpretation; providing ballot title; and directing
15 filing.

BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES AND THE SENATE OF THE
1ST SESSION OF THE 55TH OKLAHOMA LEGISLATURE:

SECTION 1. The Secretary of State shall refer to the people for
their approval or rejection, as and in the manner provided by law,
the following proposed amendment to the Constitution of the State of
Oklahoma by adding a new Section 38 to Article II thereof, to read
as follows:

Section 38. To protect agriculture as a vital sector of
Oklahoma's economy, which provides food, energy, health benefits,
and security and is the foundation and stabilizing force of
Oklahoma's economy, the rights of farmers and ranchers to engage in

1 farming and ranching practices shall be forever guaranteed in this
2 state. The Legislature shall pass no law which abridges the right
3 of farmers and ranchers to employ agricultural technology and
4 livestock production and ranching practices without a compelling
5 state interest.

6 Nothing in this section shall be construed to modify any
7 provision of common law or statutes relating to trespass, eminent
8 domain, or any other property rights.

9 SECTION 2. The Ballot Title for the proposed Constitutional
10 amendment as set forth in SECTION 1 of this resolution shall be in
11 the following form:

13 Legislative Referendum No. _____ State Question No. _____

14 THE GIST OF THE PROPOSITION IS AS FOLLOWS:

15 This measure adds a new section of law to the State
16 Constitution. It adds Section 38 to Article 2. It protects the
17 rights of farmers and ranchers to engage in farming and ranching
18 practices. It prohibits the Legislature from passing laws that
19 would take away the right to employ agricultural technology and
20 livestock production without a compelling state interest. It
21 provides for interpretation of the section.

1 SECTION 3. The Chief Clerk of the House of Representatives
