10 COMMITTEE SUBSTITUTE

11 An Act relating to appropriations; making an  
12 appropriation to the Oklahoma Indigent Defense  
13 System; stating purpose; providing lapse dates;  
14 requiring and prohibiting certain budget procedures;  
15 and providing a contingent effective date.

16 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

17 SECTION 1. There is hereby appropriated to the Oklahoma  
18 Indigent Defense System from any monies not otherwise appropriated  
19 from the General Revenue Fund of the State Treasury for the fiscal  
20 year ending June 30, 2020, the sum of Two Million Dollars  
21 (\$2,000,000.00) or so much thereof as may be necessary to implement  
22 the provisions of Enrolled Senate Bill No. 252 of the 1st Session of  
23 the 57th Oklahoma Legislature.

1 SECTION 2. Appropriations made by this act, not including  
2 appropriations made for capital outlay purposes, may be budgeted for  
3 the fiscal year ending June 30, 2020 (hereafter FY-20), or may be  
4 budgeted for the fiscal year ending June 30, 2021 (hereafter FY-21).  
5 Funds budgeted for FY-20 may be encumbered only through June 30,  
6 2020, and must be expended by November 15, 2020. Any funds  
7 remaining after November 15, 2020, and not budgeted for FY-21, shall  
8 lapse to the credit of the proper fund for the then current fiscal  
9 year. Funds budgeted for FY-21 may be encumbered only through June  
10 30, 2021. Any funds remaining after November 15, 2021, shall lapse  
11 to the credit of the proper fund for the then current fiscal year.  
12 These appropriations may not be budgeted in both fiscal years  
13 simultaneously. Funds budgeted in FY-20 and not required to pay  
14 obligations for that fiscal year, may be budgeted for FY-21, after  
15 the agency to which the funds have been appropriated has prepared  
16 and submitted a budget work program revision removing these funds  
17 from the FY-20 budget work program and after such revision has been  
18 approved by the Office of Management and Enterprise Services.

19 SECTION 3. The provisions of this act shall not become  
20 effective as law unless Enrolled Senate Bill No. 252 of the 1st  
21 Session of the 57th Oklahoma Legislature becomes effective as law.
