7	An Act relating to agency operations; providing procedures for federal rule and regulation review for
8	state agencies; authorizing the Legislature to disapprove certain rules and regulations; prohibiting
9	certain conduct upon certain disapproval; stating when certain rules and regulations are operative;
10	providing for certain exemption from liability; clarifying application to certain rights, privileges
11	or interests gained by certain persons; providing for codification; and providing an effective date.

14	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
15	SECTION 1. NEW LAW A new section of law to be codified
16	in the Oklahoma Statutes as Section 308b of Title 75, unless there
17	is created a duplication in numbering, reads as follows:
18	A. Upon receipt by a state agency of a requirement for an
19	agency to adopt, follow or otherwise submit to any new federal rule
20	or regulation or change to an existing federal rule or regulation,
21	or interpretation of any rule or regulation, that agency shall send
22	the federal rule or regulation by electronic mail to the President
23	Pro Tempore of the Senate, the Speaker of the House of
24	Representatives and the Governor.

B. By the adoption of a joint resolution, the Legislature may
 disapprove any federal rule or regulation imposed on a state agency.

C. Unless otherwise authorized by the Legislature, whenever a 3 rule or regulation is disapproved as provided in subsection B of 4 5 this section, the agency subject to such rules or regulations shall not have authority to follow, interpret or abide by any requirements 6 of the rule or regulation as specified by the Legislature. 7 Any effective rule or regulation which would have been imposed on an 8 9 agency when the Legislature was not in session shall be deemed null 10 and void on the date the Legislature disapproves the rule or 11 regulation by a resolution provided in subsection B of this section. 12 Federal rules and regulations imposed on state agencies may be disapproved in part or in whole by the Legislature. Upon enactment 13 of any joint resolution disapproving a rule or regulation, the 14 agency shall file notice of such legislative disapproval with the 15 Oklahoma Attorney General. 16

D. A federal rule or regulation shall be deemed authorized for
state agency compliance, if disapproved by a joint resolution
pursuant to subsection B of this section which has been vetoed by
the Governor in accordance with Section 11 of Article VI of the
Oklahoma Constitution and the veto has not been overridden.

E. State agencies and their employees complying with the provisions of this act shall be exempt from liability pursuant to Section 155 of Title 51 of the Oklahoma Statutes.

1	F. Any rights, privileges or interests gained by any person by
2	operation of a federal rule or regulation applied prior the adoption
3	of a joint resolution pursuant to this section, shall not be
4	affected by reason of any subsequent disapproval or rejection of
5	such rule or regulation by either house of the Legislature.
6	SECTION 2. This act shall become effective November 1, 2016.
