10 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

11 SECTION 1. AMENDATORY 59 O.S. 2021, Section 199.2, is  
12 amended to read as follows:

13 Section 199.2. A. 1. There is hereby re-created, to continue  
14 until ~~July 1, 2024~~ July 1, 2027, in accordance with the provisions  
15 of the Oklahoma Sunset Law, a State Board of Cosmetology and  
16 Barbering which shall be composed of eleven (11) members to be  
17 appointed by the Governor and to serve at the pleasure of the  
18 Governor.

19 2. One member shall be appointed from each congressional  
20 district and the additional members shall be appointed ~~at-large~~ at  
21 large. However, when congressional districts are redrawn, each  
22 member appointed prior to July 1 of the year in which such  
23 modification becomes effective shall complete the current term of  
24 office and appointments made after July 1 of the year in which such

1 modification becomes effective shall be based on the redrawn  
2 districts. Appointments made after July 1 of the year in which such  
3 modification becomes effective shall be from any redrawn districts  
4 which are not represented by a board member until such time as each  
5 of the modified congressional districts are represented by a board  
6 member. One member shall be a barber appointed ~~at-large~~ at large.

7 3. At the time of appointment, the members shall be citizens of  
8 this state, at least twenty-five (25) years of age, and shall be  
9 high school graduates. Six members shall, at the time of  
10 appointment, have had at least five (5) years' continuous practical  
11 experience in the practice of cosmetology in this state; one member  
12 shall be appointed at large and, at the time of the appointment,  
13 have had at least five (5) years' continuous practical experience in  
14 the practice of barbering in this state; one member shall be a lay  
15 person; one member shall be an administrator of a licensed private  
16 cosmetology school; one member shall be an administrator of a  
17 licensed barber school; and one member shall be an administrator of  
18 a public school licensed to teach cosmetology or barbering.

19 4. No two members shall be graduates of the same cosmetology  
20 school, nor shall they be organizers of or promote the organization  
21 of any cosmetic, beauty, or hairdressers' association. Each of the  
22 eight cosmetology appointees shall continue to be actively engaged  
23 in the profession of cosmetology while serving. No two members  
24 engaged in the profession of barbering shall be organizers of or

1 promote the organization of any barbering association. Each of the  
2 two barbering appointees shall continue to be actively engaged in  
3 the profession of barbering while serving.

4 5. If any member retires or ceases to practice his or her  
5 profession during the term of membership on the Board, such terms  
6 shall automatically cease and the Governor shall appoint a like-  
7 qualified person to fulfill the remainder of the term.

8 B. The terms of office for Board members shall be four (4)  
9 years ending June 30.

10 C. Each member shall serve until a successor is appointed and  
11 qualified.

12 D. Six members of the Board shall constitute a quorum for the  
13 transaction of business.

14 E. The Governor may remove any member of the Board at any time  
15 at the Governor's discretion. Vacancies shall be filled by  
16 appointment by the Governor for the unexpired portion of the term.

17 F. The Board shall organize by electing from its membership a  
18 chair and vice-chair, each to serve for a period of one (1) year.  
19 The presiding officer shall not be entitled to vote upon any  
20 question except in the case of a tie vote.

21 Members shall be reimbursed for their actual and necessary  
22 traveling expenses as provided by the State Travel Reimbursement  
23 Act.

1 G. Within thirty (30) days after the end of each fiscal year,  
2 the Board shall make a full report to the Governor of all its  
3 receipts and expenditures, and also a full statement of its work  
4 during the year, together with such recommendations as the Board  
5 deems expedient.

6 H. The Board may expend funds for suitable office space for the  
7 transaction of its business. The Board shall adopt a common seal  
8 for the use of the executive director in authenticating Board  
9 documents.

10 I. The Board shall meet at its office for the transaction of  
11 such business as may come before it on the second Monday in January,  
12 March, May, July, September, and November and at such other times as  
13 it may deem advisable.

14 SECTION 2. This act shall become effective July 1, 2024.

15 SECTION 3. It being immediately necessary for the preservation  
16 of the public peace, health or safety, an emergency is hereby  
17 declared to exist, by reason whereof this act shall take effect and  
18 be in full force from and after its passage and approval.
