21 BE IT B	ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
22 SEC	CTION 1. NEW LAW A new section of law to be codified
23 in the	Oklahoma Statutes as Section 1731.2 of Title 21, unless there
24 is crea	ated a duplication in numbering, reads as follows:

A. Actions relating to theft, retail theft, or larceny shall
 constitute organized retail crime when two or more of the following
 circumstances occur:

The property taken is intended for resale;
 Such property is taken by two or more persons acting
 jointly;

3. The persons taking the property do so while possessing tools
of theft including, but not limited to, tag cutters, foil-lined
bags, weapons, or other means of evading detection;

The persons taking the property attempt to exit through fire
 escapes, employee exits, or other non-public means of entry or exit;
 The persons taking such property have a means of getaway to

13 evade capture or arrest;

14 6. The persons taking such property remove, destroy,
15 deactivate, or knowingly evade any component of an anti-shoplifting
16 or inventory control device to prevent the activation of that device
17 or to facilitate another person in committing retail crime;

18 7. A person receives, purchases, or possesses retail 19 merchandise for sale or resale knowing or believing the retail 20 merchandise was stolen from a retail merchant;

8. The persons use any container, device, or other article tofacilitate a retail crime;

9. The persons use the motor vehicle of another person or arented or stolen motor vehicle when committing retail crime; or

1 10. The persons use a paper, fraudulent, altered, or obstructed 2 license plate, use a license plate meant for a different vehicle, or 3 do not have any license plate as a means of evading detection.

Violations of this section shall be punished as follows: 4 Β. 5 1. In the event the value of the property is less than Fifteen Thousand Dollars (\$15,000.00), the person shall be punished by 6 imprisonment in the custody of the Department of Corrections for a 7 term not to exceed five (5) years or in the county jail for a term 8 9 not to exceed one (1) year, or by a fine not to exceed One Thousand Dollars (\$1,000.00), or by both such imprisonment and fine; or 10

2. If the value of the property is Fifteen Thousand Dollars
(\$15,000.00) or more, the person shall be punished by imprisonment
in the custody of the Department of Corrections for a term not to
exceed eight (8) years, or by a fine not to exceed One Thousand
Dollars (\$1,000.00), or by both such imprisonment and fine.

16 C. The person shall also be ordered to pay restitution to the 17 victim as provided in Section 991f of Title 22 of the Oklahoma 18 Statutes.

19 SECTION 2. AMENDATORY 21 O.S. 2021, Section 1731, as 20 amended by Section 15, Chapter 116, O.S.L. 2018 and Section 9, State 21 Question No. 780, Initiative Petition No. 404, is amended to read as 22 follows:

23 Section 1731. A. Larceny of merchandise held for sale in 24 retail or wholesale establishments shall be punishable as follows:

1 1. For the first or second conviction, in the event the value 2 of the goods, edible meat, or other corporeal property which has been taken is less than One Thousand Dollars (\$1,000.00) Five 3 Hundred Dollars (\$500.00), the person shall be guilty of a 4 5 misdemeanor punishable by imprisonment in the county jail for a term not exceeding thirty (30) days, and by a fine not less than Ten 6 Dollars (\$10.00) nor more than Five Hundred Dollars (\$500.00); 7 provided, for the first or second conviction, in the event more than 8 9 one item of goods, edible meat, or other corporeal property has been taken, punishment shall be by imprisonment in the county jail for a 10 term not to exceed thirty (30) days, and by a fine not less than 11 Fifty Dollars (\$50.00) nor more than Five Hundred Dollars (\$500.00); 12 2. For a third or subsequent conviction, in the event the value 13 of the goods, edible meat, or other corporeal property which has 14 been taken is less than One Thousand Dollars (\$1,000.00) Five 15 Hundred Dollars (\$500.00), the person shall be guilty of a 16 misdemeanor and shall be punished by imprisonment in the county jail 17 for a term not to exceed one (1) year, and by a fine not exceeding 18 One Thousand Dollars (\$1,000.00); 19 3. In the event the value of the goods, edible meat, or other 20 corporeal property is One Thousand Dollars (\$1,000.00) Five Hundred 21

1 of Corrections for a term not to exceed two (2) years, and by a fine 2 not to exceed One Thousand Dollars (\$1,000.00);

4. In the event the value of the goods, edible meat, or other
corporeal property is Two Thousand Five Hundred Dollars (\$2,500.00)
or more but less than Fifteen Thousand Dollars (\$15,000.00), the
person shall be guilty of a felony and shall be punished by
imprisonment in the custody of the Department of Corrections for a
term not to exceed five (5) years, and by a fine not to exceed One
Thousand Dollars (\$1,000.00); or

10 5. In the event the value of the goods, edible meat, or other 11 corporeal property is Fifteen Thousand Dollars (\$15,000.00) or more, 12 the person shall be guilty of a felony and shall be punished by 13 imprisonment in the custody of the Department of Corrections for a 14 term not to exceed eight (8) years, and by a fine not to exceed One 15 Thousand Dollars (\$1,000.00).

B. When three or more separate offenses under this section are committed within a <u>ninety-day</u> <u>one-year</u> period, the value of the goods, edible meat, or other corporeal property involved in each larceny offense may be aggregated to determine the total value for purposes of determining the appropriate punishment under this section.

C. In the event any person engages in conduct that is a violation of this section in concert with at least one other individual, such person shall be liable for the aggregate value of

all items taken by all individuals. Such person may also be subject
 to the penalties set forth in Section 421 of this title, which shall
 be in addition to any other penalties provided for by law.

D. Any person convicted pursuant to the provisions of this
section shall also be ordered to pay restitution to the victim as
provided in Section 991f of Title 22 of the Oklahoma Statutes.

7 SECTION 3. AMENDATORY 21 O.S. 2021, Section 425, is
8 amended to read as follows:

9 Section 425. A. Any person who engages in a pattern of criminal offenses in two or more counties or municipalities in this 10 state or who attempts or conspires with others to engage in a 11 12 pattern of criminal offenses shall, upon conviction, be punishable punished by imprisonment in the Department of Corrections for a term 13 not exceeding two (2) years, or imprisonment in the county jail for 14 a term not exceeding one (1) year, or by a fine in an amount not 15 more than Twenty-five Thousand Dollars (\$25,000.00), or by both such 16 fine and imprisonment. Such punishment shall be in addition to any 17 penalty imposed for any offense involved in the pattern of criminal 18 offenses. Double jeopardy shall attach upon conviction. 19

20 B. For purposes of this act, "pattern of criminal offenses" 21 means:

Two or more criminal offenses are committed that are part of
 the same plan, scheme, or adventure; or

2. A sequence of two or more of the same criminal offenses are
 committed and are not separated by an interval of more than thirty
 (30) days between the first and second offense, the second and
 third, and so on; or

5 3. Two or more criminal offenses are committed, each proceeding 6 from or having as an antecedent element a single prior incident or 7 pattern of fraud, robbery, burglary, theft, identity theft, receipt 8 of stolen property, false personation, false pretenses, obtaining 9 property by trick or deception, taking a credit or debit card 10 without consent, or the making, transferring or receiving of a false 11 or fraudulent identification card.

12 C. Jurisdiction and venue for a pattern of criminal offenses 13 occurring in multiple counties in this state shall be determined as 14 provided in Section 1 of this act.

15 SECTION 4. AMENDATORY 21 O.S. 2021, Section 792, is 16 amended to read as follows:

17 Section 792. To constitute robbery, the force or fear must be 18 employed either to obtain or retain possession of the property, or 19 to prevent or overcome resistance to the taking. If employed merely 20 as a means of escape, it does not constitute robbery.

21 SECTION 5. AMENDATORY Section 1, Chapter 333, O.S.L. 22 2023 (21 O.S. Supp. 2023, Section 2200), is amended to read as 23 follows:

1 Section 2200. A. There is hereby created the Oklahoma Organized Retail Crime Task Force until December 31, 2024. 2 The purpose of the task force shall be to provide the Legislature and 3 the Governor with information on organized retail crime and the 4 5 advantages and drawbacks of instituting various countermeasures to counter losses from retail theft in the state. 6 The task force shall consist of fifteen (15) members as 7 в. follows: 8 9 1. Three members, appointed by the Governor, one of whom shall be an individual who represents state or local law enforcement; 10 2. Two members appointed by the President Pro Tempore of the 11 12 Oklahoma State Senate; 3. Two members appointed by the Speaker of the Oklahoma House 13 of Representatives; 14 4. One member appointed by the District Attorneys Council; 15 5. One member appointed by the Oklahoma Retail Merchants 16 Association; 17 6. One member appointed by the State Chamber; 18 7. One member appointed by the Oklahoma Sheriffs' Association; 19 8. One member appointed by the Oklahoma Association of Chiefs 20

9. One member appointed by the Attorney General;
10. One member from the Convenience Distributors of Oklahoma;

1 11. One member from the Oklahoma Grocers Association. Ouorum for official business of the task force shall be 2 С. eight members. A chairperson and a vice chairperson shall be 3 elected by a majority vote of the members of the task force. 4 5 D. Appointments to the task force shall be made by the appointing authority no later than sixty (60) days after the 6 effective date of this act. Appointed members shall, to the 7 greatest extent practicable, have by education or experience, 8 9 knowledge of organized retail theft. The chair shall hold the first meeting of the task force no later than ninety (90) days after the 10 effective date of this act. Any vacancies in the membership of the 11 task force shall be filled in the same manner provided for in the 12 13 initial appointment.

E. The members of the task force shall receive no compensation but shall receive travel reimbursement for necessary travel expenses incurred in the performance of their duties in accordance with the State Travel Reimbursement Act. The task force shall be staffed by the Senate.

F. The task force may consult with any organization, government entity, or person in the development of its report required pursuant to the provisions of subsection G of this section.

G. On or before December 15, 2024, the task force shall electronically submit to the Governor, the President Pro Tempore of the Oklahoma State Senate, the Oklahoma Speaker of the House of

Representatives, and the chairs of the House and Senate committees
 that oversee public safety, a report containing, but not limited to,
 the following information based on available data:

A review of laws and regulations on organized retail crime
 used by other states, the federal government, and foreign countries
 to regulate the marketplace;

7 2. The use of organized retail theft's impact on state and8 local tax receipts;

9 3. The need for interagency coordination of public education10 and outreach and prevention programs for business owners; and

Legislative and regulatory recommendations, if any, to
 increase transparency and security, enhance consumer protections,
 prevent organized retail theft, and to address the long-term
 economic impact related to the prevalence of organized retail crime.

H. The Office of the Attorney General may employ, either
directly or through memorandums of understanding or crossdeputization agreements, persons to serve as Oklahoma Organized
Retail Crime Task Force officers whose primary responsibility shall
be to prevent, respond to, investigate, and prosecute criminal
violations related to organized retail crime.

21 SECTION 6. This act shall become effective November 1, 2024.
