6 AS INTRODUCED

7 An Act relating to school districts; directing an
8 elementary school district to make certain payment to
9 an independent school district to which a student
10 transfers to attend a grade he or she is entitled to
11 attend; providing for calculation of payment;
12 directing the State Department of Education to
13 provide certain assistance; directing that certain
14 payment be included in certain State Aid calculation;
15 providing for promulgation of rules; providing for
16 codification; providing an effective date; and
17 declaring an emergency.

20 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

21 SECTION 1. NEW LAW A new section of law to be codified
22 in the Oklahoma Statutes as Section 5-103.2 of Title 70, unless
23 there is created a duplication in numbering, reads as follows:

24 A. For each student who transfers from an elementary school
district, which is the resident district of the student, to an
independent district to attend a grade the student is entitled to
pursue pursuant to Section 8-101 of Title 70 of the Oklahoma
Statues, the elementary school district shall provide to the
independent school district a proportional amount of monies derived

1 from the proceeds of the school levies made pursuant to the
2 provisions of:

3 1. Subsection (a) of Section 9 of Article X of the Oklahoma
4 Constitution;

5 2. Subsection (b) of Section 9 of Article X of the Oklahoma
6 Constitution;

7 3. Subsection (c) of Section 9 of Article X of the Oklahoma
8 Constitution;

9 4. Subsection (d) of Section 9 of Article X of the Oklahoma
10 Constitution; and

11 5. Subsection (d-1) of Section 9 of Article X of the Oklahoma
12 Constitution.

13 B. The State Department of Education shall provide assistance
14 to elementary school districts in calculating the amounts described
15 in subsection A of this section and a schedule of payments.

16 C. Payments made to an independent school district pursuant to
17 subsection A of this section shall be included in the calculation of
18 State Aid pursuant to Section 18-200.1 of Title 70 of the Oklahoma
19 Statutes.

20 D. The State Board of Education shall promulgate rules
21 necessary to implement the provisions of this act.

22 SECTION 2. This act shall become effective July 1, 2019.

23 SECTION 3. It being immediately necessary for the preservation
24 of the public peace, health or safety, an emergency is hereby
25

1 declared to exist, by reason whereof this act shall take effect and
2 be in full force from and after its passage and approval.
