15	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
16	SECTION 1. There is hereby appropriated to the Oklahoma State
17	Regents for Higher Education from any monies not otherwise
18	appropriated from the General Revenue Fund of the State Treasury for
19	the fiscal year ending June 30, 2017, the sum of One Hundred
20	Thousand Dollars (\$100,000.00) or so much thereof as may be
21	necessary to perform the duties imposed upon the Oklahoma State
22	Regents for Higher Education by law.
23	SECTION 2. Appropriations made by this act, not including
24	appropriations made for capital outlay purposes, may be budgeted for

    budgeted for the fiscal year ending June 30, 2018 (hereafter FY-18).

    Funds budgeted for FY-17 may be encumbered only through June 30,

    remaining after November 15, 2017, and not budgeted for FY-18, shall
    lapse to the credit of the proper fund for the then current fiscal

    year. Funds budgeted for FY-18 may be encumbered only through June
