AMENDATORY 47 O.S. 2021, Section 584, as last amended by Section 4, Chapter 192, O.S.L. 2022 (47 O.S. Supp. 2022, 13 Section 584), is amended to read as follows: 14 Section 584. A. The Oklahoma Used Motor Vehicle and Parts 15 Commission may deny an application for a license, impose a fine not 16 17 to exceed One Thousand Dollars (\$1,000.00) per occurrence and/or revoke or suspend a license after it has been granted, when any 18 provision of Sections 581 through 588 of this title is violated or 19 for any of the following reasons: 20 1. On satisfactory proof of unfitness of the applicant or the 21 licensee, as the case may be, under the standards established by 22 Sections 581 through 588 of this title; 23 24

2. For fraud practices or any material misstatement made by an
 applicant in any application for license under the provisions of
 Sections 581 through 588 of this title;

3. For any willful failure to comply with any provision of
Section 581 et seq. of this title or with any rule promulgated by
the Commission under authority vested in it by Sections 581 through
588 of this title;

8 4. Change of condition after license is granted resulting in9 failure to maintain the qualifications for license;

10 5. Continued or flagrant violation of any of the rules of the 11 Commission;

12 6. Being a used motor vehicle dealer, a used motor vehicle salesperson, a wholesale used motor vehicle dealer, or a 13 manufactured home dealer, a restricted manufactured home park 14 dealer, a manufactured home installer, a manufactured home 15 salesperson or a manufactured home manufacturer who: 16 resorts to or uses any false or misleading advertising 17 a. in connection with business as a used motor vehicle 18 dealer, wholesale used motor vehicle dealer or a 19 restricted manufactured home park dealer or 20 manufactured home dealer, installer or manufacturer, 21 has committed any unlawful act which resulted in the b. 22 revocation of any similar license in another state, 23

B. 1. The Commission shall deny an application for a license,
or revoke or suspend a license after it has been granted, if a
manufactured home dealer does not meet the following guidelines and
restrictions:

a. a display area for manufactured homes which is easily
accessible, with sufficient parking for the public,
b. an office for conducting business where the books,
records, and files are kept, with access to a restroom

- c. a place of business which meets all zoning, occupancy
 and other requirements of the appropriate local
 government and regular occupancy by a person, firm, or
 corporation engaged in the business of selling
 manufactured homes, and
- 18 d. a place of business which is separate and apart from
 19 any other dealer's location.

2. The Commission shall deny an application for a restricted
 manufactured home park dealer license, or revoke or suspend a
 license after it has been granted, if a manufactured home park
 dealer does not satisfy the following guidelines and restrictions:

- a. only mobile or manufactured homes that are "ready for
 occupancy" are sold or offered for sale,
- b. maintains an office for conducting business where the
 books, records, and files are kept, with access to a
 restroom for the public,
- c. maintains a place of business which meets all zoning,
 occupancy and other requirements of the appropriate
 local government and regular occupancy by a person,
 firm or corporation engaged in the business of selling
 manufactured homes inside a park, and
- d. maintains a place of business which is separate and
 apart from any other dealer's location.
- C. The Commission shall deny an application for a license, or revoke or suspend a license after it has been granted, if a manufactured home installer:
- 16 1. Installs or attempts to install a manufactured home in a 17 manner that is not in compliance with installation standards as set 18 by the Commission pursuant to rule; or
- Violates or fails to comply with any applicable rule as
 promulgated by the Commission concerning manufactured home
 installers.
- D. The Commission shall deny an application for a license, or revoke or suspend a license after it has been granted, if a manufactured home manufacturer violates or fails to comply with any

applicable rule as promulgated by the Commission concerning
 manufactured home manufacturers.

The Commission shall deny an application for a license by a 3 Ε. motor vehicle manufacturer or factory if the application is for the 4 5 purpose of selling used motor vehicles to any retail consumer in the state, other than through its retail franchised dealers, or acting 6 as a broker between a seller and a retail buyer. This subsection 7 does not prohibit a manufacturer from selling used motor vehicles 8 9 where the retail customer is a nonprofit organization or a federal, 10 state, or local government or agency. This subsection does not prohibit a manufacturer from providing information to a consumer for 11 the purpose of marketing or facilitating the sale of used motor 12 13 vehicles or from establishing a program to sell or offer to sell used motor vehicles through the manufacturer's retail franchised 14 dealers as provided for in Sections 561 through 580.2 of this title. 15 This subsection shall not prevent a factory from obtaining a 16 17 wholesale used motor vehicle dealer's license or the factory's financing subsidiary from obtaining a wholesale used motor vehicle 18 dealer's license. 19

F. If the Commission denies issuance of a license the Commission shall provide the grounds for the action to the applicant in writing and allow the applicant sixty (60) days to resolve any issues that are the grounds for the action.

G. Each of the aforementioned grounds for suspension,
 revocation, or denial of issuance or renewal of license shall also
 constitute a violation of Sections 581 through 588 of this title,
 unless the person involved has been tried and acquitted of the
 offense constituting such grounds.

6 The suspension, revocation or refusal to issue or renew a 7 license or the imposition of any other penalty by the Commission 8 shall be in addition to any penalty which might be imposed upon any 9 licensee upon a conviction at law for any violation of Sections 581 10 through 588 of this title.

H. This section shall not be construed to prohibit a used motor vehicle dealer from delivering a motor vehicle off site or from selling a motor vehicle to a customer at the home or place of business of the customer.

H. I. As used in this section:

1. "Substantially relates" means the nature of criminal conduct
 for which the person was convicted has a direct bearing on the
 fitness or ability to perform one or more of the duties or
 responsibilities necessarily related to the occupation; and

20 2. "Poses a reasonable threat" means the nature of criminal 21 conduct for which the person was convicted involved an act or threat 22 of harm against another and has a bearing on the fitness or ability 23 to serve the public or work with others in the occupation.

24 SECTION 2. This act shall become effective November 1, 2023.
