BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 73 O.S. 2011, Section 15, as amended by Section 658, Chapter 304, O.S.L. 2012 (73 O.S. Supp. 2016, Section 15), is amended to read as follows:

Section 15. Except as otherwise provided by law, the custody, supervision, and control of all work or material required in and about the Capitol building and the grounds and appurtenances thereof shall be exercised by the Office of Management and Enterprise Services which shall make all requisitions for supplies, repairs, or material required in the heating, lighting, plumbing, ventilation, and operation of the Capitol building and grounds. <u>All activities related to restoration, preservation, enhancement or modification of the Capitol building or grounds, as defined in Section 4101 of Title 74 of the Oklahoma Statutes, shall be approved by the State Capitol Preservation Commission before commencement of such activity.</u>

 Statutes, is exempt from such approval requirement.

SECTION 2. 73 O.S. 2011, Section 15.1, as 3 AMENDATORY last amended by Section 1, Chapter 335, O.S.L. 2016 (73 O.S. Supp. 4 5 2016, Section 15.1), is amended to read as follows: Section 15.1. A. The Legislature shall have management and 6 control of the following space in the State Capitol Building: 7 1. The space on the third, fourth, fifth and sixth floors; 8 9 2. Approximately one thousand five hundred eighty-five (1,585) 10 square feet of space on the north side of the west wing of the basement; 11 12 3. Approximately four thousand four hundred forty-six (4,446) square feet of space on the north side of the east wing of the 13 basement; 14 4. Approximately four thousand seven hundred (4,700) square 15 feet of space on the south side of the west wing of the basement; 16 5. Approximately two thousand sixty-nine (2,069) square feet of 17 space on the east side of the north wing of the first floor; 18 6. Approximately fifteen thousand two hundred twenty (15,220) 19 square feet of space on the north and south sides of the west wing 20

21 of the first floor;

7. Approximately one hundred (100) square feet of space between the restrooms and the northwest stairwells and approximately one hundred (100) square feet of space between the restrooms and the

1 northeast stairwells on the second, third, fourth and fifth floors; 2 and

8. All space in the west wing of the second floor and all space
in the north wing of the second floor that was occupied by the
appellate courts prior to relocation to the Wiley Post Historical
Building; provided, the Supreme Court shall continue to have
exclusive management and control of the Supreme Court courtroom and
designated robing room located in the west wing of the second floor.

9 B. The space under the management and control of the
10 Legislature pursuant to the provisions of this section shall be
11 allotted as follows:

12 1. Except as otherwise provided in this subsection, all space 13 on the east side of the center of the State Capitol Building shall 14 be occupied by the Senate and all space on the west side of the 15 center of the State Capitol Building shall be occupied by the House 16 of Representatives;

The space specified in paragraph 5 of subsection A of this
 section shall be occupied by the Legislative Service Bureau; and

All space in the north wings of the second, third and fifth
 floors, other than the space specified in paragraph 7 of subsection
 A of this section, shall be occupied by the Senate.

C. The Office of Management and Enterprise Services shall
establish an enclosed vending area within the utility shafts
accessible on the fourth floor of the State Capitol Building.

D. The authority of the Legislature to allot space may be
delegated to the President Pro Tempore of the Senate and the Speaker
of the House of Representatives. Any allotment other than as
provided in this section shall be executed pursuant to a written
agreement signed by the President Pro Tempore of the Senate and the
Speaker of the House of Representatives.

Ε. Each House of the State Legislature shall have the exclusive 7 charge of the purchase, use, allotment and disposition of its 8 9 respective chambers, committee rooms, fixtures, furniture, supplies 10 and apparatus, and shall be responsible for the use and preservation 11 of same. All activities related to restoration, preservation, 12 enhancement or modification of the Capitol building or grounds, as 13 defined in Section 4101 of Title 74 of the Oklahoma Statutes, in space designated to the Senate and House of Representatives, shall 14 15 be approved by the State Capitol Preservation Commission before 16 commencement of such activity. Maintenance, as defined in Section 17 4101 of Title 74 of the Oklahoma Statutes, is exempt from such 18 approval requirement.

F. The provisions of this section shall not prohibit the Legislature from allowing agencies of the executive or judicial departments to use space within the State Capitol Building that is under its management and control pursuant to a written agreement signed by the President Pro Tempore of the Senate and the Speaker of the House of Representatives.

1 G. The Office of Management and Enterprise Services shall cause 2 to be created a comprehensive set of architectural drawings 3 reflecting the physical layout of the Capitol spaces allocated to the Legislature pursuant to this section. The President Pro Tempore 4 5 of the Senate and the Speaker of the House of Representatives shall review and certify the architectural drawings created pursuant to 6 this subsection. The certification required by this subsection 7 shall be accomplished by the signature of each such officer upon the 8 9 face of the drawings. Upon certification, such architectural 10 drawings shall become the official record of the spaces allocated to 11 the Legislature within the State Capitol Building. The Secretary of 12 State shall attest the signatures required by this subsection and the signed and attested architectural drawings shall be deposited 13 with the State Archivist, as defined in Section 204 of Title 67 of 14 15 the Oklahoma Statutes. The State Archivist shall hold the signed and attested architectural drawings as an official record of the 16 17 State of Oklahoma. The Office of Management and Enterprise Services shall provide two copies of the signed and attested architectural 18 drawings to the Secretary of the Senate and two copies to the Clerk 19 of the House of Representatives. 20

creative imagination;

8 <u>3. "Maintenance" means keeping spaces, structures and</u>
9 <u>infrastructure in proper operating condition in a routine, scheduled</u>
10 <u>or anticipated fashion to prevent failure and/or degradation.</u>
11 <u>"Maintenance" restores an existing aspect of the State Capitol or</u>
12 grounds to its original working or aesthetic condition;

4. "Restoration" means the act or process of accurately 13 depicting the form, features and character of the State Capitol as 14 it appeared in 1917 (building) and 2002 (dome) by means of the 15 removal of features from later periods in its history and 16 17 reconstruction of missing features from the restoration period. The limited and sensitive upgrading of mechanical, electrical and 18 plumbing systems and other code-required work to make properties 19 functional is appropriate within a restoration project; 20 5. "Preservation" means the act or process of applying measures 21 necessary to sustain the existing form, integrity and materials of 22 an historic property. Work, including preliminary measures to 23

protect and stabilize the property, generally focuses upon the

2	rather than extensive replacement and new construction;
3	6. "Enhancement" means an increase or improvement upon the
4	quality, value or extent of the original design intent of the State
5	Capitol, Governor's Mansion or the respective grounds;
6	7. "Modification" means any change to an existing physical
7	attribute of the State Capitol, Governor's Mansion or the respective
8	grounds; and
9	8. "Grounds" means all land surrounding the State Capitol and
10	bordered by Lincoln Boulevard and the land contained within the
11	fence line surrounding the Governor's Mansion.
12	SECTION 4. AMENDATORY 74 O.S. 2011, Section 4102, as
13	last amended by Section 1, Chapter 237, O.S.L. 2015 (74 O.S. Supp.

18	Commission shall not be compensated except for reimbursement as

Activities related to the Capitol 20 Restoration Project, as outlined in Sections 345 and 346 of Title 73 21 of the Oklahoma Statutes are exempt from approval of the Commission; 22 23 2. 3 2. 3. Establish standards for the acquisition and display of

6 related to the history and culture of the State of Oklahoma;

3. <u>4.</u> Establish procedures by which private contributions of
suitable art can be accepted for the Capitol and the Governor's
Mansion. The Commission is authorized to accept and make proper
disposition of works of art as may be donated to the Commission and
this state;

4. Have authority to approve and submit to the Long-Range
Capital Planning Commission any proposed modification, alteration,
renovation, repair, or construction on any part of the Capitol and
the Governor's Mansion; and

16 5. Have final approval authority for any plans or programs for
17 the restoration, preservation, or display of fine art programs in
18 and surrounding the Capitol and, the Governor's Mansion and the
19 respective grounds.

B. The Long-Range Capital Planning Commission shall submit any
capital construction or renovation project with respect to the State
Capitol or the Governor's Mansion to the State Capitol Preservation
Commission for its advisory opinion prior to consideration by the
Long-Range Capital Planning Commission.

The Director of the Office of Management and Enterprise Services may contract for the services of a Capitol Architect and Curator or employ such an individual on either a full- or part-time basis. Compensation for the position will be in accord with similar professional positions in state government.

8 SECTION 8. AMENDATORY 74 O.S. 2011, Section 4106, as 9 amended by Section 16, Chapter 209, O.S.L. 2013 (74 O.S. Supp. 2016, 10 Section 4106), is amended to read as follows:

Section 4106. The State Capitol Preservation Commission and the Long-Range Capital Planning Commission are is directed to maintain close coordination with the executive, legislative and judicial branches of government to ensure that the needs of each branch of government are considered in all planned development and modifications of the Capitol and the Governor's Mansion.

17 SECTION 9. AMENDATORY 74 O.S. 2011, Section 4108, is 18 amended to read as follows:

Section 4108. The provisions of Sections 4101 through 4107 of this title shall apply to all modifications in the structure or decor of the Capitol and the Governor's Mansion except for those immediate emergency <u>maintenance</u> repairs needed to prevent loss or damage to property or to protect the public during use of the building.
