6 WHEREAS, State Question No. 632, adopted September 18, 1990, and 7 effective January 1, 1991, limits the length of service for a member 8 of the Legislature to a total of twelve years and as a result, 9 Senator Jolley will not be eligible to stand for reelection this 10 year; and

11 WHEREAS, Clark Jolley's boisterous demeanor, middle of the night 12 emails and gavel-pounding presence in the Senate Chamber and committee meetings will not soon be forgotten by those with whom he 13 served.
