SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act makes changes to laws about prescription drugs and some health care providers. The Act says the Oregon State Hospital does not have to do certain things about staffing. The Act changes the term "physician assistant" to "physician associate." (Flesch Readability Score: 62.1).

[Digest: This Act makes changes to laws about prescription drugs, health insurance and some health care providers. The Act says the Oregon State Hospital does not have to do certain things about staffing. The Act changes the term "physician assistant" to "physician associate." (Flesch Readability Score: 60.4).]

Specifies that flavoring of a prescription drug is not compounding. [Prohibits drug manufacturers from restricting access to certain prescription drugs.] Exempts the Oregon State Hospital from certain hospital staffing requirements. [Removes the requirement that optometrists have hospital consulting privileges in order to qualify for tax credit.] Removes requirement that an applicant for licensure as a licensed professional counselor or therapist submit a professional disclosure statement. Changes the term "physician assistant" to "physician associate." [Requires health insurers to negotiate with health care interpreters and certain health care providers regarding coverage of health care interpretation services.]

Takes effect on the 91st day following adjournment sine die.

Oregon under ORS chapter 684 or a similarly licensed doctor or physician in any country or in any
state, territory or possession of the United States; or

(ii) Doctor of naturopathy or naturopathic physician licensed by the Oregon Board of
 Naturopathic Medicine under ORS chapter 685 or a similarly licensed doctor or physician in any

1 country or in any state, territory or possession of the United States; or

2 (C) For a cumulative total of 180 days from the first visit on the initial claim, a [*physician as-sistant*] **physician associate** licensed by the Oregon Medical Board in accordance with ORS 677.505 4 to 677.525 or a similarly licensed [*physician assistant*] **physician associate** in any country or in any 5 state, territory or possession of the United States.

6 (c) Except as otherwise provided for workers subject to a managed care contract, "attending 7 physician" does not include a physician who provides care in a hospital emergency room and refers 8 the injured worker to a primary care physician for follow-up care and treatment.

9 (d) "Consulting physician" means a doctor or physician who examines a worker or the worker's 10 medical record to advise the attending physician or nurse practitioner authorized to provide 11 compensable medical services under ORS 656.245 regarding treatment of a worker's compensable 12 injury.

(13)(a) "Employer" means any person, including receiver, administrator, executor or trustee, and the state, state agencies, counties, municipal corporations, school districts and other public corporations or political subdivisions, that contracts to pay a remuneration for the services of any worker.

(b) Notwithstanding paragraph (a) of this subsection, for purposes of this chapter, the client of a temporary service provider is not the employer of temporary workers provided by the temporary service provider.

(c) As used in paragraph (b) of this subsection, "temporary service provider" has the meaning
given that term in ORS 656.850.

(d) For the purposes of this chapter, "subject employer" means an employer that is subject to
 this chapter as provided in ORS 656.023.

(14) "Insurer" means the State Accident Insurance Fund Corporation or an insurer authorized
under ORS chapter 731 to transact workers' compensation insurance in this state or an assigned
claims agent selected by the director under ORS 656.054.

(15) "Consumer and Business Services Fund" means the fund created by ORS 705.145.

28 (16) "Incapacitated" means an individual is physically or mentally unable to earn a livelihood.

(17) "Medically stationary" means that no further material improvement would reasonably be
 expected from medical treatment or the passage of time.

(18) "Noncomplying employer" means a subject employer that has failed to comply with ORS
 656.017.

(19) "Objective findings" in support of medical evidence are verifiable indications of injury or disease that may include, but are not limited to, range of motion, atrophy, muscle strength and palpable muscle spasm. "Objective findings" does not include physical findings or subjective responses to physical examinations that are not reproducible, measurable or observable.

(20) "Palliative care" means medical service rendered to reduce or moderate temporarily the
 intensity of an otherwise stable medical condition, but does not include those medical services ren dered to diagnose, heal or permanently alleviate or eliminate a medical condition.

40 (21) "Party" means a claimant for compensation, the employer of the injured worker at the time 41 of injury and the insurer, if any, of the employer.

42 (22) "Payroll" means a record of wages payable to workers for their services and includes 43 commissions, value of exchange labor and the reasonable value of board, rent, housing, lodging or 44 similar advantage received from the employer. However, "payroll" does not include overtime pay, 45 vacation pay, bonus pay, tips, amounts payable under profit-sharing agreements or bonus payments

to reward workers for safe working practices. Bonus pay is limited to payments that are not anticipated under the contract of employment and that are paid at the sole discretion of the employer. The exclusion from payroll of bonus payments to reward workers for safe working practices is only for the purpose of calculations based on payroll to determine premium for workers' compensation

7 (23) "Person" includes a partnership, joint venture, association, limited liability company and

9 (24)(a) "Preexisting condition" means, for all industrial injury claims, any injury, disease, con-10 genital abnormality, personality disorder or similar condition that contributes to disability or need 11 for treatment, provided that:

12 (A) Except for claims in which a preexisting condition is arthritis or an arthritic condition, the 13 worker has been diagnosed with the condition, or has obtained medical services for the symptoms 14 of the condition regardless of diagnosis; and

(B)(i) In claims for an initial injury or omitted condition, the diagnosis or treatment precedes
 the initial injury;

(ii) In claims for a new medical condition, the diagnosis or treatment precedes the onset of thenew medical condition; or

(iii) In claims for a worsening pursuant to ORS 656.273 or 656.278, the diagnosis or treatment
 precedes the onset of the worsened condition.

(b) "Preexisting condition" means, for all occupational disease claims, any injury, disease, congenital abnormality, personality disorder or similar condition that contributes to disability or need for treatment and that precedes the onset of the claimed occupational disease, or precedes a claim for worsening in such claims pursuant to ORS 656.273 or 656.278.

(c) For the purposes of industrial injury claims, a condition does not contribute to disability or
 need for treatment if the condition merely renders the worker more susceptible to the injury.

(25) "Self-insured employer" means an employer or group of employers certified under ORS
656.430 as meeting the qualifications set out by ORS 656.407.

(26) "State Accident Insurance Fund Corporation" and "corporation" mean the State Accident
 Insurance Fund Corporation created under ORS 656.752.

31 (27) "Wages" means the money rate at which the service rendered is recompensed under the contract of hiring in force at the time of the accident, including reasonable value of board, rent, 32housing, lodging or similar advantage received from the employer, and includes the amount of tips 33 34 required to be reported by the employer pursuant to section 6053 of the Internal Revenue Code of 35 1954, as amended, and the regulations promulgated pursuant thereto, or the amount of actual tips reported, whichever amount is greater. The State Accident Insurance Fund Corporation may estab-36 37 lish assumed minimum and maximum wages, in conformity with recognized insurance principles, at 38 which any worker shall be carried upon the payroll of the employer for the purpose of determining the premium of the employer. 39

40 (28)(a) "Worker" means any person, other than an independent contractor, who engages to fur-41 nish services for a remuneration, including a minor whether lawfully or unlawfully employed and 42 salaried, elected and appointed officials of the state, state agencies, counties, cities, school districts 43 and other public corporations, but does not include any person whose services are performed as an 44 adult in custody or ward of a state institution or as part of the eligibility requirements for a general 45 or public assistance grant.

1 (b) For the purpose of determining entitlement to temporary disability benefits or permanent 2 total disability benefits under this chapter, "worker" does not include a person who has withdrawn 3 from the workforce during the period for which such benefits are sought.

6 (29) "Independent contractor" has the meaning given that term in ORS 670.600.

(1)(a) For every compensable injury, the insurer or the self-insured employer shall cause 9 to be provided medical services for conditions caused in material part by the injury for such period 10 as the nature of the injury or the process of the recovery requires, subject to the limitations in ORS 11 656.225, including such medical services as may be required after a determination of permanent 12 disability. In addition, for consequential and combined conditions described in ORS 656.005 (7), the 13 insurer or the self-insured employer shall cause to be provided only those medical services directed 14 to medical conditions caused in major part by the injury.

(c) Notwithstanding any other provision of this chapter, medical services after the worker's

(C) Services necessary to administer prescription medication or monitor the administration of
 prescription medication.

27 (D) Prosthetic devices, braces and supports.

(E) Services necessary to monitor the status, replacement or repair of prosthetic devices, braces
 and supports.

30 (F) Services provided pursuant to an accepted claim for aggravation under ORS 656.273.

31 (G) Services provided pursuant to an order issued under ORS 656.278.

32 (H) Services that are necessary to diagnose the worker's condition.

33 (I) Life-preserving modalities similar to insulin therapy, dialysis and transfusions.

34 (J) With the approval of the insurer or self-insured employer, palliative care that the worker's attending physician referred to in ORS 656.005 (12)(b)(A) prescribes and that is necessary to enable 35 the worker to continue current employment or a vocational training program. If the insurer or 36 37 self-insured employer does not approve, the attending physician or the worker may request approval 38 from the Director of the Department of Consumer and Business Services for such treatment. The director may order a medical review by a physician or panel of physicians pursuant to ORS 656.327 39 (3) to aid in the review of such treatment. The decision of the director is subject to review under 40 41 ORS 656.704.

42 (K) With the approval of the director, curative care arising from a generally recognized, non-43 experimental advance in medical science since the worker's claim was closed that is highly likely 44 to improve the worker's condition and that is otherwise justified by the circumstances of the claim. 45 The decision of the director is subject to review under ORS 656.704.

1 (L) Curative care provided to a worker to stabilize a temporary and acute waxing and waning 2 of symptoms of the worker's condition.

3 (d) When the medically stationary date in a disabling claim is established by the insurer or 4 self-insured employer and is not based on the findings of the attending physician, the insurer or 5 self-insured employer is responsible for reimbursement to affected medical service providers for 6 otherwise compensable services rendered until the insurer or self-insured employer provides written 7 notice to the attending physician of the worker's medically stationary status.

8 (e) Except for services provided under a managed care contract, out-of-pocket expense re-9 imbursement to receive care from the attending physician or nurse practitioner authorized to pro-10 vide compensable medical services under this section shall not exceed the amount required to seek 11 care from an appropriate nurse practitioner or attending physician of the same specialty who is in 12 a medical community geographically closer to the worker's home. For the purposes of this para-13 graph, all physicians and nurse practitioners within a metropolitan area are considered to be part 14 of the same medical community.

Thereafter, medical service provided to an injured worker without the written authorization of an attending physician is not compensable.

(B) A medical service provider who is not an attending physician cannot authorize the payment of temporary disability compensation. However, an emergency room physician who is not authorized to serve as an attending physician under ORS 656.005 (12)(c) may authorize temporary disability benefits for a maximum of 14 days. A medical service provider qualified to serve as an attending physician under ORS 656.005 (12)(b)(B) may authorize the payment of temporary disability compensation for a period not to exceed 30 days from the date of the first visit on the initial claim.

36 (C) Except as otherwise provided in this chapter, only a physician qualified to serve as an at-37 tending physician under ORS 656.005 (12)(b)(A) or (B)(i) who is serving as the attending physician 38 at the time of claim closure may make findings regarding the worker's impairment for the purpose 39 of evaluating the worker's disability.

23(a) Those workers who are subject to the contract shall receive medical services in the manner prescribed in the contract. A worker may continue to treat with the attending physician or nurse practitioner authorized to pro-35 vide compensable medical services under this section under an expired or terminated managed care 36 37 organization contract if the physician or nurse practitioner agrees to comply with the rules, terms 38 and conditions regarding services performed under any subsequent managed care organization contract to which the worker is subject. A worker shall not be subject to a contract if the worker's 39 40 primary residence is more than 100 miles outside the managed care organization's certified geographical area. Each such contract must comply with the certification standards provided in ORS 41 42656.260. However, a worker may receive immediate emergency medical treatment that is compensable from a medical service provider who is not a member of the managed care organization. 43 Insurers or self-insured employers who contract with a managed care organization for medical ser-44 vices shall give notice to the workers of eligible medical service providers and such other informa-45

Notwithstanding any provision of law or rule to the contrary, a worker of a noncomplying employer
is considered to be subject to a contract between the State Accident Insurance Fund Corporation

5 (b)(A) For initial or aggravation claims filed after June 7, 1995, the insurer or self-insured em-6 ployer may require an injured worker, on a case-by-case basis, immediately to receive medical ser-7 vices from the managed care organization.

8 (B) If the insurer or self-insured employer gives notice that the worker is required to receive 9 treatment from the managed care organization, the insurer or self-insured employer must guarantee that any reasonable and necessary services so received, that are not otherwise covered by health 10 insurance, will be paid as provided in ORS 656.248, even if the claim is denied, until the worker 11 12 receives actual notice of the denial or until three days after the denial is mailed, whichever event first occurs. Reasonable and necessary medical services received from sources other than the managed care organization after the date of claim denial must be paid as provided in ORS 656.248 by the insurer or self-insured employer if the claim is finally determined to be compensable.

(5)(a) A nurse practitioner, or a [*physician assistant*] **physician associate** described in ORS 656.005 (12)(b)(C), who is not a member of the managed care organization is authorized to provide the same level of services as a primary care physician as established by ORS 656.260 (4) if the nurse practitioner or [*physician assistant*] **physician associate**:

29 (A) Maintains the worker's medical records;

30 (B) Has a documented history of treatment with the worker;

31 (C) Agrees to refer the worker to the managed care organization for any specialized treatment,

including physical therapy, to be furnished by another provider that the worker may require; and
 (D) Agrees to comply with all the rules, terms and conditions regarding services performed by
 the managed care organization.

(b)(A) A nurse practitioner or [physician assistant] physician associate authorized to provide

(i) Provide medical treatment to the worker if the treatment is determined to be medically ap propriate according to the service utilization review process of the managed care organization; and

injured worker, insurer or self-insured employer may request administrative review by the director

(4) The director shall certify a health care provider or group of medical service providers to
 provide managed care under a plan if the director finds that the plan:

(a) Proposes to provide medical and health care services required by this chapter in a mannerthat:

26 (A) Meets quality, continuity and other treatment standards adopted by the health care provider 27 or group of medical service providers in accordance with processes approved by the director; and

(B) Is timely, effective and convenient for the worker.

(b) Subject to any other provision of law, does not discriminate against or exclude from participation in the plan any category of medical service providers and includes an adequate number of each category of medical service providers to give workers adequate flexibility to choose medical service providers from among those individuals who provide services under the plan. However, nothing in the requirements of this paragraph shall affect the provisions of ORS 441.055 relating to the granting of medical staff privileges.

(c) Provides appropriate financial incentives to reduce service costs and utilization without
 sacrificing the quality of service.

(d) Provides adequate methods of peer review, service utilization review, quality assurance, contract review and dispute resolution to ensure appropriate treatment or to prevent inappropriate or excessive treatment, to exclude from participation in the plan those individuals who violate these treatment standards and to provide for the resolution of such medical disputes as the director considers appropriate. A majority of the members of each peer review, quality assurance, service utilization and contract review committee shall be physicians licensed to practice medicine by the Oregon Medical Board. As used in this paragraph:

(A) "Peer review" means evaluation or review of the performance of colleagues by a panel with
 similar types and degrees of expertise. Peer review requires participation of at least three physicians

prior to final determination. 1

2 (B) "Service utilization review" means evaluation and determination of the reasonableness, necessity and appropriateness of a worker's use of medical care resources and the provision of any 3 needed assistance to clinician or member, or both, to ensure appropriate use of resources. "Service 4 utilization review" includes prior authorization, concurrent review, retrospective review, discharge $\mathbf{5}$ planning and case management activities. 6

(C) "Quality assurance" means activities to safeguard or improve the quality of medical care 7 by assessing the quality of care or service and taking action to improve it. 8

9 (D) "Dispute resolution" includes the resolution of disputes arising under peer review, service 10 utilization review and quality assurance activities between insurers, self-insured employers, workers and medical and health care service providers, as required under the certified plan. 11

12 (E) "Contract review" means the methods and processes whereby the managed care organization 13 monitors and enforces its contracts with participating providers for matters other than matters enumerated in subparagraphs (A), (B) and (C) of this paragraph. 14

15 (e) Provides a program involving cooperative efforts by the workers, the employer and the managed care organizations to promote workplace health and safety consultative and other services 16 17 and early return to work for injured workers.

18 (f) Provides a timely and accurate method of reporting to the director necessary information regarding medical and health care service cost and utilization to enable the director to determine 19 20the effectiveness of the plan.

(g)(A) Authorizes workers to receive compensable medical treatment from a primary care phy-2122sician or chiropractic physician who is not a member of the managed care organization, but who 23maintains the worker's medical records and is a physician with whom the worker has a documented 24history of treatment, if:

25(i) The primary care physician or chiropractic physician agrees to refer the worker to the managed care organization for any specialized treatment, including physical therapy, to be furnished 2627by another provider that the worker may require;

(ii) The primary care physician or chiropractic physician agrees to comply with all the rules, 28terms and conditions regarding services performed by the managed care organization; and 29

30 (iii) The treatment is determined to be medically appropriate according to the service utilization 31 review process of the managed care organization.

32(B) Nothing in this paragraph is intended to limit the worker's right to change primary care physicians or chiropractic physicians prior to the filing of a workers' compensation claim. 33

34 (C) A chiropractic physician authorized to provide compensable medical treatment under this 35 paragraph may provide services and authorize temporary disability compensation as provided in ORS 656.005 (12)(b)(B) and 656.245 (2)(b). However, the managed care organization may authorize 36 37 chiropractic physicians to provide medical services and authorize temporary disability payments 38 beyond the periods established in ORS 656.005 (12)(b)(B) and 656.245 (2)(b).

(D) As used in this paragraph, "primary care physician" means a physician who is qualified to 39 be an attending physician referred to in ORS 656.005 (12)(b)(A) and who is a family practitioner, a 40 general practitioner or an internal medicine practitioner. 41

(h) Provides a written explanation for denial of participation in the managed care organization 42 plan to any licensed health care provider that has been denied participation in the managed care 43 organization plan. 44

(i) Does not prohibit the injured worker's attending physician from advocating for medical ser-

vices and temporary disability benefits for the injured worker that are supported by the medicalrecord.

(j) Complies with any other requirement the director determines is necessary to provide quality
 medical services and health care to injured workers.

5 (5)(a) Notwithstanding ORS 656.245 (5) and subsection (4)(g) of this section, a managed care or-6 ganization may deny or terminate the authorization of a primary care physician or chiropractic 7 physician to serve as an attending physician under subsection (4)(g) of this section or of a nurse 8 practitioner or [*physician assistant*] **physician associate** to provide medical services as provided in 9 ORS 656.245 (5) if the physician, nurse practitioner or [*physician assistant*] **physician associate**, 10 within two years prior to the worker's enrollment in the plan:

(A) Has been terminated from serving as an attending physician, nurse practitioner or [*physician associate* for a worker enrolled in the plan for failure to meet the requirements
 of subsection (4)(g) of this section or of ORS 656.245 (5); or

(B) Has failed to satisfy the credentialing standards for participating in the managed care or-ganization.

 other health professional licensed or certified in this state, whose clinical practice is in the area
 of primary care.

(B) A health care team or clinic that has been certified by the Oregon Health Authority as a
 patient centered primary care home.

(2)(a) The Oregon Health Authority shall convene a primary care payment reform collaborative
 to advise and assist in the implementation of a Primary Care Transformation Initiative to:

39 (A) Use value-based payment methods that are not paid on a per claim basis to:

40 (i) Increase the investment in primary care;

41 (ii) Align primary care reimbursement by all purchasers of care; and

42 (iii) Continue to improve reimbursement methods, including by investing in the social determi-43 nants of health;

(B) Increase investment in primary care without increasing costs to consumers or increasing the
 total cost of health care;

1	(C) Provide technical assistance to clinics and payers in implementing the initiative;
2	(D) Aggregate the data from and align the metrics used in the initiative with the work of the
3	Health Plan Quality Metrics Committee established in ORS 413.017;
4	(E) Facilitate the integration of primary care behavioral and physical health care; and
5	(F) Ensure that the goals of the initiative are met by December 31, 2027.
6	(b) The collaborative is a governing body, as defined in ORS 192.610.
7	(3) The authority shall invite representatives from all of the following to participate in the pri-
8	mary care payment reform collaborative:
9	(a) Primary care providers;
10	(b) Health care consumers;
11	(c) Experts in primary care contracting and reimbursement;
12	(d) Independent practice associations;
13	(e) Behavioral health treatment providers;
14	(f) Third party administrators;
15	(g) Employers that offer self-insured health benefit plans;
16	(h) The Department of Consumer and Business Services;
17	(i) Carriers;
18	(j) A statewide organization for mental health professionals who provide primary care;
19	(k) A statewide organization representing federally qualified health centers;
20	(L) A statewide organization representing hospitals and health systems;
21	(m) A statewide professional association for family physicians;
22	(n) A statewide professional association for physicians;
23	(o) A statewide professional association for nurses; and
24	(p) The Centers for Medicare and Medicaid Services.
25	(4) The primary care payment reform collaborative shall annually report to the Oregon Health
26	Policy Board and to the Legislative Assembly on the achievement of the primary care spending
27	targets in ORS [414.625] 414.572 and 743.010 and the implementation of the Primary Care Transfor-
28	mation Initiative.
29	(5) A coordinated care organization shall report to the authority, no later than October 1 of
30	each year, the proportion of the organization's total medical costs that are allocated to primary
31	care.
32	(6) The authority, in collaboration with the Department of Consumer and Business Services,
33	shall adopt rules prescribing the primary care services for which costs must be reported under
34	subsection (5) of this section.

36	Sec. 20. A [physician assistant] physician associate practicing under a practice agreement or
