SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act makes changes to laws about prescription drugs and some health care providers. The Act says the Oregon State Hospital does not have to do certain things about staffing. The Act changes the term "physician assistant" to "physician associate." (Flesch Readability Score: 62.1).

Specifies that flavoring of a prescription drug is not compounding. Exempts the Oregon State Hospital from certain hospital staffing requirements. Removes requirement that an applicant for licensure as a licensed professional counselor or therapist submit a professional disclosure statement. Changes the term "physician assistant" to "physician associate."

Takes effect on the 91st day following adjournment sine die.

1 (6)(a) A hospital professional and technical staffing committee must adopt a professional and
2 technical staffing plan by a majority vote of the members of the committee. If a quorum of members
3 present at a meeting comprises an unequal number of professional and technical staff and profes-
4 sional and technical managers, only an equal number of staff and managers may vote. A staffing plan
5 adopted by the committee must include a summary of the committee's consideration of the criteria
6 in subsection (5) of this section and how the plan:

7 (A) Is consistent with the approved nurse staffing plan for the hospital; and

8 (B) Takes into account the hospital service staffing plan for the hospital that was developed in
9 accordance with ORS 441.776.

10 (b) If the hospital professional and technical staffing committee does not adopt a professional
11 and technical staffing plan or adopts only a part of the staffing plan, either cochair may invoke the
12 commencement of a 60-day period during which the committee shall continue to develop the staffing
13 plan. If, by the end of the 60-day period, the committee does not adopt a staffing plan or adopts only
14 part of a staffing plan, the committee shall submit the disputed plan or parts of the plan, as appli-
15 cable, including a summary of the committee's consideration of the criteria in subsection (5) of this
16 section, to the chief executive officer of the hospital. No later than 60 days after receiving the
17 submission from the committee, the chief executive officer or the chief executive officer's designee
18 shall decide the disputed plan or parts of the plan, as applicable, considering the summary of the
19 committee's consideration of the criteria in subsection (5) of this section, and adopt the staffing plan
20 or parts of the staffing plan that were not adopted by the committee. The chief executive officer or
21 the chief executive officer's designee shall provide to the committee:

22 (A) A written explanation of the staffing plan or the parts of the staffing plan that were in dis-
23 pute;

24 (B) The final written proposals of the members of the committee and the members' rationales for
25 their proposals and the committee's summary of the committee's consideration of the criteria in
26 subsection (5) of this section; and

27 (C) A summary of the consideration by the chief executive officer or the chief executive officer's
28 designee of the criteria in subsection (5) of this section.

30 (b) If the service staff who work at the hospital have an exclusive representative, the exclusive
31 representative shall select the service staff members of the hospital service staffing committee.

32 (c) If none of the service staff who work at the hospital have an exclusive representative, the
33 service staff managers shall select the service staff members of the hospital service staffing com-
34 mittee.

35 (2) A hospital service staffing committee shall develop a written hospital-wide hospital service
36 staffing plan in accordance with subsection (5) of this section. The committee shall review and
37 modify the staffing plan as needed in accordance with this section.

28 were not adopted by the committee. The chief executive officer or the chief executive officer's
29 designee shall provide to the committee:

37 **SECTION 8.** ORS 743B.221 is amended to read:

38 743B.221. (1) As used in this section, "primary care provider" means an individual, **clinic or**
39 **team of health care providers** licensed or certified in this state to provide outpatient, nonspecialty
40 medical services or the coordination of health care for the purpose of:

41 (a) Promoting or maintaining mental and physical health and wellness; and

42 (b) Diagnosis, treatment or management of acute or chronic conditions caused by disease, injury
43 or illness.

44 (2) An insurer offering an individual or group policy or certificate of health insurance that re-
45 imburse the cost of hospital, medical or surgical expenses, other than coverage limited to expenses

1 from accidents or specific diseases and limited benefit coverage, must assign a beneficiary under the
2 policy or certificate to a primary care provider if the beneficiary or a parent of a minor beneficiary
3 has not selected a primary care provider by the 90th day of the plan year. If the insurer assigns the
4 beneficiary to a primary care provider, the insurer shall provide notice of the assignment to the
5 beneficiary or parent and to the primary care provider.

6 (3) A beneficiary may select a different primary care provider at any time.

7 (4) The Department of Consumer and Business Services shall adopt rules prescribing a method-

35 **SECTION 10.** ORS 675.755 is amended to read:

36 675.755. (1) Except as provided in subsection [(6)] (4) of this section, prior to the performance
37 of professional counseling or marriage and family therapy, [*the*] **a** licensee must furnish the client
38 with a copy of a professional disclosure statement. If the licensee fails to provide the statement, the
39 licensee [*shall*] **may** not charge [*a*] **the** client a fee for services.

40 (2) A professional disclosure statement [*shall*] **must** include the following information regarding
41 the [*applicant or*] licensee:

42 (a) Name, business address and telephone number;

43 (b) Philosophy and approach to counseling or marriage and family therapy;

44 (c) Formal education and training;

45 (d) Continuing education and supervision requirements; and

(e) Fee schedules.

(3) The statement must include the name, address and telephone number of the Oregon Board of Licensed Professional Counselors and Therapists.

[(4) An applicant shall submit a professional disclosure statement for board approval upon application for a license.]

[(5) Whenever an applicant or licensee makes a change in the professional disclosure statement, the new statement shall be presented to the board for approval.]

[(6)] (4) The board may adopt by rule exemptions from the requirements of this section.

SECTION 11. The amendments to ORS 675.755 by section 10 of this 2024 Act apply to applications received by the Oregon Board of Licensed Professional Counselors and Marriage and Family Therapists on or after the effective date of this 2024 Act and to professional disclosure statements changed on or after the effective date of this 2024 Act.

PHYSICIAN ASSISTANTS

SECTION 15. ORS 3.450 is amended to read:

3.450. (1) As used in this section:

(a) “Drug court program” means a program in which:

(A) Individuals who are before the court obtain treatment for substance abuse issues and report regularly to the court on the progress of their treatment; and

(B) A local drug court team, consisting of the court, agency personnel and treatment and service providers, monitors the individuals’ participation in treatment.

(b) “Individual-provider relationship” includes a relationship between an individual and a physician, a [*physician assistant*] **physician associate** or nurse practitioner.

(2)(a) The governing body of a county or a treatment provider may establish fees that individuals participating in a drug court program may be required to pay for treatment and other services provided as part of the drug court program.

(b) A court may order an individual participating in a drug court program to pay fees to participate in the program. Fees imposed under this subsection may not be paid to the court.

(3) Records that are maintained by the circuit court specifically for the purpose of a drug court program must be maintained separately from other court records. Records maintained by a circuit court specifically for the purpose of a drug court program are confidential and may not be disclosed except in accordance with regulations adopted under 42 U.S.C. 290dd-2, including under the circumstances described in subsections (4) to (7) of this section.

(4) If the individual who is the subject of the record gives written consent, a record described in subsection (3) of this section may be disclosed to members of the local drug court team in order to develop treatment plans, monitor progress in treatment and determine outcomes of participation in the drug court program.

(5) A record described in subsection (3) of this section may not be introduced into evidence in any legal proceeding other than the drug court program unless:

(a) The individual who is the subject of the record gives written consent for introduction of the record; or

(b) The court finds good cause for introduction. In determining whether good cause exists for purposes of this paragraph, the court shall weigh the public interest and the need for disclosure against the potential injury caused by the disclosure to:

(A) The individual who is the subject of the record;

(B) The individual-provider relationship; and

(C) The treatment services being provided to the individual who is the subject of the record.

(6) A court, the State Court Administrator, the Alcohol and Drug Policy Commission or the Oregon Criminal Justice Commission:

(a) May use records described in subsection (3) of this section and other drug court program information to track and develop statistics about the effectiveness, costs and other areas of public interest concerning drug court programs.

(b) May release statistics developed under paragraph (a) of this subsection and analyses based on the statistics to the public.

1 (7) Statistics and analyses released under subsection (6) of this section may not contain any in-
2 formation that identifies an individual participant in a drug court program.

12 limited to necessary personnel.

13 (e) The data is limited to elements required for analysis and meets the criteria in 45 C.F.R.
14 164.514(e) for a limited data set.

15 (f) The investigator is a party to the data use agreement as provided by 45 C.F.R. 164.514(e) for
16 limited data set recipients.

17 (6) Research conducted in accordance with this section is rebuttably presumed to comply with
18 ORS 192.535 and 192.539.

19 (7)(a) Notwithstanding ORS 192.535, a person may use a DNA sample or genetic information
20 obtained, with blanket informed consent, before June 25, 2001, for genetic research.

21 (b) Notwithstanding ORS 192.535, a person may use a DNA sample or genetic information ob-
22 tained without specific informed consent and derived from a biological specimen or clinical individ-
23 ually identifiable health information for anonymous research or coded research if an institutional
24 review board operating under subsection (1)(b) of this section:

25 (A) Waives or alters the consent requirements pursuant to the Federal Policy for the Protection

(B) The exceptions to the right to revoke the authorization;

(C) The ability or inability to condition treatment, payment, enrollment or eligibility for benefits on whether the individual signs the authorization; and

(D) The potential for information disclosed pursuant to the authorization to be subject to redisclosure by the recipient and no longer protected.

(2) "Covered entity" means:

(a) A state health plan;

(b) A health insurer;

(c) A health care provider that transmits any health information in electronic form to carry out financial or administrative activities in connection with a transaction covered by ORS 192.553 to 192.581; or

(d) A health care clearinghouse.

(3) "Health care" means care, services or supplies related to the health of an individual.

(4) "Health care operations" includes but is not limited to:

(a) Quality assessment, accreditation, auditing and improvement activities;

7 physician;
- 8 (J) A naturopathic physician licensed under ORS chapter 685 or an employee of the naturopathic
9 physician;
- 10 (K) A massage therapist licensed under ORS 687.011 to 687.250 or an employee of the massage
11 therapist;
- 12 (L) A direct entry midwife licensed under ORS 687.405 to 687.495 or an employee of the direct
13 entry midwife;
- 14 (M) A physical therapist licensed under ORS 688.010 to 688.201 or an employee of the physical
15 therapist;
- 16 (N) A medical imaging licensee under ORS 688.405 to 688.605 or an employee of the medical
17 imaging licensee;
- 18 (O) A respiratory care practitioner licensed under ORS 688.815 or an employee of the respir-
19 atory care practitioner;
- 20 (P) A polysomnographic technologist licensed under ORS 688.819 or an employee of the poly-
21 somnographic technologist;
- 22 (Q) A pharmacist licensed under ORS chapter 689 or an employee of the pharmacist;
- 23 (R) A dietitian licensed under ORS 691.405 to 691.485 or an employee of the dietitian;
- 24 (S) A funeral service practitioner licensed under ORS chapter 692 or an employee of the funeral
25 service practitioner;
- 26 (T) A health care facility as defined in ORS 442.015;
- 27 (U) A home health agency as defined in ORS 443.014;
- 28 (V) A hospice program as defined in ORS 443.850;
- 29 (W) A clinical laboratory as defined in ORS 438.010;
- 30 (X) A pharmacy as defined in ORS 689.005; and
- 31 (Y) Any other person or entity that furnishes, bills for or is paid for health care in the normal
32 course of business.
- 33 (c) “Individual” means a natural person.
- 34 (d) “Individually identifiable health information” means any oral or written health information
35 in any form or medium that is:
- 36 (A) Created or received by a covered entity, an employer or a health care provider that is not
37 a covered entity; and
- 38 (B) Identifiable to an individual, including demographic information that identifies the individual,
39 or for which there is a reasonable basis to believe the information can be used to identify an indi-

2 (7) "Other treatment" means oral administration of food containing glucose or other forms of

4 (8) "Other treatment has failed" means a hypoglycemic student's symptoms have worsened after
5 the administration of a food containing glucose or other form of carbohydrate or a hypoglycemic
6 student has become incoherent, unconscious or unresponsive.

7 (9) "Physician" means a physician licensed under ORS chapter 677.

8 (10) [*"Physician assistant"*] "**Physician associate**" means a [*physician assistant*] **physician as-**
9 **sociate** licensed under ORS 677.505 to 677.525.

10 **SECTION 83.** ORS 433.815 is amended to read:

11 433.815. (1) Educational training on the treatment of allergic responses, as required by ORS
12 433.800 to 433.830, shall be conducted by a physician, [*physician assistant*] **physician associate** or
13 nurse practitioner. The training may be conducted by any other health care professional licensed
14 under ORS chapter 678 as assigned by a physician, [*physician assistant*] **physician associate** or

20 (a) "Facility" means a hospital, outpatient clinic owned by a hospital, ambulatory surgical center,
21 freestanding birthing center or facility that receives Medicare reimbursement as an independent
22 diagnostic testing facility.

23 (b) "Financial interest" means a five percent or greater direct or indirect ownership interest.

24 (c)(A) "Health practitioner" means a physician, naturopathic physician licensed under ORS
25 chapter 685, dentist, direct entry midwife, licensed [*physician assistant*] **physician associate** or
26 medical imaging licensee under ORS 688.405 to 688.605 or a nurse practitioner or nurse practitioner
27 specializing in nurse midwifery licensed under ORS chapter 678.

28 (B) "Health practitioner" does not include a provider in a health maintenance organization as
29 defined in ORS 750.005.

30 (d) "Physician" has the meaning given that term in ORS 677.010.

31 (2) A health practitioner's decision to refer a patient to a facility for a diagnostic test or health
32 care treatment or service shall be based on the patient's clinical needs and personal health choices.

33 (3) If a health practitioner refers a patient for a diagnostic test or health care treatment or
34 service at a facility in which the health practitioner or an immediate family member of the health
35 practitioner has a financial interest, the health practitioner or the practitioner's designee shall in-
36 form the patient orally and in writing of that interest at the time of the referral.

37 (4)(a) If a health practitioner refers a patient to a facility for a diagnostic test or health care
38 treatment or service, the health practitioner or the practitioner's designee shall inform the patient,
39 in the form and manner prescribed by the Oregon Health Authority by rule, that:

40 (A) The patient may receive the test, treatment or service at a different facility of the patient's

9 Threshold Limit Values for Chemical Substances and Physical Agents in the Work Environment by
10 the American Conference of Governmental Industrial Hygienists; or

11 (c) Radioactive waste and material as defined in ORS 469.300 and radioactive substance as de-

42 (7) "Manager" means a person licensed by the superintendent who does any of the following:

43 (a) By contract or agreement undertakes to represent the interests of a professional unarmed
44 combat sports competitor in procuring or arranging the conduct of an unarmed combat sports event
45 in which the professional unarmed combat sports competitor is a participant.

1 (b) Receives or is entitled to receive more than 10 percent of the contracted portion of the gross
2 purse of a professional unarmed combat sports competitor for services related to the unarmed com-
3 bat sports competitor's participation in an unarmed combat sports event.

4 (c) Is an officer, director or stockholder of a corporation that receives or is entitled to receive
5 more than 10 percent of the contracted portion of the gross purse of a professional unarmed combat
6 sports competitor for services relating to the unarmed combat sports competitor's participation in
7 an unarmed combat sports event.

8 (d) Directs or controls the professional activities of a professional unarmed combat sports com-
9 petitor.

10 (e) Attends to the professional unarmed combat sports competitor at cageside or ringside or

12 (8) "Matchmaker" means a person licensed by the superintendent who is employed by or asso-

8 warehouseman or employee of the carrier or warehouseman.

9 (5) "Board" means the State Board of Pharmacy.

10 (6) "Controlled substance":

11 (a) Means a drug or its immediate precursor classified in Schedules I through V under the fed-
12 eral Controlled Substances Act, 21 U.S.C. 811 to 812, as modified under ORS 475.035. The use of the
13 term "precursor" in this paragraph does not control and is not controlled by the use of the term
14 "precursor" in ORS 475.752 to 475.980.

15 (b) Does not include:

16 (A) The plant Cannabis family Cannabaceae;

17 (B) Any part of the plant Cannabis family Cannabaceae, whether growing or not;

18 (C) Resin extracted from any part of the plant Cannabis family Cannabaceae;

19 (D) The seeds of the plant Cannabis family Cannabaceae;

20 (E) Any compound, manufacture, salt, derivative, mixture or preparation of a plant, part of a
21 plant, resin or seed described in this paragraph; or

22 (F) Psilocybin or psilocin, but only if and to the extent that a person manufactures, delivers, or

29 (8) "Deliver" or "delivery" means the actual, constructive or attempted transfer, other than by
30 administering or dispensing, from one person to another of a controlled substance, whether or not
31 there is an agency relationship.

32 (9) "Device" means instruments, apparatus or contrivances, including their components, parts
33 or accessories, intended:

34 (a) For use in the diagnosis, cure, mitigation, treatment or prevention of disease in humans or

45 to any of them;

1 (b) Substances intended for use in the diagnosis, cure, mitigation, treatment or prevention of
2 disease in humans or animals;

5 (d) Substances intended for use as a component of any article specified in paragraph (a), (b) or
6 (c) of this subsection; however, the term does not include devices or their components, parts or ac-

8 (14) “Electronically transmitted” or “electronic transmission” means a communication sent or
9 received through technological apparatuses, including computer terminals or other equipment or
10 mechanisms linked by telephone or microwave relays, or any similar apparatus having electrical,
11 digital, magnetic, wireless, optical, electromagnetic or similar capabilities.

12 (15) “Manufacture” means the production, preparation, propagation, compounding, conversion
13 or processing of a controlled substance, either directly or indirectly by extraction from substances
14 of natural origin, or independently by means of chemical synthesis, or by a combination of extraction
15 and chemical synthesis, and includes any packaging or repackaging of the substance or labeling or
16 relabeling of its container, except that this term does not include the preparation or compounding
17 of a controlled substance:

43 (b) "Compensable injury" does not include:

44 (A) Injury to any active participant in assaults or combats that are not connected to the job
45 assignment and that amount to a deviation from customary duties;

1 (B) Injury incurred while engaging in or performing, or as the result of engaging in or per-
2 forming, any recreational or social activities primarily for the worker's personal pleasure; or

3 (C) Injury the major contributing cause of which is demonstrated to be by a preponderance of
4 the evidence the injured worker's consumption of alcoholic beverages or cannabis or the unlawful
5 consumption of any controlled substance, unless the employer permitted, encouraged or had actual
6 knowledge of such consumption.

7 (c) A "disabling compensable injury" is an injury that entitles the worker to compensation for
8 disability or death. An injury is not disabling if no temporary benefits are due and payable, unless
9 there is a reasonable expectation that permanent disability will result from the injury.

10 (d) A "nondisabling compensable injury" is any injury that requires medical services only.

11 (8) "Compensation" includes all benefits, including medical services, provided for a compensable
12 injury to a subject worker or the worker's beneficiaries by an insurer or self-insured employer pur-
13 suant to this chapter.

14 (9) "Department" means the Department of Consumer and Business Services.

15 (10) "Dependent" means any of the following individuals who, at the time of an accident, de-
16 pended in whole or in part for the individual's support on the earnings of a worker who dies as a
17 result of an injury:

18 (a) A parent of a worker or the parent's spouse or domestic partner;

19 (b) A grandparent of a worker or the grandparent's spouse or domestic partner;

20 (c) A grandchild of a worker or the grandchild's spouse or domestic partner;

21 (d) A sibling or stepsibling of a worker or the sibling's or stepsibling's spouse or domestic
22 partner; and

23 (e) Any individual related by blood or affinity whose close association with a worker is the
24 equivalent of a family relationship.

25 (11) "Director" means the Director of the Department of Consumer and Business Services.

26 (12)(a) "Doctor" or "physician" means a person duly licensed to practice one or more of the
27 healing arts in any country or in any state, territory or possession of the United States within the
28 limits of the license of the licensee.

29 (b) Except as otherwise provided for workers subject to a managed care contract, "attending
30 physician" means a doctor, physician or [*physician assistant*] **physician associate** who is primarily
31 responsible for the treatment of a worker's compensable injury and who is:

32 (A) A physician licensed under ORS 677.100 to 677.228 by the Oregon Medical Board, or a
33 podiatric physician and surgeon licensed under ORS 677.805 to 677.840 by the Oregon Medical
34 Board, an oral and maxillofacial surgeon licensed by the Oregon Board of Dentistry or a similarly
35 licensed doctor in any country or in any state, territory or possession of the United States;

36 (B) For a cumulative total of 60 days from the first visit on the initial claim or for a cumulative
37 total of 18 visits, whichever occurs first, to any of the medical service providers listed in this sub-
38 paragraph, a:

39 (i) Doctor or physician licensed by the State Board of Chiropractic Examiners for the State of
40 Oregon under ORS chapter 684 or a similarly licensed doctor or physician in any country or in any
41 state, territory or possession of the United States; or

42 (ii) Doctor of naturopathy or naturopathic physician licensed by the Oregon Board of
43 Naturopathic Medicine under ORS chapter 685 or a similarly licensed doctor or physician in any
44 country or in any state, territory or possession of the United States; or

45 (C) For a cumulative total of 180 days from the first visit on the initial claim, a [*physician as-*

1 *sistant*] **physician associate** licensed by the Oregon Medical Board in accordance with ORS 677.505
2 to 677.525 or a similarly licensed [*physician assistant*] **physician associate** in any country or in any
3 state, territory or possession of the United States.

4 (c) Except as otherwise provided for workers subject to a managed care contract, “attending
5 physician” does not include a physician who provides care in a hospital emergency room and refers
6 the injured worker to a primary care physician for follow-up care and treatment.

7 (d) “Consulting physician” means a doctor or physician who examines a worker or the worker’s
8 medical record to advise the attending physician or nurse practitioner authorized to provide
9 compensable medical services under ORS 656.245 regarding treatment of a worker’s compensable
10 injury.

11 (13)(a) “Employer” means any person, including receiver, administrator, executor or trustee, and
12 the state, state agencies, counties, municipal corporations, school districts and other public corpo-
13 rations or political subdivisions, that contracts to pay a remuneration for the services of any
14 worker.

15 (b) Notwithstanding paragraph (a) of this subsection, for purposes of this chapter, the client of
16 a temporary service provider is not the employer of temporary workers provided by the temporary
17 service provider.

18 (c) As used in paragraph (b) of this subsection, “temporary service provider” has the meaning
19 given that term in ORS 656.850.

20 (d) For the purposes of this chapter, “subject employer” means an employer that is subject to
21 this chapter as provided in ORS 656.023.

22 (14) “Insurer” means the State Accident Insurance Fund Corporation or an insurer authorized
23 under ORS chapter 731 to transact workers’ compensation insurance in this state or an assigned
24 claims agent selected by the director under ORS 656.054.

25 (15) “Consumer and Business Services Fund” means the fund created by ORS 705.145.

26 (16) “Incapacitated” means an individual is physically or mentally unable to earn a livelihood.

27 (17) “Medically stationary” means that no further material improvement would reasonably be
28 expected from medical treatment or the passage of time.

29 (18) “Noncomplying employer” means a subject employer that has failed to comply with ORS
30 656.017.

31 (19) “Objective findings” in support of medical evidence are verifiable indications of injury or
32 disease that may include, but are not limited to, range of motion, atrophy, muscle strength and
33 palpable muscle spasm. “Objective findings” does not include physical findings or subjective re-
34 sponses to physical examinations that are not reproducible, measurable or observable.

35 (20) “Palliative care” means medical service rendered to reduce or moderate temporarily the
36 intensity of an otherwise stable medical condition, but does not include those medical services ren-
37 dered to diagnose, heal or permanently alleviate or eliminate a medical condition.

38 (21) “Party” means a claimant for compensation, the employer of the injured worker at the time
39 of injury and the insurer, if any, of the employer.

40 (22) “Payroll” means a record of wages payable to workers for their services and includes
41 commissions, value of exchange labor and the reasonable value of board, rent, housing, lodging or
42 similar advantage received from the employer. However, “payroll” does not include overtime pay,
43 vacation pay, bonus pay, tips, amounts payable under profit-sharing agreements or bonus payments
44 to reward workers for safe working practices. Bonus pay is limited to payments that are not antic-
45 ipated under the contract of employment and that are paid at the sole discretion of the employer.

1 The exclusion from payroll of bonus payments to reward workers for safe working practices is only
2 for the purpose of calculations based on payroll to determine premium for workers' compensation
3 insurance, and does not affect any other calculation or determination based on payroll for the pur-
4 poses of this chapter.

5 (23) "Person" includes a partnership, joint venture, association, limited liability company and
6 corporation.

7 (24)(a) "Preexisting condition" means, for all industrial injury claims, any injury, disease, con-
8 genital abnormality, personality disorder or similar condition that contributes to disability or need
9 for treatment, provided that:

10 (A) Except for claims in which a preexisting condition is arthritis or an arthritic condition, the
11 worker has been diagnosed with the condition, or has obtained medical services for the symptoms
12 of the condition regardless of diagnosis; and

13 (B)(i) In claims for an initial injury or omitted condition, the diagnosis or treatment precedes
14 the initial injury;

15 (ii) In claims for a new medical condition, the diagnosis or treatment precedes the onset of the
16 new medical condition; or

17 (iii) In claims for a worsening pursuant to ORS 656.273 or 656.278, the diagnosis or treatment
18 precedes the onset of the worsened condition.

19 (b) "Preexisting condition" means, for all occupational disease claims, any injury, disease, con-
20 genital abnormality, personality disorder or similar condition that contributes to disability or need
21 for treatment and that precedes the onset of the claimed occupational disease, or precedes a claim
22 for worsening in such claims pursuant to ORS 656.273 or 656.278.

23 (c) For the purposes of industrial injury claims, a condition does not contribute to disability or
24 need for treatment if the condition merely renders the worker more susceptible to the injury.

25 (25) "Self-insured employer" means an employer or group of employers certified under ORS
26 656.430 as meeting the qualifications set out by ORS 656.407.

27 (26) "State Accident Insurance Fund Corporation" and "corporation" mean the State Accident
28 Insurance Fund Corporation created under ORS 656.752.

29 (27) "Wages" means the money rate at which the service rendered is recompensed under the
30 contract of hiring in force at the time of the accident, including reasonable value of board, rent,
31 housing, lodging or similar advantage received from the employer, and includes the amount of tips
32 required to be reported by the employer pursuant to section 6053 of the Internal Revenue Code of
33 1954, as amended, and the regulations promulgated pursuant thereto, or the amount of actual tips
34 reported, whichever amount is greater. The State Accident Insurance Fund Corporation may estab-
35 lish assumed minimum and maximum wages, in conformity with recognized insurance principles, at
36 which any worker shall be carried upon the payroll of the employer for the purpose of determining
37 the premium of the employer.

38 (28)(a) "Worker" means any person, other than an independent contractor, who engages to fur-
39 nish services for a remuneration, including a minor whether lawfully or unlawfully employed and
40 salaried, elected and appointed officials of the state, state agencies, counties, cities, school districts
41 and other public corporations, but does not include any person whose services are performed as an
42 adult in custody or ward of a state institution or as part of the eligibility requirements for a general
43 or public assistance grant.

44 (b) For the purpose of determining entitlement to temporary disability benefits or permanent
45 total disability benefits under this chapter, "worker" does not include a person who has withdrawn

1 from the workforce during the period for which such benefits are sought.

2 (c) For the purposes of this chapter, “subject worker” means a worker who is subject to this
3 chapter as provided in ORS 656.027.

4 (29) “Independent contractor” has the meaning given that term in ORS 670.600.

5 **SECTION 111.** ORS 656.245 is amended to read:

6 656.245. (1)(a) For every compensable injury, the insurer or the self-insured employer shall cause
7 to be provided medical services for conditions caused in material part by the injury for such period
8 as the nature of the injury or the process of the recovery requires, subject to the limitations in ORS
9 656.225, including such medical services as may be required after a determination of permanent
10 disability. In addition, for consequential and combined conditions described in ORS 656.005 (7), the
11 insurer or the self-insured employer shall cause to be provided only those medical services directed
12 to medical conditions caused in major part by the injury.

13 (b) Compensable medical services shall include medical, surgical, hospital, nursing, ambulances
14 and other related services, and drugs, medicine, crutches and prosthetic appliances, braces and
15 supports and where necessary, physical restorative services. A pharmacist or dispensing physician
16 shall dispense generic drugs to the worker in accordance with ORS 689.515. The duty to provide
17 such medical services continues for the life of the worker.

18 (c) Notwithstanding any other provision of this chapter, medical services after the worker’s
19 condition is medically stationary are not compensable except for the following:

20 (A) Services provided to a worker who has been determined to be permanently and totally dis-
21 abled.

22 (B) Prescription medications.

23 (C) Services necessary to administer prescription medication or monitor the administration of
24 prescription medication.

25 (D) Prosthetic devices, braces and supports.

26 (E) Services necessary to monitor the status, replacement or repair of prosthetic devices, braces
27 and supports.

28 (F) Services provided pursuant to an accepted claim for aggravation under ORS 656.273.

29 (G) Services provided pursuant to an order issued under ORS 656.278.

30 (H) Services that are necessary to diagnose the worker’s condition.

31 (I) Life-preserving modalities similar to insulin therapy, dialysis and transfusions.

32 (J) With the approval of the insurer or self-insured employer, palliative care that the worker’s
33 attending physician referred to in ORS 656.005 (12)(b)(A) prescribes and that is necessary to enable
34 the worker to continue current employment or a vocational training program. If the insurer or
35 self-insured employer does not approve, the attending physician or the worker may request approval
36 from the Director of the Department of Consumer and Business Services for such treatment. The
37 director may order a medical review by a physician or panel of physicians pursuant to ORS 656.327
38 (3) to aid in the review of such treatment. The decision of the director is subject to review under
39 ORS 656.704.

40 (K) With the approval of the director, curative care arising from a generally recognized, non-
41 experimental advance in medical science since the worker’s claim was closed that is highly likely
42 to improve the worker’s condition and that is otherwise justified by the circumstances of the claim.
43 The decision of the director is subject to review under ORS 656.704.

44 (L) Curative care provided to a worker to stabilize a temporary and acute waxing and waning
45 of symptoms of the worker’s condition.

1 (d) When the medically stationary date in a disabling claim is established by the insurer or
2 self-insured employer and is not based on the findings of the attending physician, the insurer or
3 self-insured employer is responsible for reimbursement to affected medical service providers for
4 otherwise compensable services rendered until the insurer or self-insured employer provides written
5 notice to the attending physician of the worker's medically stationary status.

6 (e) Except for services provided under a managed care contract, out-of-pocket expense re-
7 imbursement to receive care from the attending physician or nurse practitioner authorized to pro-
8 vide compensable medical services under this section shall not exceed the amount required to seek
9 care from an appropriate nurse practitioner or attending physician of the same specialty who is in
10 a medical community geographically closer to the worker's home. For the purposes of this para-
11 graph, all physicians and nurse practitioners within a metropolitan area are considered to be part
12 of the same medical community.

13 (2)(a) The worker may choose an attending doctor, physician or nurse practitioner within the
14 State of Oregon. The worker may choose the initial attending physician or nurse practitioner and
15 may subsequently change attending physician or nurse practitioner two times without approval from
16 the director. If the worker thereafter selects another attending physician or nurse practitioner, the
17 insurer or self-insured employer may require the director's approval of the selection. The decision
18 of the director is subject to review under ORS 656.704. The worker also may choose an attending
19 doctor or physician in another country or in any state or territory or possession of the United
20 States with the prior approval of the insurer or self-insured employer.

21 (b) A medical service provider who is not a member of a managed care organization is subject
22 to the following provisions:

23 (A) A medical service provider who is not qualified to be an attending physician may provide
24 compensable medical service to an injured worker for a period of 30 days from the date of the first
25 visit on the initial claim or for 12 visits, whichever first occurs, without the authorization of an
26 attending physician. Thereafter, medical service provided to an injured worker without the written
27 authorization of an attending physician is not compensable.

28 (B) A medical service provider who is not an attending physician cannot authorize the payment
29 of temporary disability compensation. However, an emergency room physician who is not authorized
30 to serve as an attending physician under ORS 656.005 (12)(c) may authorize temporary disability
31 benefits for a maximum of 14 days. A medical service provider qualified to serve as an attending
32 physician under ORS 656.005 (12)(b)(B) may authorize the payment of temporary disability compen-
33 sation for a period not to exceed 30 days from the date of the first visit on the initial claim.

34 (C) Except as otherwise provided in this chapter, only a physician qualified to serve as an at-
35 tending physician under ORS 656.005 (12)(b)(A) or (B)(i) who is serving as the attending physician
36 at the time of claim closure may make findings regarding the worker's impairment for the purpose
37 of evaluating the worker's disability.

38 (D) Notwithstanding subparagraphs (A) and (B) of this paragraph, a nurse practitioner licensed
39 under ORS 678.375 to 678.390 or a [*physician assistant*] **physician associate** licensed by the Oregon
40 Medical Board in accordance with ORS 677.505 to 677.525 or a similarly licensed [*physician*
41 *assistant*] **physician associate** in any country or in any state, territory or possession of the United
42 States:

43 (i) May provide compensable medical services for 180 days from the date of the first visit on the
44 initial claim;

45 (ii) May authorize the payment of temporary disability benefits for a period not to exceed 180

1 days from the date of the first visit on the initial claim; and

2 (iii) When an injured worker treating with a nurse practitioner or [*physician assistant*] **physi-**
 3 **cian associate** authorized to provide compensable services under this section becomes medically
 4 stationary within the 180-day period in which the nurse practitioner or [*physician assistant*] **physi-**
 5 **cian associate** is authorized to treat the injured worker, shall refer the injured worker to a physi-
 6 cian qualified to be an attending physician as defined in ORS 656.005 for the purpose of making
 7 findings regarding the worker's impairment for the purpose of evaluating the worker's disability. If
 8 a worker returns to the nurse practitioner or [*physician assistant*] **physician associate** after initial
 9 claim closure for evaluation of a possible worsening of the worker's condition, the nurse practitioner
 10 or [*physician assistant*] **physician associate** shall refer the worker to an attending physician and the
 11 insurer shall compensate the nurse practitioner or [*physician assistant*] **physician associate** for the
 12 examination performed.

13 (3) Notwithstanding any other provision of this chapter, the director, by rule, upon the advice
 14 of the committee created by ORS 656.794 and upon the advice of the professional licensing boards
 15 of practitioners affected by the rule, may exclude from compensability any medical treatment the
 16 director finds to be unscientific, unproven, outmoded or experimental. The decision of the director
 17 is subject to review under ORS 656.704.

18 (4) Notwithstanding subsection (2)(a) of this section, when a self-insured employer or the insurer
 19 of an employer contracts with a managed care organization certified pursuant to ORS 656.260 for
 20 medical services required by this chapter to be provided to injured workers:

21 (a) Those workers who are subject to the contract shall receive medical services in the manner
 22 prescribed in the contract. Workers subject to the contract include those who are receiving medical
 23 treatment for an accepted compensable injury or occupational disease, regardless of the date of in-
 24 jury or medically stationary status, on or after the effective date of the contract. If the managed
 25 care organization determines that the change in provider would be medically detrimental to the
 26 worker, the worker shall not become subject to the contract until the worker is found to be med-
 27 ically stationary, the worker changes physicians or nurse practitioners, or the managed care or-
 28 ganization determines that the change in provider is no longer medically detrimental, whichever
 29 event first occurs. A worker becomes subject to the contract upon the worker's receipt of actual
 30 notice of the worker's enrollment in the managed care organization, or upon the third day after the
 31 notice was sent by regular mail by the insurer or self-insured employer, whichever event first oc-
 32 curs. A worker shall not be subject to a contract after it expires or terminates without renewal. A
 33 worker may continue to treat with the attending physician or nurse practitioner authorized to pro-
 34 vide compensable medical services under this section under an expired or terminated managed care
 35 organization contract if the physician or nurse practitioner agrees to comply with the rules, terms
 36 and conditions regarding services performed under any subsequent managed care organization con-
 37 tract to which the worker is subject. A worker shall not be subject to a contract if the worker's
 38 primary residence is more than 100 miles outside the managed care organization's certified ge-
 39 ographical area. Each such contract must comply with the certification standards provided in ORS
 40 656.260. However, a worker may receive immediate emergency medical treatment that is
 41 compensable from a medical service provider who is not a member of the managed care organization.
 42 Insurers or self-insured employers who contract with a managed care organization for medical ser-
 43 vices shall give notice to the workers of eligible medical service providers and such other informa-
 44 tion regarding the contract and manner of receiving medical services as the director may prescribe.
 45 Notwithstanding any provision of law or rule to the contrary, a worker of a noncomplying employer

1 is considered to be subject to a contract between the State Accident Insurance Fund Corporation
2 as a processing agent or the assigned claims agent and a managed care organization.

3 (b)(A) For initial or aggravation claims filed after June 7, 1995, the insurer or self-insured em-
4 ployer may require an injured worker, on a case-by-case basis, immediately to receive medical ser-
5 vices from the managed care organization.

6 (B) If the insurer or self-insured employer gives notice that the worker is required to receive
7 treatment from the managed care organization, the insurer or self-insured employer must guarantee
8 that any reasonable and necessary services so received, that are not otherwise covered by health
9 insurance, will be paid as provided in ORS 656.248, even if the claim is denied, until the worker
10 receives actual notice of the denial or until three days after the denial is mailed, whichever event
11 first occurs. The worker may elect to receive care from a primary care physician, nurse practitioner
12 or [*physician assistant*] **physician associate** authorized to provide compensable medical services
13 under this section who agrees to the conditions of ORS 656.260 (4)(g). However, guarantee of pay-
14 ment is not required by the insurer or self-insured employer if this election is made.

15 (C) If the insurer or self-insured employer does not give notice that the worker is required to
16 receive treatment from the managed care organization, the insurer or self-insured employer is under
17 no obligation to pay for services received by the worker unless the claim is later accepted.

18 (D) If the claim is denied, the worker may receive medical services after the date of denial from
19 sources other than the managed care organization until the denial is reversed. Reasonable and
20 necessary medical services received from sources other than the managed care organization after
21 the date of claim denial must be paid as provided in ORS 656.248 by the insurer or self-insured em-
22 ployer if the claim is finally determined to be compensable.

23 (5)(a) A nurse practitioner, or a [*physician assistant*] **physician associate** described in ORS
24 656.005 (12)(b)(C), who is not a member of the managed care organization is authorized to provide
25 the same level of services as a primary care physician as established by ORS 656.260 (4) if the nurse
26 practitioner or [*physician assistant*] **physician associate**:

27 (A) Maintains the worker's medical records;

28 (B) Has a documented history of treatment with the worker;

29 (C) Agrees to refer the worker to the managed care organization for any specialized treatment,
30 including physical therapy, to be furnished by another provider that the worker may require; and

31 (D) Agrees to comply with all the rules, terms and conditions regarding services performed by
32 the managed care organization.

33 (b)(A) A nurse practitioner or [*physician assistant*] **physician associate** authorized to provide
34 medical services to a worker enrolled in the managed care organization may:

35 (i) Provide medical treatment to the worker if the treatment is determined to be medically ap-
36 propriate according to the service utilization review process of the managed care organization; and

37 (ii) Authorize temporary disability payments as provided in subsection (2)(b)(D) of this section.

38 (B) The managed care organization may also authorize the nurse practitioner or [*physician as-*
39 *stant*] **physician associate** to provide medical services and authorize temporary disability pay-
40 ments beyond the periods established in subsection (2)(b)(D) of this section.

41 (6) Subject to the provisions of ORS 656.704, if a claim for medical services is disapproved, the
42 injured worker, insurer or self-insured employer may request administrative review by the director
43 pursuant to ORS 656.260 or 656.327.

44 **SECTION 112.** ORS 656.260 is amended to read:

45 656.260. (1) Any health care provider or group of medical service providers may make written

1 application to the Director of the Department of Consumer and Business Services to become certi-
2 fied to provide managed care to injured workers for injuries and diseases compensable under this
3 chapter. However, nothing in this section authorizes an organization that is formed, owned or op-
4 erated by an insurer or employer other than a health care provider to become certified to provide
5 managed care.

6 (2) Each application for certification shall be accompanied by a reasonable fee prescribed by the
7 director. A certificate is valid for such period as the director may prescribe unless sooner revoked
8 or suspended.

9 (3) Application for certification shall be made in such form and manner and shall set forth such
10 information regarding the proposed plan for providing services as the director may prescribe. The
11 information shall include, but not be limited to:

12 (a) A list of the names of all individuals who will provide services under the managed care plan,
13 together with appropriate evidence of compliance with any licensing or certification requirements
14 for that individual to practice in this state.

15 (b) A description of the times, places and manner of providing services under the plan.

16 (c) A description of the times, places and manner of providing other related optional services
17 the applicants wish to provide.

18 (d) Satisfactory evidence of ability to comply with any financial requirements to insure delivery
19 of service in accordance with the plan which the director may prescribe.

20 (4) The director shall certify a health care provider or group of medical service providers to
21 provide managed care under a plan if the director finds that the plan:

22 (a) Proposes to provide medical and health care services required by this chapter in a manner
23 that:

24 (A) Meets quality, continuity and other treatment standards adopted by the health care provider
25 or group of medical service providers in accordance with processes approved by the director; and

26 (B) Is timely, effective and convenient for the worker.

27 (b) Subject to any other provision of law, does not discriminate against or exclude from partic-
28 ipation in the plan any category of medical service providers and includes an adequate number of
29 each category of medical service providers to give workers adequate flexibility to choose medical
30 service providers from among those individuals who provide services under the plan. However,
31 nothing in the requirements of this paragraph shall affect the provisions of ORS 441.055 relating to
32 the granting of medical staff privileges.

33 (c) Provides appropriate financial incentives to reduce service costs and utilization without
34 sacrificing the quality of service.

35 (d) Provides adequate methods of peer review, service utilization review, quality assurance,
36 contract review and dispute resolution to ensure appropriate treatment or to prevent inappropriate
37 or excessive treatment, to exclude from participation in the plan those individuals who violate these
38 treatment standards and to provide for the resolution of such medical disputes as the director con-
39 siders appropriate. A majority of the members of each peer review, quality assurance, service utili-
40 zation and contract review committee shall be physicians licensed to practice medicine by the
41 Oregon Medical Board. As used in this paragraph:

42 (A) "Peer review" means evaluation or review of the performance of colleagues by a panel with
43 similar types and degrees of expertise. Peer review requires participation of at least three physicians
44 prior to final determination.

45 (B) "Service utilization review" means evaluation and determination of the reasonableness, ne-

1 cessity and appropriateness of a worker’s use of medical care resources and the provision of any
2 needed assistance to clinician or member, or both, to ensure appropriate use of resources. “Service
3 utilization review” includes prior authorization, concurrent review, retrospective review, discharge
4 planning and case management activities.

5 (C) “Quality assurance” means activities to safeguard or improve the quality of medical care
6 by assessing the quality of care or service and taking action to improve it.

7 (D) “Dispute resolution” includes the resolution of disputes arising under peer review, service
8 utilization review and quality assurance activities between insurers, self-insured employers, workers
9 and medical and health care service providers, as required under the certified plan.

10 (E) “Contract review” means the methods and processes whereby the managed care organization
11 monitors and enforces its contracts with participating providers for matters other than matters
12 enumerated in subparagraphs (A), (B) and (C) of this paragraph.

13 (e) Provides a program involving cooperative efforts by the workers, the employer and the
14 managed care organizations to promote workplace health and safety consultative and other services
15 and early return to work for injured workers.

16 (f) Provides a timely and accurate method of reporting to the director necessary information
17 regarding medical and health care service cost and utilization to enable the director to determine
18 the effectiveness of the plan.

19 (g)(A) Authorizes workers to receive compensable medical treatment from a primary care phy-
20 sician or chiropractic physician who is not a member of the managed care organization, but who
21 maintains the worker’s medical records and is a physician with whom the worker has a documented
22 history of treatment, if:

23 (i) The primary care physician or chiropractic physician agrees to refer the worker to the
24 managed care organization for any specialized treatment, including physical therapy, to be furnished
25 by another provider that the worker may require;

26 (ii) The primary care physician or chiropractic physician agrees to comply with all the rules,
27 terms and conditions regarding services performed by the managed care organization; and

28 (iii) The treatment is determined to be medically appropriate according to the service utilization
29 review process of the managed care organization.

30 (B) Nothing in this paragraph is intended to limit the worker’s right to change primary care
31 physicians or chiropractic physicians prior to the filing of a workers’ compensation claim.

32 (C) A chiropractic physician authorized to provide compensable medical treatment under this
33 paragraph may provide services and authorize temporary disability compensation as provided in ORS
34 656.005 (12)(b)(B) and 656.245 (2)(b). However, the managed care organization may authorize

41 plan to any licensed health care provider that has been denied participation in the managed care

43 (i) Does not prohibit the injured worker’s attending physician from advocating for medical ser-
44 vices and temporary disability benefits for the injured worker that are supported by the medical
45 record.

1 (j) Complies with any other requirement the director determines is necessary to provide quality
2 medical services and health care to injured workers.

3 (5)(a) Notwithstanding ORS 656.245 (5) and subsection (4)(g) of this section, a managed care or-
4 ganization may deny or terminate the authorization of a primary care physician or chiropractic
5 physician to serve as an attending physician under subsection (4)(g) of this section or of a nurse
6 practitioner or [*physician assistant*] **physician associate** to provide medical services as provided in

22 care provider or group of medical service providers to provide managed care if the director finds
23 that:

24 (a) The plan for providing medical or health care services fails to meet the requirements of this

26 (b) Service under the plan is not being provided in accordance with the terms of a certified plan.

27 (7) Any issue concerning the provision of medical services to injured workers subject to a
28 managed care contract and service utilization review, quality assurance, dispute resolution, contract
29 review and peer review activities as well as authorization of medical services to be provided by
30 other than an attending physician pursuant to ORS 656.245 (2)(b) shall be subject to review by the
31 director or the director's designated representatives. The decision of the director is subject to re-
32 view under ORS 656.704. Data generated by or received in connection with these activities, includ-
33 ing written reports, notes or records of any such activities, or of any review thereof, shall be
34 confidential, and shall not be disclosed except as considered necessary by the director in the ad-

10 **associate's** primary location of practice and made available to the Oregon Medical Board upon re-

12 (4) Performance assessments and reviews of a [*physician assistant*] **physician associate** may be
13 completed by the [*physician assistant's*] **physician associate's** employer in accordance with a per-

19 (a) Refuse to issue a license or permit to any applicant;

20 (b) Refuse to renew the license of any medical imaging licensee or the permit of a limited X-ray

23 (d) Issue a letter of reprimand to a licensee or permittee of the board; or

24 (e) Impose probation upon a licensee or permittee of the board.

25 (2) The board may take any of the actions described in subsection (1) of this section against a

27 (a) Has been disciplined by a credentialing organization or a licensing board in this state or in
28 another state, territory of the United States or nation for acts by the holder of a license or a permit
29 that are similar to acts described in this subsection. A certified copy of the order of discipline
30 constitutes conclusive evidence of the discipline.

31 (b) Has an impairment as defined in ORS 676.303.

32 (c) In the judgment of the board, is guilty of unethical or unprofessional conduct in the practice
33 of a medical imaging modality or as a limited X-ray machine operator.

34 (d) Has been convicted of any crime that bears a demonstrable relationship to the practice of
35 a medical imaging modality or as a limited X-ray machine operator, or otherwise reflects adversely
36 on fitness to practice.

37 (e) In the judgment of the board, has acted with gross negligence in the practice of a medical
38 imaging modality or as a limited X-ray machine operator.

39 (f) Has undertaken to act as a medical imaging licensee independently of the supervision of a
40 licensed physician, or has undertaken to act as a limited X-ray machine operator independently of
41 the supervision of a licensed physician, licensed nurse practitioner or licensed [*physician assistant*]
42 **physician associate**.

43 (g) Has obtained or attempted to obtain a license or permit under ORS 688.405 to 688.605 by
44 fraud or material misrepresentation.

45 (h) Is in violation of a provision of ORS 688.405 to 688.605 or rule adopted under ORS 688.405

1 to 688.605.

2 (i) Has failed to respond to inquiries by the board.

3 (j) Has failed to cooperate with an investigation conducted by the board.

4 (k) Has failed to comply with an order issued by the board.

5 (L) Has committed an act of moral turpitude, dishonesty, fraud or misrepresentation that is not
6 related to the practice of a medical imaging modality or as a limited X-ray machine operator but
7 that, in the discretion of the board, bears upon the person's fitness to practice medical imaging.

8 (3) Upon receipt of a complaint under ORS 688.405 to 688.605, the board shall conduct an in-
9 vestigation as described under ORS 676.165.

10 (4) Information that the board obtains as part of an investigation into licensee, permittee or
11 applicant conduct or as part of a contested case proceeding, consent order or stipulated agreement

43 (b) Must be performed in accordance with the prescription or verbal order of a physician,
44 naturopathic physician or [*physician assistant*] **physician associate** licensed under ORS chapter 677
45 or a nurse practitioner licensed under ORS 678.375 to 678.390 and under the direction of a qualified

1 medical director for polysomnography.

2 **SECTION 150.** ORS 694.042 is amended to read:

3 694.042. (1) In addition to any other rights and remedies the purchaser may have, including
4 rights under ORS 646A.460 to 646A.476, the purchaser of a hearing aid shall have the right to
5 rescind the transaction if:

6 (a) The purchaser for whatever reason consults with a physician licensed under ORS chapter
7 677 to practice medicine who specializes in diseases of the ear or with a [*physician assistant*] **phy-**
8 **sician associate** licensed under ORS 677.505 to 677.525 who specializes in diseases of the ear, or
9 consults with an audiologist not licensed under this chapter and not affiliated with anyone licensed
10 under this chapter and with a physician licensed under ORS chapter 677 to practice medicine or
11 with a [*physician assistant*] **physician associate** licensed under ORS 677.505 to 677.525, subsequent
12 to purchasing the hearing aid, and the physician or [*physician assistant*] **physician associate** advises
13 such purchaser against purchasing or using a hearing aid and in writing specifies the medical reason
14 for the advice;

15 (b) The seller, in dealings with the purchaser, failed to adhere to the practice standards listed
16 in ORS 694.142, or failed to provide the statement required by ORS 694.036;

17 (c) The fitting of the hearing instrument failed to meet current industry standards; or

18 (d) The licensee fails to meet any standard of conduct prescribed in the law or rules regulating
19 fitting and dispensing of hearing aids and this failure affects in any way the transaction which the
20 purchaser seeks to rescind.

21 (2) The purchaser of a hearing aid shall have the right to rescind the transaction, for other than

5 contained in this section requires the insurer to reproduce in the policy the particular language of
6 any of the following provisions:

7 (1)(a) Notwithstanding ORS 30.260 to 30.300, the insurer will pay all sums that the insured or
8 the heirs or legal representative of the insured is legally entitled to recover as damages from the
9 owner or operator of an uninsured vehicle because of bodily injury sustained by the insured caused
10 by accident and arising out of the ownership, maintenance or use of the uninsured vehicle. Deter-
11 mination as to whether the insured, the insured's heirs or the insured's legal representative is le-
12 gally entitled to recover such damages, and if so, the amount thereof, shall be made by agreement
13 between the insured and the insurer, or, in the event of disagreement, may be determined by arbi-
14 tration as provided in subsection (10) of this section.

15 (b) No judgment against any person or organization alleged to be legally responsible for bodily
16 injury, except for proceedings instituted against the insurer as provided in this policy, shall be
17 conclusive, as between the insured and the insurer, on the issues of liability of the person or or-
18 ganization or of the amount of damages to which the insured is legally entitled.

19 (2) As used in this policy:

20 (a) "Bodily injury" means bodily injury, sickness or disease, including death resulting therefrom.

21 (b) "Hit-and-run vehicle" means a vehicle that causes bodily injury to an insured arising out of
22 physical contact of the vehicle with the insured or with a vehicle the insured is occupying at the
23 time of the accident, provided:

24 (A) The identity of either the operator or the owner of the hit-and-run vehicle cannot be ascer-
25 tained;

26 (B) The insured or someone on behalf of the insured reported the accident within 72 hours to
27 a police, peace or judicial officer, to the Department of Transportation or to the equivalent depart-
28 ment in the state where the accident occurred, and filed with the insurer within 30 days thereafter
29 a statement under oath that the insured or the legal representative of the insured has a cause or
30 causes of action arising out of the accident for damages against a person or persons whose identities
31 are unascertainable, and setting forth the facts in support thereof; and

32 (C) At the insurer's request, the insured or the legal representative of the insured makes avail-
33 able for inspection the vehicle the insured was occupying at the time of the accident.

34 (c) "Insured," when unqualified and when applied to uninsured motorist coverage, means:

35 (A) The named insured as stated in the policy and any person designated as named insured in
36 the schedule and, while residents of the same household, the spouse of any named insured and rel-
37 atives of either, provided that neither the relative nor the spouse is the owner of a vehicle not de-
38 scribed in the policy and that, if the named insured as stated in the policy is other than an
39 individual or spouses in a marriage who are residents of the same household, the named insured
40 shall be only a person so designated in the schedule;

41 (B) Any child residing in the household of the named insured if the insured has performed the
42 duties of a parent to the child by rearing the child as the insured's own although the child is not
43 related to the insured by blood, marriage or adoption; and

44 (C) Any other person while occupying an insured vehicle, provided the actual use thereof is with
45 the permission of the named insured.

1 (d) "Insured vehicle," except as provided in paragraph (e) of this provision, means:

2 (A) The vehicle described in the policy or a newly acquired or substitute vehicle, as each of
3 those terms is defined in the public liability coverage of the policy, insured under the public liability
4 provisions of the policy; or

5 (B) A nonowned vehicle operated by the named insured or spouse if a resident of the same
6 household, provided that the actual use thereof is with the permission of the owner of the vehicle
7 and the vehicle is not owned by nor furnished for the regular or frequent use of the insured or any
8 member of the same household.

9 (e) "Insured vehicle" does not include a trailer of any type unless the trailer is a described ve-
10 hicle in the policy.

11 (f) "Occupying" means in or upon or entering into or alighting from.

12 (g) "Phantom vehicle" means a vehicle that causes bodily injury to an insured arising out of a
13 motor vehicle accident that is caused by a vehicle that has no physical contact with the insured or
14 the vehicle the insured is occupying at the time of the accident, provided:

15 (A) The identity of either the operator or the owner of the phantom vehicle cannot be ascer-
16 tained;

17 (B) The facts of the accident can be corroborated by competent evidence other than the testi-
18 mony of the insured or any person having an uninsured motorist claim resulting from the accident;
19 and

20 (C) The insured or someone on behalf of the insured reported the accident within 72 hours to
21 a police, peace or judicial officer, to the Department of Transportation or to the equivalent depart-
22 ment in the state where the accident occurred, and filed with the insurer within 30 days thereafter
23 a statement under oath that the insured or the legal representative of the insured has a cause or
24 causes of action arising out of the accident for damages against a person or persons whose identities
25 are unascertainable, and setting forth the facts in support thereof.

26 (h) "State" includes the District of Columbia, a territory or possession of the United States and
27 a province of Canada.

28 (i) "Stolen vehicle" means an insured vehicle that causes bodily injury to the insured arising
29 out of a motor vehicle accident if:

30 (A) The vehicle is operated without the consent of the insured;

31 (B) The operator of the vehicle does not have collectible motor vehicle bodily injury liability
32 insurance;

33 (C) The insured or someone on behalf of the insured reported the accident within 72 hours to
34 a police, peace or judicial officer or to the equivalent department in the state where the accident
35 occurred; and

36 (D) The insured or someone on behalf of the insured cooperates with the appropriate law
37 enforcement agency in the prosecution of the theft of the vehicle.

38 (j) "Sums that the insured or the heirs or legal representative of the insured is legally entitled
39 to recover as damages" means the amount of damages that:

40 (A) A claimant could have recovered in a civil action from the owner or operator at the time
41 of the injury after determination of fault or comparative fault and resolution of any applicable de-
42 fenses;

43 (B) Are calculated without regard to the tort claims limitations of ORS 30.260 to 30.300; and

44 (C) Are no larger than benefits payable under the terms of the policy as provided in subsection
45 (7) of this section.

1 (k) "Uninsured vehicle," except as provided in paragraph (L) of this provision, means:

2 (A) A vehicle with respect to the ownership, maintenance or use of which there is no collectible
3 motor vehicle bodily injury liability insurance, in at least the amounts or limits prescribed for bodily
4 injury or death under ORS 806.070 applicable at the time of the accident with respect to any person
5 or organization legally responsible for the use of the vehicle, or with respect to which there is
6 collectible bodily injury liability insurance applicable at the time of the accident but the insurance
7 company writing the insurance denies coverage or the company writing the insurance becomes vol-
8 untarily or involuntarily declared bankrupt or for which a receiver is appointed or becomes insol-
9 vent. It shall be a disputable presumption that a vehicle is uninsured in the event the insured and
10 the insurer, after reasonable efforts, fail to discover within 90 days from the date of the accident,
11 the existence of a valid and collectible motor vehicle bodily injury liability insurance applicable at
12 the time of the accident.

13 (B) A hit-and-run vehicle.

14 (C) A phantom vehicle.

15 (D) A stolen vehicle.

16 (E) A vehicle that is owned or operated by a self-insurer:

17 (i) That is not in compliance with ORS 806.130 (1)(c); or

18 (ii) That provides recovery to an insured in an amount that is less than the sums that the in-
19 sured or the heirs or legal representative of the insured is legally entitled to recover as damages
20 for bodily injury or death that is caused by accident and that arises out of owning, maintaining or
21 using an uninsured vehicle.

22 (L) "Uninsured vehicle" does not include:

23 (A) An insured vehicle, unless the vehicle is a stolen vehicle;

24 (B) Except as provided in paragraph (k)(E) of this subsection, a vehicle that is owned or oper-
25 ated by a self-insurer within the meaning of any motor vehicle financial responsibility law, motor
26 carrier law or any similar law;

27 (C) A vehicle that is owned by the United States of America, Canada, a state, a political sub-
28 division of any such government or an agency of any such government;

29 (D) A land motor vehicle or trailer, if operated on rails or crawler-treads or while located for
30 use as a residence or premises and not as a vehicle;

31 (E) A farm-type tractor or equipment designed for use principally off public roads, except while
32 actually upon public roads; or

33 (F) A vehicle owned by or furnished for the regular or frequent use of the insured or any
34 member of the household of the insured.

35 (m) "Vehicle" means every device in, upon or by which any person or property is or may be
36 transported or drawn upon a public highway, but does not include devices moved by human power
37 or used exclusively upon stationary rails or tracks.

38 (3) This coverage applies only to accidents that occur on and after the effective date of the
39 policy, during the policy period and within the United States of America, its territories or pos-
40 sessions, or Canada.

41 (4)(a) This coverage does not apply to bodily injury of an insured with respect to which the in-
42 sured or the legal representative of the insured shall, without the written consent of the insurer,
43 make any settlement with or prosecute to judgment any action against any person or organization
44 who may be legally liable therefor.

45 (b) This coverage does not apply to bodily injury to an insured while occupying a vehicle, other

1 than an insured vehicle, owned by, or furnished for the regular use of, the named insured or any
2 relative resident in the same household, or through being struck by the vehicle.

3 (c) This coverage does not apply so as to inure directly or indirectly to the benefit of any
4 workers' compensation carrier, any person or organization qualifying as a self-insurer under any
5 workers' compensation or disability benefits law or any similar law or the State Accident Insurance
6 Fund Corporation.

7 (d) This coverage does not apply with respect to underinsured motorist benefits unless:

8 (A) The limits of liability under any bodily injury liability insurance applicable at the time of
9 the accident regarding the injured person have been exhausted by payment of judgments or settle-
10 ments to the injured person or other injured persons;

11 (B) The described limits have been offered in settlement, the insurer has refused consent under
12 paragraph (a) of this subsection and the insured protects the insurer's right of subrogation to the
13 claim against the tortfeasor;

14 (C) The insured gives credit to the insurer for the unrealized portion of the described liability
15 limits as if the full limits had been received if less than the described limits have been offered in
16 settlement, and the insurer has consented under paragraph (a) of this subsection; or

17 (D) The insured gives credit to the insurer for the unrealized portion of the described liability
18 limits as if the full limits had been received if less than the described limits have been offered in
19 settlement and, if the insurer has refused consent under paragraph (a) of this subsection, the insured
20 protects the insurer's right of subrogation to the claim against the tortfeasor.

21 (e) When seeking consent under paragraph (a) or (d) of this subsection, the insured shall allow
22 the insurer a reasonable time in which to collect and evaluate information related to consent to the
23 proposed offer of settlement. The insured shall provide promptly to the insurer any information that
24 is reasonably requested by the insurer and that is within the custody and control of the insured.
25 Consent will be presumed to be given if the insurer does not respond within a reasonable time. For
26 purposes of this paragraph, a "reasonable time" is no more than 30 days from the insurer's receipt
27 of a written request for consent, unless the insured and the insurer agree otherwise.

28 (5)(a) As soon as practicable, the insured or other person making claim shall give to the insurer
29 written proof of claim, under oath if required, including full particulars of the nature and extent of
30 the injuries, treatment and other details entering into the determination of the amount payable
31 hereunder. The insured and every other person making claim hereunder shall submit to examinations
32 under oath by any person named by the insurer and subscribe the same, as often as may reasonably
33 be required. Proof of claim shall be made upon forms furnished by the insurer unless the insurer fails
34 to furnish the forms within 15 days after receiving notice of claim.

35 (b) Upon reasonable request of and at the expense of the insurer, the injured person shall submit
36 to physical examinations by physicians, naturopathic physicians, [*physician assistants*] **physician**
37 **associates** or nurse practitioners selected by the insurer and shall, upon each request from the
38 insurer, execute authorization to enable the insurer to obtain medical reports and copies of records.

39 (6) If, before the insurer makes payment of loss hereunder, the insured or the legal represen-

33 the Department of Consumer and Business Services shall develop and approve a form for the request
34 for verification.

35 (d) The insurer shall respond to a request for verification of coverage submitted on an approved
36 form by a life settlement provider or life settlement broker within 30 calendar days of the date the
37 request is received and shall indicate whether, based on the medical evidence and documents pro-
38 vided, the insurer intends to pursue an investigation at this time regarding the validity of the in-
39 surance contract or possible fraud. The insurer shall accept a request for verification of coverage
40 made on a form approved by the director. The insurer shall accept an original or facsimile or elec-
41 tronic copy of such request and any accompanying authorization signed by the owner. Failure by the
42 insurer to meet its obligations under this subsection is a violation of the Insurance Code.

43 (e) Prior to or at the time of execution of the life settlement contract, the life settlement pro-
44 vider shall obtain a witnessed document in which the owner consents to the life settlement contract,
45 represents that the owner has a full and complete understanding of the life settlement contract, that

1 the owner has a full and complete understanding of the benefits of the life insurance policy, ac-
2 knowledges that the owner is entering into the life settlement contract freely and voluntarily and,
3 for persons with a terminal illness or chronic illness or condition, acknowledges that the insured
4 has a terminal illness or chronic illness and that the terminal illness or chronic illness or condition
5 was diagnosed after the life insurance policy was issued.

6 (f) If a life settlement broker performs any of the activities required of the life settlement pro-
7 vider, the provider is deemed to have fulfilled the requirements of this section that were performed
8 by the broker.

9 (2) All medical information solicited or obtained by any licensee is privileged and confidential
10 under ORS 705.137.

11 (3)(a) All life settlement contracts entered into in this state must provide the owner with an
12 absolute right to rescind the contract before the earlier of 60 calendar days after the date upon
13 which the life settlement contract is executed by all parties or 30 calendar days after the life
14 settlement proceeds have been sent to the owner under subsection (5) of this section.

15 (b) The life settlement provider may condition rescission upon the owner both giving notice and
16 repaying to the life settlement provider within the rescission period all proceeds of the settlement
17 and any premiums, loans and loan interest paid by or on behalf of the life settlement provider in
18 connection with or as a consequence of the life settlement.

19 (c) If the insured dies during the rescission period, the life settlement contract is deemed to have
20 been rescinded, subject to repayment within 60 calendar days of the death of the insured to the life
21 settlement provider or purchaser of all life settlement proceeds and any premiums, loans and loan
22 interest that have been paid by the life settlement provider or purchaser.

23 (d) In the event of any rescission, if the life settlement provider has paid commissions or other
24 compensation to a life settlement broker in connection with the rescinded transaction, the life
25 settlement broker shall refund all such commissions and compensation to the life settlement provider
26 within five business days following receipt of written demand from the life settlement provider. The
27 demand must be accompanied by either the owner's notice of rescission if rescinded at the election
28 of the owner, or the notice of the death of the insured if rescinded by reason of the death of the
29 insured within the applicable rescission period.

30 (4) The life settlement purchaser shall have the right to rescind a life settlement contract within
31 three days after the disclosures mandated by ORS 744.354 (7) are received by the purchaser.

32 (5)(a) The life settlement provider shall instruct the owner to send the executed documents re-
33 quired to effect the change in ownership, assignment or change in beneficiary directly to an inde-
34 pendent escrow agent selected by the provider.

35 (b) Within three business days after the date the escrow agent receives the document, or from
36 the date the life settlement provider receives the documents, if the owner erroneously provides the
37 documents directly to the provider, the provider shall pay or transfer the proceeds of the life
38 settlement into an escrow or trust account maintained in a state or federally chartered financial
39 institution whose deposits are insured by the Federal Deposit Insurance Corporation.

40 (c) Upon payment of the settlement proceeds into the escrow account, the escrow agent shall
41 deliver the original change in ownership, assignment or change in beneficiary forms to the life
42 settlement provider or related provider trust or other designated representative of the life settle-
43 ment provider. Upon the escrow agent's receipt of the acknowledgment of the properly completed
44 transfer of ownership, assignment or designation of beneficiary from the insurance company, the
45 escrow agent shall pay the settlement proceeds to the owner.

1 (6) Failure to pay the owner the full contract amount for the life settlement contract within the
2 time set forth under subsection (5) of this section renders the life settlement contract voidable by
3 the owner until the time full payment is tendered to and accepted by the owner. Funds are deemed
4 sent by a life settlement provider to an owner as of the date that the escrow agent either releases
5 funds for wire transfer to the owner or places a check for delivery to the owner via the United
6 States Postal Service or another nationally recognized delivery service.

7 (7)(a) Contacts with the insured for the purpose of determining the health status of the insured
8 by the life settlement provider or life settlement broker after the life settlement has occurred may
9 be made only by the life settlement provider or broker licensed in this state or its authorized rep-
10 resentatives and are limited to once every three months for insureds with a life expectancy of more
11 than one year, and to no more than once per month for insureds with a life expectancy of one year
12 or less.

13 (b) The limitations set forth in this subsection do not apply to any contacts with an insured for
14 reasons other than determining the insured's health status.

15 **SECTION 159.** ORS 744.367 is amended to read:

16 744.367. (1) A person may not enter into a life settlement contract at any time prior to the ap-
17 plication or issuance of a policy that is the subject of a life settlement contract or within a five-year
18 period commencing with the date of issuance of the insurance policy or certificate. However, this
19 five-year restriction does not apply if the owner certifies to the life settlement provider that any one
20 or more of the following conditions has been met within the five-year period:

21 (a) The policy was issued upon the owner's exercise of conversion rights arising out of a group
22 or individual policy if the total of the time covered under the conversion policy plus the time cov-
23 ered under the prior policy is at least 60 months. The time covered under a group policy is calcu-
24 lated without regard to any change in insurance carriers, provided the coverage has been
25 continuous and under the same group sponsorship;

26 (b) The owner submits independent evidence to the life settlement provider that one or more of
27 the following conditions have been met within the five-year period:

28 (A) The owner or insured is terminally ill or chronically ill;

29 (B) The owner's spouse dies;

30 (C) The owner divorces the owner's spouse;

31 (D) The owner retires from full-time employment;

32 (E) The owner becomes physically or mentally disabled and a physician, naturopathic physician
33 licensed under ORS chapter 685, [*physician assistant*] **physician associate** licensed under ORS
34 677.505 to 677.525 or nurse practitioner licensed under ORS 678.375 to 678.390 determines that the
35 disability prevents the owner from maintaining full-time employment; or

36 (F) A final order, judgment or decree is entered by a court of competent jurisdiction, on the
37 application of a creditor of the owner, adjudicating the owner bankrupt or insolvent, or approving
38 a petition seeking reorganization of the owner or appointing a receiver, trustee or liquidator to all
39 or a substantial part of the owner's assets; or

40 (c) The owner enters into a life settlement contract more than two years after the date of issu-
41 ance of a policy and, with respect to the policy, at all times prior to the date that is two years after
42 policy issuance, the following conditions are met:

43 (A) Policy premiums have been funded exclusively with unencumbered assets, including an in-
44 terest in the life insurance policy being financed only to the extent of its net cash surrender value,
45 provided by, or full recourse liability incurred by, the insured or a person closely related to the in-

1 sured by blood or law or a party having a lawful substantial economic interest in the continued life,
2 health and bodily safety of the person insured, or a trust established primarily for the benefit of such
3 parties;

4 (B) There is no agreement or understanding with any other person to guarantee any such li-
5 ability or to purchase or stand ready to purchase the policy, including through an assumption or
6 forgiveness of the loan; and

7 (C) Neither the insured nor the policy has been evaluated for settlement.

8 (2) Copies of the independent evidence described in subsection (1)(b) of this section and docu-
9 ments required by ORS 744.364 (1) must be submitted to the insurer when the life settlement pro-
10 vider or other party entering into a life settlement contract with an owner submits a request to the
11 insurer for verification of coverage. The copies must be accompanied by a letter of attestation from
12 the life settlement provider that the copies are true and correct copies of the documents received
13 by the life settlement provider.

14 (3) If the life settlement provider submits to the insurer a copy of the owner's or insured's cer-
15 tification described in and the documents required by ORS 744.364 (1) when the provider submits a
16 request to the insurer to effect the transfer of the policy or certificate to the life settlement pro-
17 vider, the copy conclusively establishes that the life settlement contract satisfies the requirements
18 of this section and the insurer shall respond in a timely manner to the request.

19 (4) An insurer may not, as a condition of responding to a request for verification of coverage
20 or effecting the transfer of a policy pursuant to a life settlement contract, require that the owner,
21 insured, life settlement provider or life settlement broker sign any forms, disclosures, consent or
22 waiver form that has not been expressly approved by the Director of the Department of Consumer
23 and Business Services for use in connection with life settlement contracts in this state.

24 (5) Upon receipt of a properly completed request for a change of ownership or beneficiary of a
25 policy, the insurer shall respond in writing within 30 calendar days with written acknowledgement
26 confirming that the change has been effected or specifying the reasons why the requested change
27 cannot be processed. The insurer may not unreasonably delay effecting change of ownership or
28 beneficiary and may not otherwise seek to interfere with any life settlement contract lawfully en-
29 tered into in this state.

44 (h) Attempting to settle claims for less than the amount to which a reasonable person would

2 (i) Attempting to settle claims on the basis of an application altered without notice to or consent
3 of the applicant;

4 (j) Failing, after payment of a claim, to inform insureds or beneficiaries, upon request by them,
5 of the coverage under which payment has been made;

6 (k) Delaying investigation or payment of claims by requiring a claimant or the claimant's phy-
7 sician, naturopathic physician, [*physician assistant*] **physician associate** or nurse practitioner to
8 submit a preliminary claim report and then requiring subsequent submission of loss forms when both
9 require essentially the same information;

10 (L) Failing to promptly settle claims under one coverage of a policy where liability has become
11 reasonably clear in order to influence settlements under other coverages of the policy;

12 (m) Failing to promptly provide the proper explanation of the basis relied on in the insurance
13 policy in relation to the facts or applicable law for the denial of a claim; or

14 (n) Any of the practices described in ORS 746.233.

15 (2) No insurer shall refuse, without just cause, to pay or settle claims arising under coverages
16 provided by its policies with such frequency as to indicate a general business practice in this state,
17 which general business practice is evidenced by:

18 (a) A substantial increase in the number of complaints against the insurer received by the De-
19 partment of Consumer and Business Services;

20 (b) A substantial increase in the number of lawsuits filed against the insurer or its insureds by
21 claimants; or

22 (c) Other relevant evidence.

23 **SECTION 161.** ORS 746.600 is amended to read:
24 746.600. As used in ORS 746.600 to 746.690:

25 (1)(a) "Adverse underwriting decision" means any of the following actions with respect to in-
26 surance transactions involving insurance coverage that is individually underwritten:

27 (A) A declination of insurance coverage.

29 (C) Failure of an insurance producer to apply for insurance coverage with a specific insurer that
30 the insurance producer represents and that is requested by an applicant.

45 (B) A declination of insurance coverage solely because the coverage is not available on a class

3 (2) "Affiliate of" a specified person or "person affiliated with" a specified person means a person
4 who directly, or indirectly, through one or more intermediaries, controls, or is controlled by, or is
5 under common control with, the person specified.

6 (3) "Applicant" means a person who seeks to contract for insurance coverage, other than a
7 person seeking group insurance coverage that is not individually underwritten.

8 (4) "Consumer" means an individual, or the personal representative of the individual, who seeks
9 to obtain, obtains or has obtained one or more insurance products or services from a licensee that
10 are to be used primarily for personal, family or household purposes, and about whom the licensee

12 (5) "Consumer report" means any written, oral or other communication of information bearing
13 on a natural person's creditworthiness, credit standing, credit capacity, character, general reputa-
14 tion, personal characteristics or mode of living that is used or expected to be used in connection

16 (6) "Consumer reporting agency" means a person that, for monetary fees or dues, or on a co-

20 (c) Furnishes consumer reports to other persons.

21 (7) "Control" means, and the terms "controlled by" or "under common control with" refer to,

24 than a commercial contract for goods or nonmanagement services, or otherwise, unless the power

29 (b) A health care provider that transmits any health information in electronic form to carry out

33 (9) "Credit history" means any written or other communication of any information by a con-
34 sumer reporting agency that:

37 eligibility, premiums or rates for personal insurance.

38 (10) "Customer" means a consumer who has a continuing relationship with a licensee under

41 (11) "Declination of insurance coverage" or "decline coverage" means a denial, in whole or in
42 part, by an insurer or insurance producer of an application for requested insurance coverage.
