Senate Bill 1580

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.**

Prohibits methadone clinic from commencing operation at site within 1,000 feet of pediatric clinic or public park.

A BILL FOR AN ACT 1 2 Relating to methadone clinics; creating new provisions; and amending ORS 430.590. Be It Enacted by the People of the State of Oregon: 3 SECTION 1. ORS 430.590 is amended to read: 4 430.590. (1) As used in this section: 5 6 (a) "Licensed child care facility" means a child care center certified under ORS 329A.280 7 that is operating under the authority of a valid business license. 8 (b) "Pediatric clinic" means a health clinic, defined by the Oregon Health Authority by rule, that specializes in providing pediatric physical health, dental or mental health services. 9 (c) "Within 1,000 feet" means a straight line measurement in a radius extending for 1,000 10 feet or less in every direction from any point on the boundary line of the real property. 11 12 [(1)] (2) It is unlawful for any person to commence operating a methadone clinic: 13(a) Within 1,000 feet of the real property comprising an existing public or private elementary, secondary or career school attended primarily by minors; 14 (b) Within 1,000 feet of the real property comprising an existing pediatric clinic; 15(c) Within 1,000 feet of the real property comprising an existing public park; or 16 17 [(b)] (d) Within 1,000 feet of the real property comprising an existing licensed child care facility. [As used in this section, "licensed child care facility" means a child care center certified under ORS 18 329A.280 that is operating under authority of a valid business license.] 19 20 [(2)] (3) Commencing operation of a methadone clinic within 1,000 feet of a school, [or] licensed 21child care facility, pediatric clinic or public park is a nuisance and operation of the methadone 22clinic shall be enjoined and abated as provided in ORS 105.550 to 105.600. 23[(3) For purposes of this section, "within 1,000 feet" means a straight line measurement in a radius 24 extending for 1,000 feet or less in every direction from any point on the boundary line of the real 25property comprising an existing public or private elementary, secondary or career school or an existing 26 licensed child care facility under this section.] 27SECTION 2. The amendments to ORS 430.590 by section 1 of this 2014 Act apply to 28 methadone clinics that begin providing doses of methadone to patients on or after the effective date of this 2014 Act. 2930
