(1) The State Marine Board shall submit two reports to the interim com-19 mittees of the Legislative Assembly related to natural resources, in the manner provided in 20 ORS 192.245, on the implementation of sections 2 to 7 of this 2019 Act and the amendments 21to ORS 830.110, 830.565, 830.570, 830.575 and 830.990 by sections 10 to 14 of this 2019 Act. Each 22report must include the following: 23 "(a) An overview of the rules adopted by the board; 24 "(b) A description of the board's educational outreach efforts; 25"(c) Information about the number of waterway access permits issued; "(d) Information about the number of citations and warnings issued for violation of sec-2627tion 5 of this 2019 Act; and 28"(e) A description of the revenue and expenses related to the issuance of waterway ac-29cess permits. "(2) The first report must be submitted no later than September 15, 2020. 30 31 "(3) The second report must be submitted no later than September 15, 2021. "SECTION 17. Section 16 of this 2019 Act is repealed on January 2, 2022. 32 "SECTION 18. (1) Sections 2 to 9 of this 2019 Act and the amendments to ORS 830.110, 33 830.565, 830.570 and 830.575 by sections 10 and 12 to 14 of this 2019 Act become operative on 34 35 January 1, 2020.

1 "(2) The amendments to ORS 830.990 by section 11 of this 2019 Act become operative on 2 August 1, 2020.

"(3) The State Marine Board may take any action before the operative date specified in subsection (1) of this section that is necessary to enable the board to exercise, on and after the operative date specified in subsection (1) of this section, all the duties, functions and powers conferred on the board by sections 2 to 9 of this 2019 Act and the amendments to ORS 830.110, 830.565, 830.570 and 830.575 by sections 10 and 12 to 14 of this 2019 Act.".
