## AN ACT

7	Section 1. Title 61 of the Pennsylvania Consolidated

9	§ 5908. Information on health care screenings for incarcerated

11	(a) Reports The correctional institution shall annually
12	submit a report on health care screenings for incarcerated
13	individuals to all of the following:

- 2 (b) Contents. -- The report under subsection (a) shall include
- 3 all of the following information:
- 4 (1) The correctional institution's response time to DC-
- 5 500, Sick Call Requests.
- 6 (2) The number of DC-500, Sick Call Requests.
- 7 (3) The number of incarcerated individuals who opt out
- 8 <u>of receiving health care screenings or health care services.</u>
- 9 <u>(4) The number of emergency services used in each</u>
- 10 <u>correctional institution.</u>
- 11 (5) The number of specialty off-site health care
- 12 <u>services used by incarcerated individuals.</u>
- 13 (6) The total number of incarcerated women and girls who
- have received health care screenings.
- 15 (7) The total number of pregnant incarcerated women and
- 16 girls who have received health care screenings.
- 17 (8) The total number of live births and stillbirths by
- incarcerated women and girls.
- 19 (9) The total number and type of maternal complications.
- 20 (10) The number of specialty on-site health care
- 21 services used by incarcerated individuals.
- 22 (c) Guidelines. -- The correctional institution shall provide
- 23 all incarcerated individuals with comprehensive written
- 24 guidelines regarding the correctional institution's health care
- 25 screening procedures and information on preventative screenings.
- 26 The following apply:
- 27 (1) The guidelines used by the correctional institution
- should follow national guidelines, such as those used by
- 29 insurance companies, that include information on the
- 30 recommended preventative screening guidelines based on age

- 1 <u>and gender.</u>
- 2 (2) The correctional institution shall also provide all
- 3 <u>incarcerated individuals with updated guidelines under this</u>
- 4 <u>subsection as the correctional institution deems necessary to</u>
- 5 <u>keep the incarcerated individuals informed.</u>
- 6 Section 2. This act shall take effect in 60 days.
