AN ACT

Amending the act of March 4, 1971 (P.L.6, No.2), entitled "An act relating to tax reform and State taxation by codifying 2 and enumerating certain subjects of taxation and imposing 3 taxes thereon; providing procedures for the payment, 4 collection, administration and enforcement thereof; providing 5 for tax credits in certain cases; conferring powers and 6 imposing duties upon the Department of Revenue, certain employers, fiduciaries, individuals, persons, corporations 8 and other entities; prescribing crimes, offenses and 9 penalties," in personal income tax, further providing for 10 classes of income. 11 12 The General Assembly of the Commonwealth of Pennsylvania 13 hereby enacts as follows: 14 Section 1. Section 303 of the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, is amended by 15 16 adding a subsection to read: 17 Section 303. Classes of Income. --* * * 18 (a.9) The following shall apply: 19 (1) When calculating taxable income on the annual personal 20 income tax return, a taxpayer may deduct an amount not to exceed ten thousand dollars (\$10,000) if, while living, the taxpayer or 21

- 1 the taxpayer's dependent donates one or more of his or her human
- 2 organs to another human being for human organ transplantation
- 3 and incurs any of the following unreimbursed expenses which are
- 4 <u>related to the organ donation:</u>
- 5 (i) Travel expenses.
- 6 (ii) Lodging expenses.
- 7 <u>(iii) Lost wages.</u>
- 8 <u>(iv) Medical expenses.</u>
- 9 (2) Subject to the restriction under paragraph (1), the
- 10 taxpayer may only deduct an amount equal to the unreimbursed
- 11 expenses incurred by the taxpayer under paragraph (1). The
- 12 <u>deduction may not result in taxable income being less than zero.</u>
- 13 (3) A deduction under this subsection may only be claimed in
- 14 the taxable year in which the human organ transplantation
- 15 occurred. A taxpayer may claim the deduction under this
- 16 <u>subsection only one time during the taxpayer's lifetime.</u>
- 17 (4) As used in this subsection, the term "human organ" means
- 18 all or part of a liver, pancreas, kidney, intestine, lung or
- 19 bone marrow.

- 21 Section 2. The addition of section 303(a.9) of the act shall
- 22 apply to tax years beginning after December 31, 2015.
- 23 Section 3. This act shall take effect immediately.
