AN ACT

1	Amending the act of May 19, 1995 (P.L.4, No.2), entitled "An act
2	providing for the recycling of existing industrial and
3 4	commercial sites; further defining the cleanup liability of new industries and tenants; establishing a framework for
5	setting environmental remediation standards; establishing the
6	Voluntary Cleanup Loan Fund, the Industrial Land Recycling
7	Fund and the Industrial Sites Cleanup Fund to aid industrial
8	site cleanups; assigning powers and duties to the
9	Environmental Quality Board and the Department of
10	Environmental Resources; and making repeals," in
11 12	miscellaneous provisions, further providing for permits and other requirements.
13	The General Assembly of the Commonwealth of Pennsylvania
14	hereby enacts as follows:
15	Section 1. Section 902 of the act of May 19, 1995 (P.L.4,
16	No.2), known as the Land Recycling and Environmental Remediation
17	Standards Act, is amended by adding a subsection to read:
18	Section 902. Permits and other requirements.

20	(c) Consolidated standards permit A person conducting
21	remediation activities under this act may obtain a consolidated

- 2 <u>under this act is not required to obtain a permit, license, plan</u>
- 3 approval or other approval in connection with the activity under
- 4 the act of June 22, 1937 (P.L.1987, No.394), known as The Clean
- 5 Streams Law, the act of January 8, 1960 (1959 P.L.2119, No.787),
- 6 known as the Air Pollution Control Act, the act of July 7, 1980
- 7 (P.L.380, No.97), known as the Solid Waste Management Act, the
- 8 <u>act of July 13, 1988 (P.L.525, No.93), referred to as the</u>
- 9 <u>Infectious and Chemotherapeutic Waste Law, or the act of July 6,</u>
- 10 1989 (P.L.169, No.32), known as the Storage Tank and Spill
- 11 Prevention Act. A person who obtains a consolidated standards
- 12 permit under this subsection is deemed to be in compliance with
- 13 the requirement to obtain a permit, license, plan approval or
- 14 other approval in connection with the activity under the
- 15 applicable provisions of those acts and regulations. The
- 16 <u>department shall grant or deny a consolidated standards permit</u>
- 17 within 120 calendar days from its receipt of an application.
- 18 Section 2. This act shall take effect in 60 days.
