1 Service of petition for the appointment of viewers and (b) 2 order appointing viewers. -- The petitioners shall promptly send to all other parties by [registered] certified mail, return 3 receipt requested, a certified true copy of the petition for the 4 appointment of viewers and a copy of the court order appointing 5 the viewers if an order has been entered. A copy of the petition 6 7 and order, if entered, shall also be mailed to all mortgagees 8 and other lienholders of record.

9 (c) Notice of views and hearings.--The viewers shall give 10 notice of the time and place of all views and hearings. The 11 notice shall be given to all parties by not less than 30 days 12 written notice by [registered] <u>certified</u> mail, return receipt 13 requested.

15 § 505. Service of notice of view and hearing.

(a) General rule.--Notice of the view and hearing shall be served, within or without this Commonwealth, by any competent adult in the same manner as a civil action or by [registered] <u>certified</u> mail, return receipt requested, to the last known address of the condemnee and condemnor.
