AN ACT

- Amending the act of April 9, 1929 (P.L.177, No.175), entitled 1 "An act providing for and reorganizing the conduct of the 2 executive and administrative work of the Commonwealth by the 3 Executive Department thereof and the administrative departments, boards, commissions, and officers thereof, including the boards of trustees of State Normal Schools, or 5 6 Teachers Colleges; abolishing, creating, reorganizing or 7 authorizing the reorganization of certain administrative 8 9 departments, boards, and commissions; defining the powers and duties of the Governor and other executive and administrative 10 officers, and of the several administrative departments, 11 boards, commissions, and officers; fixing the salaries of the 12 Governor, Lieutenant Governor, and certain other executive 13 and administrative officers; providing for the appointment of 14 certain administrative officers, and of all deputies and 15 other assistants and employes in certain departments, boards, 16 and commissions; providing for judicial administration; and 17 prescribing the manner in which the number and compensation 18 19 of the deputies and all other assistants and employes of certain departments, boards and commissions shall be 20 determined," in Commonwealth budget procedures, further 21 providing for lapsing of funds. 22 23 The General Assembly of the Commonwealth of Pennsylvania 24 hereby enacts as follows: 25 Section 1. Section 621(m) of the act of April 9, 1929 26 (P.L.177, No.175), known as The Administrative Code of 1929, is
- 27 amended to read:

- 1 Section 621. Lapsing of Funds. --* * *
- 2 (m) The Secretary of the Budget [shall have the power to
- 3 waive any of the provisions included in section 621] <u>may waive</u>
- 4 <u>subsections (c), (d), (e), (f), (h), (i), (j) and (l)</u> upon
- 5 written request of an agency justifying an exception to these
- 6 provisions which is [in the best interests of the Commonwealth.]
- 7 <u>necessary for the prudent management of the Commonwealth's</u>
- 8 <u>budget in accordance with the following:</u>
- 9 (1) When the Secretary of the Budget decides to approve an
- 10 agency request for a waiver of these provisions, he shall submit
- 11 the agency request along with his own written analysis and
- 12 justification for the waiver of these provisions to the
- 13 respective Chairmen of the Majority and Minority Appropriations
- 14 Committees in the House of Representatives and the Senate
- 15 allowing a reasonable time for their review and comment. The
- 16 <u>Secretary of the Budget shall also submit the written analysis</u>
- 17 and justification to the Independent Fiscal Office and members
- 18 of the General Assembly.
- 19 (2) The submission under paragraph (1) shall include all of
- 20 the following:
- 21 (i) The specific amount, appropriation and fiscal year that
- 22 the money was appropriated which is the subject of the waiver.
- 23 (ii) The provision of this section requested to be waived.
- 24 (iii) A description of the purpose of the waiver and how
- 25 granting the waiver is necessary for the prudent management of
- 26 the Commonwealth's budget.
- 27 <u>(iv) The contract number or other identifying information</u>
- 28 for a contract submitted under Chapter 17 of the act of February
- 29 14, 2008 (P.L.6, No.3), known as the "Right-to-Know Law," if
- 30 applicable.

- 1 (3) Amounts subject to a waiver under this subsection may
- 2 not be used for the creation of a new or expanded program or
- 3 initiative.
- 4 (4) A waiver under this subsection shall expire on the first
- 5 day of the fiscal year following the year in which the waiver
- 6 was granted.
- 7 (5) No waiver may be granted for amounts appropriated prior
- 8 to the two fiscal years preceding the fiscal year in which the
- 9 <u>waiver is requested.</u>
- 10 Section 2. The amendment of section 621(m) of the act shall
- 11 apply to waivers approved on or after the effective date of this
- 12 section.
- 13 Section 3. This act shall take effect immediately.
