AN ACT

1 Making appropriations from the Pennsylvania Race Horse
2 Development Restricted Receipts Account to the Department of
3 Agriculture for the fiscal year beginning July 1, 2019, and
4 for the payment of bills incurred and remaining unpaid at the
5 close of the fiscal year ending June 30, 2020.

6 The General Assembly of the Commonwealth of Pennsylvania

9 PRELIMINARY PROVISIONS

10 Section 101. Short title.

11 This act shall be known and may be cited as the Appropriation
12 Act of 2019 - Pennsylvania Race Horse Development Restricted
13 Receipts Account.

18 Section 301. Appropriations from Pennsylvania Race Horse

1 necessary, are hereby appropriated from the Pennsylvania Race
2 Horse Development Restricted Receipts Account to the Department
3 of Agriculture for the purposes specified in this part for the
4 fiscal year beginning July 1, 2019, and for the payment of bills
5 incurred and remaining unpaid at the close of the fiscal year
6 ending June 30, 2020.
