- 11 (b) Availability. -- Publications under subsection (a) shall
- 12 be available on an Internet website maintained by the commission
- 13 in a secure format accessible to the public and shall be updated
- 14 within 60 days of the enactment of any amendment.
- 15 Section 2. Section 2.1 of the act of May 29, 1935 (P.L.244,
- 16 No.102), referred to as the Local Government Commission Law, is
