15	Section 1. Section 632 of the act of May 17, 1921 (P.L.682,
16	No.284), known as The Insurance Company Law of 1921, is amended

18	Section 632. Coverage for Mammographic Examinations <u>(a)</u>
19	All group or individual health or sickness or accident insurance
20	policies providing hospital or medical/surgical coverage and all
21	group or individual subscriber contracts or certificates issued

by any entity subject to 40 Pa.C.S. Ch. 61 (relating to hospital 1 2 plan corporations) or 63 (relating to professional health 3 services plan corporations), this act, the act of December 29, 1972 (P.L.1701, No.364), known as the "Health Maintenance 4 Organization Act," [the act of July 29, 1977 (P.L.105, No.38), 5 known as the "Fraternal Benefit Society Code,"] or an employe 6 7 welfare benefit plan as defined in section 3 of the Employee 8 Retirement Income Security Act of 1974 (Public Law 93-406, 29 9 U.S.C. § 1001 et seq.) providing hospital or medical/surgical 10 coverage shall also provide coverage for mammographic 11 examinations. The minimum coverage required shall include all 12 costs associated with a mammogram every year for women 40 years 13 of age or older and with any mammogram based on a physician's 14 recommendation for women under 40 years of age[.], including ultrasound screening, magnetic resonance imaging or other 15 16 supplemental screening if a mammogram demonstrates heterogeneous or dense breast tissue based on the Breast Imaging Reporting and 17 18 Data System established by the American College of Radiology or 19 if a woman is believed to be at increased risk for breast cancer 20 due to family history or prior personal history of breast cancer, positive genetic testing or other indications as deemed 21 medically necessary by a physician. Prior to payment for a 22 23 screening mammogram, insurers shall verify that the screening 24 mammography service provider is properly licensed by the department in accordance with the act of July 9, 1992 (P.L.449, 25 No.93), known as the "Mammography Quality Assurance Act." 26 Nothing in this section shall be construed to require an insurer 27 28 to cover the surgical procedure known as mastectomy or to 29 prevent application of deductible or copayment provisions 30 contained in the policy or plan.
