## AN ACT

- 1 Providing for the Pennsylvania Business Permitting Portal within
- the Department of Community and Economic Development; and
- 3 establishing the Pennsylvania Business Permitting Portal
- 4 Advisory Board.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Short title.
- 8 This act shall be known and may be cited as the Pennsylvania
- 9 Business Permitting Portal Act.
- 10 Section 2. Legislative intent.
- 11 The General Assembly recognizes the following public policy
- 12 purposes and declares the following objectives of the
- 13 Commonwealth are to be served by this act:
- 14 (1) To provide one-stop services to assist businesses in
- identifying and securing appropriate permits, licenses,
- 16 certifications, applications, forms and registrations needed
- 17 to establish and operate a business in this Commonwealth.
- 18 (2) To establish the Pennsylvania Business Permitting

- 1 Portal to provide an electronic single access point to aid
- 2 existing and potential business owners in completing the
- 3 various business registration forms and permit applications
- 4 required to establish and operate a business in this
- 5 Commonwealth.
- 6 (3) To provide for the compilation of a comprehensive
- 7 listing of all permits required by Commonwealth agencies and
- 8 categorize the required permits into a format that is readily
- 9 available to business owners.
- 10 (4) To promote efficient dialogue between permit
- applicants and the Commonwealth agency responsible for the
- 12 review of permit applications.
- 13 Section 3. Definitions.
- 14 The following words and phrases when used in this act shall
- 15 have the meanings given to them in this section unless the
- 16 context clearly indicates otherwise:
- 17 "Board." The Pennsylvania Business Permitting Portal
- 18 Advisory Board established under section 8.
- "Commonwealth agencies." Any office, department, authority,
- 20 board or commission of the Executive Department of the
- 21 Commonwealth.
- "Department." The Department of Community and Economic
- 23 Development of the Commonwealth.
- "Individual business account." A secure online account
- 25 maintained by the Department of Community and Economic
- 26 Development to store individualized information relating to a
- 27 business's activities through the permitting portal.
- 28 "Local permitting authorities." Any municipality or
- 29 municipal authority which has the authority to issue a permit.
- 30 "Permit." The whole, part or the renewal of any permit,

- 1 certificate, license, approval, registration, charter or any
- 2 other form of permission issued by a Commonwealth agency to
- 3 allow for the operation of a business in this Commonwealth.
- 4 "Permit application." Any request to a Commonwealth agency
- 5 which is necessary to obtain a permit.
- 6 "Permitting portal." The Pennsylvania Business Permitting
- 7 Portal established under section 4.
- 8 "Secretary." The Secretary of Community and Economic
- 9 Development.
- 10 Section 4. Establishment of the Pennsylvania Business
- 11 Permitting Portal.
- 12 (a) Establishment. -- The department shall establish the
- 13 Pennsylvania Business Permitting Portal to provide a single
- 14 online access point to aid existing and potential business
- 15 owners in completing the necessary permit applications
- 16 associated with establishing and operating a business in this
- 17 Commonwealth.
- 18 (b) Permitting portal functions. -- The permitting portal
- 19 shall, at a minimum, allow for the following:
- 20 (1) The creation of an individual business account to
- 21 store general information on the business, which will be used
- 22 to automatically fill in recurring fields on a permit
- 23 application.
- 24 (2) The electronic submission of a permit application.
- 25 (3) The electronic submission of permit fees or fines.
- 26 (4) The tracking of status of payments from Commonwealth
- 27 agencies to contractors.
- 28 (5) The tracking of pending permit applications.
- 29 (6) The recording of electronic signatures.
- 30 (7) Access to customized, agency-created to-do

- 1 checklists specific to the individual business account.
- 2 (8) Online interaction with the department to resolve
- 3 difficulties with the permitting portal.
- 4 (9) Online interaction with Commonwealth agencies to resolve questions relating to permit applications.
- 6 (10) The protection of the confidentiality of all information submitted through the permitting portal.
- 8 (11) The recording of backup records of all activities,
  9 including time-stamp information on the submission of permit
  10 applications.
- 11 (12) The listing of information relating to local permit
  12 application information for relevant local permitting
  13 authorities.
- 14 Section 5. Cooperation between the department and Commonwealth agencies.
- 16 (a) Permit identification.—The department shall coordinate 17 with the Commonwealth agencies to identify permits that are:
- 18 (1) Appropriate for inclusion in the permitting portal.
- 19 (2) Compatible with or that may be made compatible with 20 the permitting portal.
- 21 (b) Cooperation.--The department and Commonwealth agencies
- 22 shall cooperate in good faith to integrate the maximum number of
- 23 permits into the permitting portal.
- 24 Section 6. Preservation of Commonwealth agency authority.
- 25 (a) Existing regulatory authority.--This act shall not
- 26 supersede any regulatory authority granted to any Commonwealth
- 27 agency.
- 28 (b) Existing permit authority.--A Commonwealth agency listed
- 29 on the department's portal shall maintain final authority to do
- 30 the following:

- 1 (1) Determine the permits appropriate for inclusion on
- 2 the permitting portal.
- 3 (2) Approve or deny permits according to applicable law.
- 4 (3) Determine the requirements for submission and
- 5 payment of permit application fees and fines.
- 6 Section 7. Liability.
- 7 This act shall not impose any liability on the department
- 8 resulting from the operation of the permitting portal.
- 9 Section 8. Pennsylvania Business Permitting Portal Advisory
- 10 Board.
- 11 (a) Establishment. -- There is established within the
- 12 department an advisory board known as the Pennsylvania Business
- 13 Permitting Portal Advisory Board.
- 14 (b) Duties.--The board shall advise the department on ways
- 15 to ensure that the permitting portal system is operated in an
- 16 effective and user-friendly manner for existing and potential
- 17 business owners.
- 18 (c) Membership. -- The board shall consist of seven members as
- 19 follows:
- 20 (1) The Secretary of Community and Economic Development
- 21 or his designee.
- 22 (2) One member appointed by the President pro tempore of
- the Senate.
- 24 (3) One member appointed by the Minority Leader of the
- 25 Senate.
- 26 (4) One member appointed by the Speaker of the House of
- 27 Representatives.
- 28 (5) One member appointed by the Minority Leader of the
- 29 House of Representatives.
- 30 (6) One member appointed by the Governor representing

- 1 small business.
- 2 (7) One member appointed by the Governor representing
- 3 business or industry.
- 4 (d) Chairperson. -- The secretary or his designee shall serve
- 5 as the chairperson. The board may elect additional officers as
- 6 it deems necessary.
- 7 (e) Terms.--Members shall serve without compensation at the
- 8 pleasure of the respective appointing authority, but shall be
- 9 reimbursed for expenses.
- 10 Section 9. Effective date.
- 11 This act shall take effect in 60 days.
