AN ACT

- Providing for the Pennsylvania Business Permitting Portal within
 the Department of Community and Economic Development; and
 establishing the Pennsylvania Business Permitting Portal
 Advisory Board.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Short title.
- 8 This act shall be known and may be cited as the Pennsylvania
- 9 Business Permitting Portal Act.
- 10 Section 2. Legislative intent.
- 11 The General Assembly recognizes the following public policy
- 12 purposes and declares the following objectives of the
- 13 Commonwealth are to be served by this act:
- 14 (1) To provide one-stop services to assist businesses in
- 15 identifying and securing appropriate permits, licenses,
- 16 certifications, applications, forms and registrations needed
- 17 to establish and operate a business in this Commonwealth.

- 1 (2) To establish the Pennsylvania Business Permitting
- 2 Portal to provide an electronic single access point to aid
- 3 existing and potential business owners in completing the
- 4 various business registration forms and permit applications
- 5 required to establish and operate a business in this
- 6 Commonwealth.
- 7 (3) To provide for the compilation of a comprehensive
- 8 listing of all permits required by Commonwealth agencies and
- 9 categorize the required permits into a format that is readily
- 10 available to business owners.
- 11 (4) To promote efficient dialogue between permit
- 12 applicants and the Commonwealth agency responsible for the
- 13 review of permit applications.
- 14 Section 3. Definitions.
- The following words and phrases when used in this act shall
- 16 have the meanings given to them in this section unless the
- 17 context clearly indicates otherwise:
- 18 "Board." The Pennsylvania Business Permitting Portal
- 19 Advisory Board established under section 8.
- "Commonwealth agencies." Any office, department, authority,

- 21 board or commission of the Executive Department of the
- 22 Commonwealth.
- "Department." The Department of Community and Economic
- 24 Development of the Commonwealth.
- "Individual business account." A secure online account
- 26 maintained by the Department of Community and Economic
- 27 Development to store individualized information relating to a
- 28 business's activities through the permitting portal.
- "Local permitting authorities." Any municipality or
- 30 municipal authority which has the authority to issue a permit.

- 1 "Permit." The whole, part or the renewal of any permit,
- 2 certificate, license, approval, registration, charter or any
- 3 other form of permission issued by a Commonwealth agency to
- 4 allow for the operation of a business in this Commonwealth.
- 5 "Permit application." Any request to a Commonwealth agency
- 6 which is necessary to obtain a permit.
- 7 "Permitting portal." The Pennsylvania Business Permitting
- 8 Portal established under section 4.
- 9 "Secretary." The Secretary of Community and Economic
- 10 Development.
- 11 Section 4. Establishment of the Pennsylvania Business
- 12 Permitting Portal.
- 13 (a) Establishment.--The department shall establish the
- 14 Pennsylvania Business Permitting Portal to provide a single
- 15 online access point to aid existing and potential business
- 16 owners in completing the necessary permit applications
- 17 associated with establishing and operating a business in this
- 18 Commonwealth.
- 19 (b) Permitting portal functions. -- The permitting portal
- 20 shall, at a minimum, allow for the following:
- 21 (1) The creation of an individual business account to
- store general information on the business, which will be used
- 23 to automatically fill in recurring fields on a permit
- 24 application.
- 25 (2) The electronic submission of a permit application.
- 26 (3) The electronic submission of permit fees or fines.
- 27 (4) The tracking of status of payments from Commonwealth
- 28 agencies to contractors.
- 29 (5) The tracking of pending permit applications.
- 30 (6) The recording of electronic signatures.

- 1 (7) Access to customized, agency-created to-do
- 2 checklists specific to the individual business account.
- 3 (8) Online interaction with the department to resolve
- 4 difficulties with the permitting portal.
- 5 (9) Online interaction with Commonwealth agencies to
- 6 resolve questions relating to permit applications.
- 7 (10) The protection of the confidentiality of all
- 8 information submitted through the permitting portal.
- 9 (11) The recording of backup records of all activities,
- 10 including time-stamp information on the submission of permit
- 11 applications.
- 12 (12) The listing of information relating to local permit
- application information for relevant local permitting
- 14 authorities.
- 15 Section 5. Cooperation between the department and Commonwealth
- 16 agencies.
- 17 (a) Permit identification. -- The department shall coordinate
- 18 with the Commonwealth agencies to identify permits that are:
- 19 (1) Appropriate for inclusion in the permitting portal.
- 20 (2) Compatible with or that may be made compatible with
- 21 the permitting portal.
- 22 (b) Cooperation. -- The department and Commonwealth agencies
- 23 shall cooperate in good faith to integrate the maximum number of
- 24 permits into the permitting portal.
- 25 Section 6. Preservation of Commonwealth agency authority.
- 26 (a) Existing regulatory authority. -- This act shall not
- 27 supersede any regulatory authority granted to any Commonwealth
- 28 agency.
- 29 (b) Existing permit authority. -- A Commonwealth agency listed
- 30 on the department's portal shall maintain final authority to do

- 1 the following:
- 2 (1) Determine the permits appropriate for inclusion on
- 3 the permitting portal.
- 4 (2) Approve or deny permits according to applicable law.
- 5 (3) Determine the requirements for submission and
- 6 payment of permit application fees and fines.
- 7 Section 7. Liability.
- 8 This act shall not impose any liability on the department
- 9 resulting from the operation of the permitting portal.
- 10 Section 8. Pennsylvania Business Permitting Portal Advisory
- 11 Board.
- 12 (a) Establishment. There is established within the
- 13 department an advisory board known as the Pennsylvania Business
- 14 Permitting Portal Advisory Board.
- 15 (b) Duties. The board shall advise the department on ways
- 16 to ensure that the permitting portal system is operated in an
- 17 effective and user-friendly manner for existing and potential
- 18 business owners.
- 19 (c) Membership. The board shall consist of seven members as
- 20 follows:
- 21 (1) The Secretary of Community and Economic Development
- 22 or his designee.
- 23 (2) One member appointed by the President pro tempore of
- 24 the Senate.
- 25 (3) One member appointed by the Minority Leader of the
- 26 Senate.
- 27 (4) One member appointed by the Speaker of the House of
- 28 Representatives.
- 29 (5) One member appointed by the Minority Leader of the
- 30 House of Representatives.

1	(6) One member appointed by the Governor representing	
2	small business.	
3	(7) One member appointed by the Governor representing	
4	business or industry.	
5	(d) Chairperson. The secretary or his designee shall serve	
6	as the chairperson. The board may elect additional officers as	
7	it deems necessary.	
8	(e) Terms. Members shall serve without compensation at the	
9	pleasure of the respective appointing authority, but shall be	
10	reimbursed for expenses.	
11	Section 9 8. Effective date.	<-
12	This act shall take effect in 60 days IMMEDIATELY.	<-
