Amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in burglary and other criminal 2 intrusion, further providing for the offense of criminal 3 4 trespass. 5 The General Assembly of the Commonwealth of Pennsylvania 6 hereby enacts as follows: 7 Section 1. Section 3503(d) of Title 18 of the Pennsylvania Consolidated Statutes is amended and the section is amended by 8 adding a subsection to read: § 3503. Criminal trespass. 10 * * * 11 12 (b.4) Evaluation for gambling disorder .--13 (1) Upon conviction or admission to Accelerated 14 Rehabilitative Disposition or other pretrial diversion 15 program of a person for an offense committed under subsection 16 (b), where the person's name is included on a self-exclusion 17 list and the offense was committed at a licensed facility or 18 a video gaming area, the court may direct that the person be 19 evaluated in a manner deemed appropriate by the court to

- 2 <u>(i) if the person has a gambling disorder;</u> and
- 3 (ii) whether there is a need for counseling or
- 4 <u>treatment as part of the sentence or preadjudication</u>
- 5 <u>disposition.</u>
- 6 (2) The evaluation shall be conducted by a single county <--
- 7 <u>authority for drug and alcohol or its designee CLINICIAN</u>
- 8 APPOINTED BY THE COURT and shall include recommendations for
- 9 <u>levels of care, continuing care and monitoring.</u>

- 11 (d) [Definition] Definitions. -- As used in this section, the
- 12 [term "school grounds" means any] <u>following words and phrases</u>
- 13 <u>shall have the meanings given to them in this subsection:</u>
- "Establishment licensee." As defined in 4 Pa.C.S. § 3102
- 15 (relating to definitions).
- 16 <u>"Evaluation." An assessment performed by a clinician who</u>
- 17 meets the minimum qualifications prescribed by the Department of
- 18 Drug and Alcohol Programs for the provision of gambling disorder
- 19 counseling.
- "Licensed facility." As defined in 4 Pa.C.S. § 1103
- 21 (relating to definitions).
- 22 "Licensed gaming entity." As defined in 4 Pa.C.S. § 1103.
- 23 "School grounds." Any building of or grounds of any
- 24 elementary or secondary publicly funded educational institution,
- 25 any elementary or secondary private school licensed by the
- 26 Department of Education, any elementary or secondary parochial
- 27 school, any certified day-care center or any licensed preschool
- 28 program.
- 29 "Self-exclusion list." The lists established and maintained
- 30 by the Pennsylvania Gaming Control Board under 4 Pa.C.S. §§ 1516

- 1 <u>(relating to list of persons self excluded from gaming</u>
- 2 <u>activities</u>) and 3903 (relating to self-exclusion) or self-
- 3 exclusion lists maintained by a licensed gaming entity which
- 4 meets the minimum criteria stated in 4 Pa.C.S. § 1516 or by an
- 5 <u>establishment licensee which meets the minimum criteria stated</u>
- 6 <u>in 4 Pa.C.S. § 3903.</u>
- 7 "Video gaming area." As defined in 4 Pa.C.S. § 3102.
- 8 Section 2. This act shall take effect in 60 days.
