## A SUPPLEMENT

- To the act of December 8, 1982 (P.L.848, No.235), entitled "An act providing for the adoption of capital projects related to the repair, rehabilitation or replacement of highway bridges to be financed from current revenue or by the incurring of debt and capital projects related to highway and safety improvement projects to be financed from current revenue of the Motor License Fund," itemizing additional State and local bridge projects.
- 9 The General Assembly of the Commonwealth of Pennsylvania
- 10 hereby enacts as follows:
- 11 Section 1. Short title.
- 12 This act shall be known and may be cited as the Highway-
- 13 Railroad and Highway Bridge Capital Budget Supplemental Act for
- 14 2019-2020.
- 15 Section 2. Definitions.
- 16 The following words and phrases when used in this act shall
- 17 have the meanings given to them in this section unless the
- 18 context clearly indicates otherwise:
- 19 "Account." The Highway Bridge Improvement Restricted Account
- 20 within the Motor License Fund.

- 1 "Capital project." A capital project as defined in section
- 2 302 of the act of February 9, 1999 (P.L.1, No.1), known as the
- 3 Capital Facilities Debt Enabling Act, and shall include a county
- 4 or municipal bridge rehabilitation, replacement or improvement
- 5 project as set forth in this act.
- 6 "Department." The Department of Transportation of the
- 7 Commonwealth.
- 8 "Secretary." The Secretary of Transportation of the
- 9 Commonwealth.
- 10 Section 3. Total authorization for bridge projects.
- 11 (a) Total projects. -- The total authorization for the costs
- 12 of the projects itemized pursuant to this act and to be financed
- 13 from current revenue or by the incurring of debt shall be
- 14 \$000,000,000.
- 15 (b) State projects. -- The authorization for capital projects
- 16 in the category of highway bridge projects and forestry and
- 17 State park bridge projects to be constructed by the Department
- 18 of Transportation or the Department of Conservation and Natural
- 19 Resources, or their successors or assigns, and to be financed by
- 20 the incurring of debt or from current revenue, itemized in this
- 21 act under the category of State bridges, shall be \$000,000,000.
- 22 (c) Non-State projects. -- The authorization for non-State
- 23 highway bridge projects to be constructed by municipalities and
- 24 to be financed in part with grants not exceeding 80% of the non-
- 25 Federal share of the costs made to the local government
- 26 municipalities by the department from current revenues itemized
- 27 in this act under the category of local bridges, shall be
- 28 \$000,000,000.
- 29 Section 4. Itemization of bridge projects.
- The individual capital projects in the category of highway

- 1 projects to be constructed by the Department of Transportation,
- 2 its successors or assigns, and to be financed from current
- 3 revenue or by the incurring of debt are hereby itemized,
- 4 together with their estimated financial costs, in the following

- 29 Section 73. Limitation on expenditure of funds.
- The following shall apply: 30

- 1 (1) Any money derived from the incurring of debt shall
- 2 be used solely for effecting the rehabilitation, replacement
- 3 or removal of bridges located on State highways. All other
- 4 bridge rehabilitation, replacement or removal shall be
- 5 financed from current revenue.
- 6 (2) Notwithstanding any law to the contrary, the
- 7 projects itemized in the act of December 8, 1982 (P.L.848,
- 8 No.235), known as the Highway-Railroad and Highway Bridge
- 9 Capital Budget Act for 1982-1983, may be financed from
- 10 current revenue.
- 11 Section 74. Debt authorization.
- 12 The Governor, Auditor General and State Treasurer are hereby
- 13 authorized and directed to borrow from time to time, in addition
- 14 to any authorization heretofore or hereafter enacted, on the
- 15 credit of the Commonwealth, subject to the limitations provided
- 16 in the current capital budget, money not exceeding in the
- 17 aggregate the sum of \$000,000,000 as may be found necessary to
- 18 carry out the acquisition and construction of the State projects
- 19 specifically itemized in this act.
- 20 Section 75. Issue of bonds.
- 21 The indebtedness authorized in this act shall be incurred
- 22 from time to time and shall be evidenced by one or more series
- 23 of general obligation bonds of the Commonwealth in such
- 24 aggregate principal amount for each series as the Governor,
- 25 Auditor General and State Treasurer shall determine, but the
- 26 latest stated maturity date shall not exceed 30 years from the
- 27 date of the bond first issued for each series.
- 28 Section 76. Estimated useful life of projects.
- 29 The General Assembly states the estimated useful life of the
- 30 projects itemized in this act as 30 years.

- 1 Section 77. Appropriation.
- 2 The net proceeds of the sale of the obligations authorized in
- 3 this act are hereby appropriated from the Capital Facilities
- 4 Fund to the department in the maximum amount of \$000,000,000 to
- 5 be used by it exclusively to defray the financial costs of the
- 6 State projects specifically itemized in this capital budget.
- 7 After reserving or paying the expenses of the sale of the
- 8 obligation, the State Treasurer shall pay out to the department
- 9 the money as required and certified by it to be legally due and
- 10 payable.
- 11 Section 78. Federal funds.
- 12 In addition to those funds appropriated in section 77, all
- 13 money received from the Federal Government for the public
- 14 improvement projects specifically itemized in this act is also
- 15 hereby appropriated for those projects.
- 16 Section 79. Allocation of funds.
- 17 (a) General rule. -- Whenever the department or the Department
- 18 of Conservation and Natural Resources determines that the full
- 19 estimated financial costs of the projects itemized in this act
- 20 are not necessary for the proper design, acquisition or
- 21 construction of such projects, the excess funds no longer
- 22 required may be allocated by the department or the Department of
- 23 Conservation and Natural Resources to increase the estimated
- 24 costs of any one or more of the projects specifically itemized
- 25 in a capital budget.
- 26 (b) Reimbursement of municipal expenditures. -- Money raised
- 27 or expended by municipalities after the effective date of this
- 28 act, in anticipation of receipt of funds authorized for projects
- 29 itemized by this act, may be reimbursable to those
- 30 municipalities.

- 1 Section 80. Policy on jobs and materials.
- 2 (a) Jobs.--It is the declared policy of the Commonwealth
- 3 that the construction projects authorized in this act be used,
- 4 to the greatest extent possible, to provide for the creation of
- 5 jobs and the rehiring of the unemployed in this Commonwealth. In
- 6 order to reach this goal, firms with Commonwealth-based
- 7 facilities shall be actively solicited to make bids on contracts
- 8 to furnish products and materials, including, but not limited
- 9 to, steel and steel products, to be used in these projects.
- 10 (b) Materials.--Every contract document entered into to
- 11 undertake a project contained in this act shall provide that any
- 12 steel or other products to be used or supplied in the
- 13 performance of this contract shall be required to be
- 14 manufactured by plants in the United States unless the secretary
- 15 determines, on a contract by contract basis, that certain
- 16 required products are not produced in the United States in
- 17 sufficient quantities to meet the requirements of the contract.
- 18 Such a determination and the reasons therefor shall be published
- 19 in the Pennsylvania Bulletin. Decisions made under this
- 20 subsection shall not be inconsistent with the general provisions
- 21 of the act of March 3, 1978 (P.L.6, No.3), known as the Steel
- 22 Products Procurement Act.
- 23 (c) Minorities and women. -- It is also the declared policy of
- 24 the Commonwealth to require and encourage substantial
- 25 participation by minorities and women in the construction
- 26 projects authorized by this act.
- 27 Section 81. Payment of capital debt service.
- 28 The repayment of any debt incurred pursuant to this act shall
- 29 be made from the account and such repayment shall have first
- 30 claim on the revenues of the account.

- 1 Section 82. Authorization and debt cumulation.
- 2 The additional authorization and debt allowance provided for
- 3 in this act shall be added to the total authorizations and debt
- 4 incurred pursuant to the act of December 8, 1982 (P.L.848,
- 5 No.235), known as the Highway-Railroad and Highway Bridge
- 6 Capital Budget Act for 1982-1983, as amended and supplemented.
- 7 Section 83. Editorial changes.
- 8 In editing and preparing this act for printing following the
- 9 final enactment, the Legislative Reference Bureau shall insert
- 10 or revise letters or numbers for projects where the letters or
- 11 numbers are missing or require revision. The bureau shall also
- 12 revise the total monetary amounts for the total authorization,
- 13 debt authorization, appropriations and departmental totals as
- 14 necessary to agree with the total monetary amounts of the
- 15 projects.
- 16 Section 84. Effective date.
- 17 This act shall take effect immediately.
