AN ACT

- Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain provisions applicable as well to private and parochial
- schools; amending, revising, consolidating and changing the
- laws relating thereto," in duties and powers of boards of
- 6 school directors, further providing for school athletics,
- 7 publications and organizations.
- 8 The General Assembly of the Commonwealth of Pennsylvania
- 9 hereby enacts as follows:
- 10 Section 1. Section 511(a) of the act of March 10, 1949
- 11 (P.L.30, No.14), known as the Public School Code of 1949,
- 12 amended April 14, 1949 (P.L.460, No.85), is amended and the
- 13 section is amended by adding a subsection to read:
- 14 Section 511. School Athletics, Publications, and
- 15 Organizations.--
- 16 (a) The board of school directors in every school district
- 17 shall prescribe, adopt, and enforce such reasonable rules and
- 18 regulations as it may deem proper, regarding (1) the management,
- 19 supervision, control, or prohibition of exercises, athletics, or
- 20 games of any kind, school publications, debating, forensic,

- 1 dramatic, musical, and other activities related to the school
- 2 program, including raising and disbursing funds for any or all
- 3 of such purposes and for scholarships, and (2) the organization,
- 4 management, supervision, control, financing, or prohibition of
- 5 organizations, clubs, societies and groups of the members of any
- 6 class or school, and may provide for the suspension, dismissal,
- 7 or other reasonable penalty in the case of any appointee,
- 8 professional or other employe, or pupil who violates any of such
- 9 rules or regulations. The board shall provide for the inclusion
- 10 in any of these activities any student who lives within the
- 11 school district, attends a private or nonpublic school and
- 12 <u>elects to participate in such public school activities that are</u>
- 13 not offered by the private or nonpublic school. The student
- 14 shall be subject to the same rules and regulations that apply to
- 15 students enrolled in the school district relating to such
- 16 <u>activities</u>.
- 17 (a.1) (1) The board of school directors shall not restrict
- 18 inclusion of a student who lives within the school district but
- 19 is enrolled in a charter or cyber charter school, private or
- 20 nonpublic school or participating in a home education program in
- 21 an activity in accordance with subsection (a) by making the
- 22 activity or converting the activity to be part of the regular
- 23 school curriculum or by granting credit toward graduation
- 24 requirements for participation.
- 25 (2) Nothing in this subsection shall be construed to
- 26 preclude a school district from providing a public school
- 27 <u>student with credit for participation in such activities.</u>
- 28 * * *
- 29 Section 2. This act shall take effect in 60 days.
