1 ~~Subject to additional definitions contained in subsequent~~
2 ~~provisions of this title which are applicable to specific~~
3 ~~provisions of this title, the following words and phrases when~~
4 ~~used in this title shall have, unless the context clearly~~
5 ~~indicates otherwise, the meanings given to them in this section:~~

7 ~~(1) A vehicle (other than a pedalcycle) shall be~~
8 ~~presumed to be abandoned under any of the following~~
9 ~~circumstances, but the presumption is rebuttable by a~~
10 ~~preponderance of the evidence:~~

11 ~~(i) The vehicle is physically inoperable and is left~~
12 ~~unattended on a highway or other public property for more~~
13 ~~than 48 hours.~~

14 ~~(ii) The vehicle has remained illegally on a highway~~
15 ~~or other public property for a period of more than 48~~
16 ~~hours.~~

17 ~~(iii) The vehicle is left unattended on or along a~~
18 ~~highway or other public property for more than 48 hours~~
19 ~~and does not bear all of the following:~~

1 ~~construction or in the operation or maintenance of highways~~
2 ~~or public utility facilities, which are left in a manner~~
3 ~~which does not interfere with the normal movement of traffic,~~

28 ~~(a) Staggered renewal system to be established. The~~
29 ~~department shall establish a system of staggered registration~~
30 ~~renewal in a manner that an approximately equal number of~~

1 ~~registrations will expire every month throughout the year. This~~
2 ~~system shall be coordinated with the periodic inspection of all~~
3 ~~vehicles that are subject to annual inspection except those~~
4 ~~vehicles bearing dealer registration plates. In order to~~
5 ~~implement and maintain the staggered registration system, the~~
6 ~~department may prorate annual registration fees over~~
7 ~~registration periods of from 6 to 18 months.~~

9 ~~[(g) Election. Upon application on a form prescribed by the~~
10 ~~department, the owner or lessee of a motor vehicle, except a~~

25 ~~(f) Authority of police. Any police officer may stop any~~
26 ~~motor vehicle, mass transit vehicle or trailer and require the~~
27 ~~owner or operator to display an official certificate of~~
28 ~~inspection or validating registration sticker for the vehicle~~
29 ~~being operated. A police officer may summarily remove an~~
30 ~~unauthorized, expired or unlawfully issued certificate of~~

1 ~~inspection or validating registration sticker from any vehicle~~
2 ~~or mass transit vehicle. For the purposes of administering the~~
3 ~~requirements of regulations promulgated by the department, a~~
4 ~~qualified Commonwealth employee or an authorized department~~

23 ~~not required or a mass transit vehicle for which titling is not~~
24 ~~required, shall be inspected unless it is duly registered or~~
25 ~~titled in this Commonwealth or in any other jurisdiction. The~~
26 ~~certified inspection mechanic shall examine the registration~~
27 ~~card, title or other document as specified in department~~
28 ~~regulations in order to ascertain that the vehicle is registered~~

7 (D) VALIDATING REGISTRATION STICKERS.--VALIDATING
8 REGISTRATION STICKERS SHALL [NOT] BE ISSUED [OR] AND SHALL BE
9 REQUIRED TO BE DISPLAYED. THE FOLLOWING SHALL APPLY:

10 (1) THE DEPARTMENT SHALL ISSUE VALIDATING STICKERS UPON
11 RENEWAL OF A VEHICLE REGISTRATION OR, IF THE VEHICLE
12 REGISTERED HAD A TEMPORARY REGISTRATION, TO INDICATE THAT
13 REGISTRATION HAS BEEN COMPLETED AND THE TEMPORARY
14 REGISTRATION STATUS TERMINATED.

15 (2) A VALIDATING STICKER SHALL BE AFFIXED TO THE
16 REGISTRATION PLATE OF THE VEHICLE FOR WHICH THE VALIDATING
17 STICKER WAS ISSUED.

18 (3) A RENEWED REGISTRATION MAY NOT BE CONSIDERED
19 VALIDATED FOR THE NEW REGISTRATION PERIOD UNTIL THE
20 APPROPRIATE STICKER IS ATTACHED AS PROVIDED UNDER PARAGRAPH
21 (1). A TEMPORARY REGISTRATION MAY NOT BE CONSIDERED VALIDATED
22 FOR A SUCCEEDING REGISTRATION PERIOD UNTIL THE APPROPRIATE
23 VALIDATING STICKER HAS BEEN ATTACHED AS PROVIDED UNDER
24 PARAGRAPH (2).
