## INTRODUCED BY BRADFORD, MARCH 11, 2019

REFERRED TO COMMITTEE ON APPROPRIATIONS, MARCH 11, 2019

## AN ACT

Providing for the capital budget for fiscal year 2019-2020; 1 itemizing public improvement projects, furniture and 2 equipment projects and redevelopment assistance projects 3 leased or assisted by the Department of General Services and 4 other State agencies, together with their estimated financial 5 costs; authorizing the incurring of debt without the approval 6 7 of the electors for the purpose of financing the projects to be constructed, acquired or assisted by the Department of 8 General Services and other State agencies; authorizing the 9 use of current revenue for the purpose of financing the 10 11 projects to be constructed, acquired or assisted by the Department of General Services and other State agencies 12 stating the estimated useful life of the projects; and making 13 appropriations. 14 15 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 16 17 Section 1. Short title. 18 This act shall be known and may be cited as the Capital Budget Project Itemization Act of 2019-2020. 19 20 Section 2. Total authorizations. 21 (a) Public improvements. -- The total authorization for the 22 additional capital projects in the category of public 23 improvement projects itemized in section 3 and to be acquired or constructed by the Department of General Services, its 24

successors or assigns, and to be financed by the incurring of
 debt shall be \$6,866,548,000.

3 (b) Furniture and equipment. -- The total authorization for the additional capital projects in the category of public 4 improvement projects consisting of the acquisition of original 5 movable furniture and equipment to complete public improvement 6 7 projects itemized in section 4 and to be acquired by the 8 Department of General Services, its successors or assigns, and to be financed by the incurring of debt shall be \$411,005,000. 9 Manufacturing Fund. -- The total authorization for the 10 (C) capital projects in the category of public improvement projects 11 12 itemized in section 5 to be acquired or developed by the 13 Department of Corrections and to be financed by current revenues 14 of the Manufacturing Fund pursuant to executive authorization shall be \$21,000,000. 15

(d) Redevelopment assistance.--The total authorization for the capital projects in the category of redevelopment capital projects itemized in section 6 for capital grants by the Department of Community and Economic Development, its successors or assigns and to be financed by the incurring of debt shall be \$750,000,000.

Section 3. Itemization of public improvement capital projects. Additional capital projects in the category of public improvement projects to be acquired or constructed by the Department of General Services, its successors or assigns, and to be financed by the incurring of debt, are hereby itemized, together with their respective estimated financial costs, as follows:
