Section 301(b) of Title 34 of the Pennsylvania 7 Consolidated Statutes, amended January 26, 2022 (P.L.14, No.3), 8 9 is amended to read:

- 12 (b) Qualifications. -- The members of the commission shall be
- 13 appointed from the various geographical sections of this
- 14 Commonwealth so that one and only one shall be a resident of
- 15 each of the following districts:
- 16 (1) The counties of Erie, Crawford, Mercer, Lawrence,
- 17 Venango, Butler, Warren, Forest and Clarion, constituting the
- 18 first district.
- 19 (2) The counties of Beaver, Allegheny, Washington,

- 1 Greene, Armstrong, Indiana, Westmoreland and Fayette,
- 2 constituting the second district.
- 3 (3) The counties of McKean, Elk, Jefferson, Potter,
- 4 Cameron, Clearfield, Clinton and Centre, constituting the
- 5 third district.
- 6 (4) The counties of Cambria, Somerset, Blair, Bedford,
- 7 Huntingdon and Fulton, constituting the fourth district.
- 8 (5) The counties of Tioga, Lycoming, Union, Bradford,
- 9 Sullivan, Columbia, Montour and Northumberland, constituting
- 10 the fifth district.
- 11 (6) The counties of Snyder, Mifflin, Juniata, Franklin,
- 12 Perry, Cumberland, Adams, Dauphin, York, Lebanon and
- 13 Lancaster, constituting the sixth district.
- 14 (7) The counties of Susquehanna, Wyoming, Luzerne,
- 15 Lackawanna, Wayne [and Pike], Pike, Carbon and Monroe,
- 16 constituting the seventh district.
- 17 (8) The counties of Chester, Bucks, Montgomery,
- 18 Philadelphia and Delaware, constituting the eighth district.
- 19 (9) The counties of [Carbon, Monroe,] Schuylkill, Berks,
- Northampton and Lehigh, constituting the ninth district.

- 22 Section 2. Section 321(c) of Title 34 is amended to read:
- 23 § 321. Meetings of commission.

- 25 (c) Quorum.--[Six] <u>Five</u> members appointed to the commission
- 26 and in attendance at each meeting shall constitute a quorum.
- 27 Section 3. This act shall take effect in 60 days.
