## AN ACT

Amending the act of May 1, 1933 (P.L.103, No.69), entitled "An 1 act concerning townships of the second class; and amending, 2 revising, consolidating and changing the law relating thereto," in auditors and accountants, further providing for 3 appointment of accountant and providing for APPOINTMENT OF 5 <--INDEPENDENT AUDITOR AND abolishment of office of elected 6 auditor. 7 8 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 10 Section 1. Section 917(b)(2) of the act of May 1, 1933 (P.L.103, No.69), known as The Second Class Township Code, is 11 12 amended to read: 13 Section 917. Appointment of Accountant. -- \* \* \* 14 (b) \* \* \*15 (2) (i) At least thirty days prior to the organizational meeting or thirty days prior to any vote to appoint a certified 17 or competent public accountant or a firm of certified or 18 competent public accountants to replace the elected auditors, 19 the board of supervisors shall advertise in a newspaper of

- 1 general circulation the intent to appoint a certified or
- 2 competent public accountant or a firm of certified or competent
- 3 public accountants to replace the elected auditors.
- 4 (ii) Except after abolishing the office of auditor under
- 5 section 918, the board of supervisors at the organizational
- 6 meeting shall pass a resolution reaffirming the appointment
- 7 under this section.

- 9 Section 2. The act is amended by adding a section to read:
- 10 <u>Section 918. APPOINTMENT OF INDEPENDENT AUDITOR; Abolishment <---</u>
- 11 of Office of Elected Auditor.--(a) The board of supervisors may <--
- 12 provide, by ordinance passed by a two-thirds vote of the entire
- 13 board of supervisors, for the appointment of an independent
- 14 <u>auditor who must be a certified public accountant registered in</u>
- 15 this Commonwealth, a firm of certified public accountants
- 16 registered in this Commonwealth or a competent public accountant
- 17 or a competent firm of public accountants.
- (b) When an ordinance has been adopted under subsection (a),
- 19 an independent auditor shall be appointed annually, by
- 20 resolution before the close of the fiscal year. The independent <--
- 21 <u>auditor shall make an independent examination of the accounting</u>
- 22 records of the borough for the fiscal year and perform the other
- 23 duties and exercise the powers as conferred upon the independent
- 24 auditor under section 917. THE BOARD OF SUPERVISORS SHALL ENTER <--
- 25 <u>INTO A CONTRACT FOR EACH APPOINTMENT. THE INDEPENDENT AUDITOR</u>
- 26 SHALL EXAMINE, AUDIT AND SETTLE THE ACCOUNTING RECORDS OF THE
- 27 TOWNSHIP FOR THE FISCAL YEAR. THE INDEPENDENT AUDITOR SHALL HAVE
- 28 THE SAME POWERS AND DUTIES, EXCEPT FOR SETTING COMPENSATION OF
- 29 SUPERVISORS EMPLOYED BY THE TOWNSHIP, AND BE SUBJECT TO THE SAME
- 30 PENALTIES AS THE ELECTED AUDITORS UNDER THIS ARTICLE. THE

- 1 COMPENSATION FOR INDEPENDENT AUDITORS SHALL BE SET BY THE BOARD
- 2 OF SUPERVISORS. THE RESPONSIBILITY TO PUBLISH THE CONCISE
- 3 FINANCIAL STATEMENT AS PROVIDED BY SECTION 904 SHALL BE
- 4 COMPLETED BY THE TOWNSHIP SECRETARY UPON RECEIPT OF THE
- 5 STATEMENT FROM THE INDEPENDENT AUDITOR WITHIN THE REQUIRED TIME
- 6 FRAME.
- 7 (c) When an independent auditor is appointed under this
- 8 section, the office of elected township auditor shall be
- 9 abolished BY ORDINANCE AS PROVIDED UNDER SUBSECTION (A), but the <--

- 10 township ELECTED auditors then in office shall continue to hold <--
- 11 office during the term for which they were elected, and the
- 12 <u>township auditor</u> <u>ELECTED AUDITORS shall not audit, settle or</u> <--
- 13 adjust the accounts audited by the independent auditor but shall
- 14 perform the other duties of office. NO ADJUSTMENTS TO THE <--
- 15 COMPENSATION OF SUPERVISORS EMPLOYED BY THE TOWNSHIP MAY BE MADE
- 16 BY THE ELECTED AUDITORS.
- 17 (d) (1) If any township has provided by ordinance for the
- 18 audit of its accounts by an appointed INDEPENDENT auditor, the <--
- 19 township may at any time repeal the ordinance UNDER SUBSECTION <--
- 20 (A), and the contract under section 917 SUBSECTION (B) shall be <--
- 21 <u>canceled as of the date set in the ordinance</u>.
- 22 (2) The township may, at the next municipal election
- 23 following the repeal of the ordinance, elect three auditors, one
- 24 for a term of two years, one for a term of four years and one
- 25 for a term of six years, on the first Monday in January
- 26 following the election. The elected auditors shall succeed the
- 27 <u>appointed auditor and shall have and possess all the powers and</u>
- 28 perform all the duties provided in this part for elected
- 29 auditors.
- 30 (3) If, at any time after the effective date of an ordinance

- 1 abolishing the office of appointed auditor, there shall be a
- 2 vacancy in the office of elected auditor, the board of
- 3 supervisors shall fill the vacancy in the manner prescribed in
- 4 section 407.
- 5 (e) (1) The duties of the elected auditor under section 606
- 6 relating to setting compensation for supervisors that hold other
- 7 employee positions shall be performed by the supervisors.
- 8 (2) The board of supervisors shall establish a series of
- 9 salary schedules that apply to any supervisor that may hold an
- 10 employee position with the township.
- 11 (3) The salary schedules shall be established through an
- 12 ordinance that cannot take effect until after the next municipal
- 13 <u>election and may not be adjusted for six years. THE ORDINANCE</u> <--
- 14 MAY BE PASSED BY THE BOARD OF SUPERVISORS PRIOR TO THE EFFECTIVE
- 15 DATE OF THE ABOLISHMENT OF THE BOARD OF AUDITORS.
- 16 (4) ALL OTHER COMPENSATION, INCLUDING, BUT NOT LIMITED TO,
- 17 PENSIONS, MAY BE CHANGED BY ORDINANCE BY THE BOARD OF
- 18 SUPERVISORS AS NEEDED. ANY CHANGES MADE SHALL NOT TAKE EFFECT
- 19 UNTIL THE BEGINNING OF THE SUPERVISORS' NEXT TERM OF OFFICE.
- 20 Section 3. This act shall take effect in 60 days.
