Amending Title 23 (Domestic Relations) of the Pennsylvania Consolidated Statutes, in child protective services, further providing for definitions, for reporting procedure, for disposition of complaints received, for responsibility for investigation, for access to information in Statewide database, for information in Statewide database and for 5 6 release of information in confidential reports. 7 8 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: Section 1. Section 6303(a) of Title 23 of the Pennsylvania 10 Consolidated Statutes is amended by adding definitions to read: 11 12 § 6303. Definitions. 13 General rule. -- The following words and phrases when used (a) in this chapter shall have the meanings given to them in this 14 15 section unless the context clearly indicates otherwise: * * * 16 17 "Concerns a military family." In a report: 18 (1) an alleged perpetrator of abuse is a service member, spouse of a service member or child of a service member; or 19

- 4 <u>"Family Advocacy Program." The program established by the</u>
- 5 United States Department of Defense to address child abuse and
- 6 <u>neglect</u>, <u>problematic sexual behavior in children and youth and</u>

- 9 "Service member." A person serving in the armed forces of
- 10 the United States or reserve component of the armed forces of
- 11 the United States or the Pennsylvania National Guard.

- 17 (b) Contents of report. -- A written report of suspected child
- 18 abuse, which may be submitted electronically, shall include the
- 19 following information, if known:

- 21 (5.1) Whether the report concerns a military family and,
- 22 if so, any necessary explanatory information.

- 24 Section 3. Sections 6334(a) and (b), 6334.1(4) and 6335(a)
- 25 of Title 23 are amended to read:
- 26 § 6334. Disposition of complaints received.
- 27 (a) Receipt of reports by county agencies and law
- 28 enforcement. -- After ensuring the immediate safety of the child
- 29 and any other child in the child's home, a county agency or law
- 30 enforcement official that receives a report of suspected child

- 1 abuse shall immediately notify the department of the report. If
- 2 the report is an oral report by telephone, the county agency or
- 3 law enforcement official shall attempt to collect as much of the
- 4 information listed in section [6313(c)] 6313(b) (relating to
- 5 reporting procedure) as possible and shall submit the
- 6 information to the department within 48 hours through a report
- 7 in writing or by electronic technologies.
- 8 (b) Receipt of reports by department and referral to county
- 9 agency; notification of Family Advocacy Program
- 10 <u>representative</u>.--The department shall immediately transmit an
- 11 oral notice or a notice by electronic technologies to the county
- 12 agency of the county where the suspected child abuse is alleged
- 13 to have occurred. <u>If the report concerns a military family</u>, the
- 14 department shall also notify the Family Advocacy Program
- 15 representative for the Commonwealth and the designated Family
- 16 Advocacy Program representative of the assigned military
- 17 <u>installation</u>. The notice shall contain the following
- 18 information:
- 19 (1) That a report of suspected child abuse by a
- 20 perpetrator has been received.
- 21 (2) The substance of the report.
- 22 (3) The existence in the Statewide database of a prior
- 23 report or a current investigation or assessment concerning a
- subject of the report.

- 26 § 6334.1. Responsibility for investigation.
- 27 The department shall establish procedures regarding the
- 28 following different responses to address suspected child abuse
- 29 and protective services depending on the person's allegedly
- 30 committing the suspected child abuse or causing a child to be in

- 3 (4) If a child is alleged to be in need of other
- 4 protective services, the appropriate county agency, in
- 5 <u>coordination with the appropriate Family Advocacy Program</u>
- 6 <u>representative</u>, <u>if applicable</u>, shall assess the needs of the
- 7 child as provided in this chapter.
- 8 § 6335. Access to information in Statewide database.
- 9 (a) Request for information. -- A county agency, Family
- 10 Advocacy Program representative or law enforcement official
- 11 shall use the Statewide toll-free telephone number, or any
- 12 manner prescribed by the department, to determine the existence
- 13 of any prior reports involving a subject of the report. If the
- 14 Statewide database contains information related to a report or a
- 15 pending investigation or assessment concerning a subject of the
- 16 report, the department shall immediately convey this information
- 17 to the county agency, Family Advocacy Program representative or
- 18 law enforcement official.

- 23 (a) Information authorized.--The Statewide database shall

- 30 (a) General rule.--Reports specified in section 6339

- 6 or to the designated Family Advocacy Program representative
- 7 <u>for the assigned military installation.</u>
